Description of fiscal impact: SB 319 allows for the creation of joint fundraising committees. The Office of the Commissioner of Political Practices would incur costs associated with upgrading its Campaign Electronic Reporting System and to draft and adopt necessary rules pertaining to joint fundraising committees.

FISCAL ANALYSIS

Assumptions:

Commissioner of Political Practices (COPP)

- SB 319 allows for the creation of joint fundraising committees. Once this bill became law, joint fundraising committees would be required to file committee finance reports with COPP.
- The Campaign Electronic Reporting System (CERS) would require upgrades to allow for electronic filing by joint fundraising committees and so that joint fundraising committees can provide their list of participants.
- CERS would also require updates to allow participating candidates to report contributions received from a joint fundraising committee. COPP estimates CERS upgrades would total \$10,000.
- COPP expects that administrative rules pertaining to joint fundraising committees would need to be drafted and adopted. COPP estimates these costs would total \$2,000.
