7 (b) may engage in independent practice, as defined by the board, upon receiving a license; and

8 (c) may use the initials "LSW" or "LCSW" for "licensed social worker" or "licensed clinical social

9 worker".

determine the suitability for licensure as provided in 37-1-201 through 37-1-205 and 37-1-307.
