18	NEW SECTION. Section 1. Discrimination based on vaccination status prohibited definitions		
19	(1) It is an unlawful discriminatory practice for:		
20	(a) the state or any of its political subdivisions or any entity receiving state funding in any form,		
21	including grants and property tax exemptions, to refuse, withhold from, or deny to a person any local, state, or		
22	federal funds, services, goods, facilities, advantages, privileges, licensing, educational opportunities, health		
23	care access, or employment opportunities based on a person's vaccination status;		
24	(b) an employer to refuse employment to a person, to bar a person from employment, or to		
25	discriminate against a person in compensation or in a term, condition, or privilege of employment based on the		
26	person's vaccination status;		
27	(c) a public accommodation to exclude, limit, refuse to serve, or otherwise discriminate against an		
28	individual based on the individual's vaccination status; or

1	(d)	an entity listed in this subsection (1) to implement an immunity passport system.	
2	(2)	An entity governed by subsection (1) does not unlawfully discriminate as long as any vaccination	
3	policy set fo	rth includes exemptions for individuals to decline to be vaccinated based on medical or religious	
4	grounds.		
5	(3)	As used in this section, the following definitions apply:	
6	(a)	"Immunity passport" means a document, digital record, or software application indicating that a	
7	person is immune to a disease, either through vaccination or infection and recovery.		
8	(b)	"Vaccination status" means an indication of whether a person has received one or more doses of	
9	a vaccine.

15	severable fr	om the invalid part remain in effect. If a part of [this act] is invalid in one or more of its applications,	
16	the part remains in effect in all valid applications that are severable from the invalid applications.
