4 A BILL FOR AN ACT ENTITLED: "AN ACT GENERALLY REVISING VENUE LAWS; ELIMINATING CHOICE
5 OF VENUE IN THE FIRST JUDICIAL DISTRICT COURT, LEWIS AND CLARK COUNTY, IN CERTAIN
6 INSTANCES; ESTABLISHING VENUE FOR CERTAIN OUT-OF-STATE LITIGANTS IN THE FIRST JUDICIAL
7 DISTRICT COURT, LEWIS AND CLARK COUNTY; AND AMENDING SECTIONS 13-37-113, 15-1-108, 16-4-

14 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

15

16 NEW SECTION. SECTION 1. VENUE GENERALLY. EXCEPT AS OTHERWISE PROVIDED BY THIS CHAPTER, ANY
17 CHALLENGE TO AN ACTION TAKEN BY THE DEPARTMENT OR TO A DECISION ISSUED BY THE BOARD PURSUANT TO THIS
18 CHAPTER MUST BE BROUGHT IN THE DISTRICT COURT IN THE COUNTY WHERE THE ACTIVITY THAT IS THE SUBJECT OF THE
19 CHALLENGE IS PROPOSED TO OCCUR. IF AN ACTIVITY IS PROPOSED TO OCCUR OR WILL OCCUR IN MORE THAN ONE
20 COUNTY, THE CHALLENGE MAY BE BROUGHT IN THE DISTRICT COURT IN ANY OF THE COUNTIES WHERE THE ACTIVITY IS
21 PROPOSED TO OCCUR OR WILL OCCUR.

23 **Section 2.** Section 13-37-113, MCA, is amended to read:

24 **"13-37-113. Hiring of attorneys -- prosecutions.** The commissioner may hire or retain attorneys
25 who are properly licensed to practice before the supreme court of the state of Montana to prosecute violations
26 of chapter 35 of this title or this chapter. Any attorney retained or hired shall exercise the powers of a special
27 attorney general, and the attorney may prosecute, subject to the control and supervision of the commissioner
28 and the provisions of 13-35-240, 13-37-124, and 13-37-125, any criminal or civil action arising out of a violation

1 of any provision of chapter 35 of this title or this chapter. All prosecutions must be brought in the state district
2 court for the county in which a violation has occurred ~~or in the district court for Lewis and Clark County~~. The
3 authority to prosecute as prescribed by this section includes the authority to:

4 (1) institute proceedings for the arrest of persons charged with or reasonably suspected of criminal
5 violations of chapter 35 of this title or this chapter;

6 (2) attend and give advice to a grand jury when cases involving criminal violations of chapter 35 of
7 this title or this chapter are presented;

8 (3) draw and file indictments, informations, and criminal complaints;

9 (4) prosecute all actions for the recovery of debts, fines, penalties, or forfeitures accruing to the state
10 or county from persons convicted of violating chapter 35 of this title or this chapter; and

11 (5) do any other act necessary to successfully prosecute a violation of any provision of chapter 35 of
12 this title or this chapter."
13

14 **Section 3.** Section 15-1-108, MCA, is amended to read:

15 **"15-1-108. Prohibition on sales -- restrictions on certain disclosures and uses.** (1) (a) Subject to
16 subsection (1)(b), a tax return preparer may not sell, receive any consideration for, or otherwise disclose tax
17 return information for the benefit of the tax return preparer or of any persons controlling, controlled by, or under
18 common control of the tax return preparer.

19 (b) The provisions of this section do not prevent the bona fide sale of a tax return preparation,
20 accounting, or law practice in the ordinary course of business.

21 (2) A tax return preparer may not disclose return information to a tax return preparer located outside
22 of the state unless:

23 (a) (i) the taxpayer has requested the disclosure; or

24 (ii) disclosure is required in connection with an internal audit;

25 (b) the tax return preparer located outside of the state agrees:

26 (i) not to sell or receive any consideration for the tax return information; and

27 (ii) not to otherwise disclose the tax return information for its benefit or for the benefit of any person
28 controlling, controlled by, or under common control with it; and

1 (c) the local tax return preparer indemnifies the taxpayer for the damages provided for in subsection
2 (3)(d) for any sale or disclosure by the tax return preparer located outside the state in violation of subsection
3 (2)(b).

4 (3) (a) A person whose tax return information is or will be used or disclosed in violation of subsection
5 (1) or (2) may bring an action to enjoin the violation and for the recovery of damages.

6 (b) An action under this section may be brought in Montana district court in the county where the
7 plaintiff resides or maintains its principal place of business ~~or in the Montana first judicial district.~~

8 (c) If the court finds that the defendant is violating or has violated any of the provisions of subsection
9 (1) or (2), the court shall enjoin the defendant. It is not necessary to allege or prove actual damages to the
10 plaintiff.

11 (d) In addition to injunctive relief, the plaintiff is entitled to recover from the defendant in an amount
12 that is the greater of three times the amount of actual damages sustained by the plaintiff or up to \$10,000.

13 (e) In any action brought under this section, the court may award the prevailing party reasonable
14 attorney fees incurred in prosecuting or defending the action. A person who brings an action on the person's
15 own behalf without an attorney may receive equivalent fees at the judge's discretion.

16 (4) A tax return preparer may disclose or use return information:

17 (a) for quality or peer reviews;

18 (b) when authorized to do so by Montana law;

19 (c) when required to do so by federal or state law; or

20 (d) pursuant to a court subpoena or administrative summons.

21 (5) As used in this section, the following definitions apply:

22 (a) (i) "Return information" includes a taxpayer's identity, the nature, source, or amount of the
23 taxpayer's income, payments, receipts, deductions, exemptions, credits, assets, liabilities, net worth, tax
24 liability, tax withheld, deficiencies, overassessments, or tax payments, or any other data received by, recorded
25 by, prepared by, furnished to, or collected by the department with respect to a return or with respect to the
26 determination of the existence or possible existence of liability or the amount of a liability of any person under
27 this title for any tax, penalty, interest, fine, forfeiture, or other imposition or any offense.

28 (ii) The term does not include data in a form that cannot be associated with or otherwise identify,

1 directly or indirectly, a particular taxpayer.

2 (b) "Tax return preparer" means:

3 (i) any person who:

4 (A) is engaged in the business of preparing tax returns;

5 (B) is engaged in the business of providing services in connection with the preparation of tax returns;

6 (C) prepares or assists in preparing or presents to the public that the person prepares or assists in
7 preparing a tax return for compensation;

8 (D) develops software used to prepare or file tax returns; or

9 (E) is an electronic return originator; and

10 (ii) an individual who, as a part of that individual's duties or employment with a person described in
11 subsection (5)(b)(i), performs services relating to:

12 (A) the preparation or filing of or the provision of services in connection with the preparation or filing of
13 a tax return; or

14 (B) the development of software used to prepare or file tax returns."
15

16 **Section 4.** Section 16-4-411, MCA, is amended to read:

17 **"16-4-411. Appeals concerning alcoholic beverages laws.** (1) Any interested party shall have the
18 right to appeal any decision of the department of revenue concerning the issuance, transfer, suspension, or
19 revocation of alcoholic beverages licenses to the district court in the county in which the issuance, transfer,
20 suspension, or revocation occurred ~~or, at the appellant's option, in the district court of the first judicial district.~~

21 (2) The appeal must be in conformity with the provisions of Title 2, chapter 4, part 7."
22

23 **Section 5.** Section 19-2-401, MCA, is amended to read:

24 **"19-2-401. Location of board -- jurisdiction and venue for judicial review -- quorum -- officers
25 and employees.** (1) The board shall maintain its office in the city of Helena. Jurisdiction and venue for judicial
26 review of final administrative decisions of the board are in the judicial district in which the appealing party
27 resides or, if the person resides outside the state, the first judicial district, Lewis and Clark County, unless
28 otherwise stipulated by the parties.

1 (2) A quorum of the board is four members.

2 (3) The board shall elect one of its members presiding officer. The board may appoint a committee of
3 one or more of its members to perform routine acts, such as retirement of members and fixing of retirement
4 benefits, approval of death claims, and correction of records necessary in the administration of the systems in
5 accordance with the provisions of chapters 2, 3, 5 through 9, 13, 17, and 50 of this title and in accordance with
6 the rules of the board. The attorney general is the legal counsel for the board."

7

8 **Section 6.** Section 19-20-201, MCA, is amended to read:

9 **"19-20-201. Administration by retirement board -- jurisdiction and venue for judicial review. (1)**

10 The retirement board shall administer and operate the retirement system within the limitations prescribed by
11 this chapter, and it is the duty of the retirement board to:

12 (a) establish rules necessary for the proper administration and operation of the retirement system;

13 (b) approve or disapprove all expenditures necessary for the proper operation of the retirement
14 system;

15 (c) keep a record of all its proceedings, which must be open to public inspection;

16 (d) submit a report to the office of budget and program planning detailing the fiscal transactions for
17 the 2 fiscal years immediately preceding the report due date, the amount of the accumulated cash and
18 securities of the retirement system, and the last fiscal year balance sheet showing the assets and liabilities of
19 the retirement system;

20 (e) keep in convenient form the data that is necessary for actuarial valuation of the various funds of
21 the retirement system and for checking the experience of the retirement system;

22 (f) prepare an annual valuation of the assets and liabilities of the retirement system that includes an
23 analysis of how market performance is affecting the actuarial funding of the retirement system;

24 (g) require the board's actuary to conduct and report on a periodic actuarial investigation into the
25 actuarial experience of the retirement system;

26 (h) prescribe a form for membership application that will provide adequate and necessary information
27 for the proper operation of the retirement system;

28 (i) annually determine the rate of regular interest as prescribed in 19-20-501;

1 (j) establish and maintain the funds of the retirement system in accordance with the provisions of part
2 6 of this chapter; and

3 (k) perform other duties and functions as are required to properly administer and operate the
4 retirement system.

5 (2) In discharging its duties, the board, or an authorized representative of the board, may conduct
6 hearings, administer oaths and affirmations, take depositions, certify to official acts and records, and issue
7 subpoenas to compel the attendance of witnesses and the production of books, papers, correspondence,
8 memoranda, and other records. Subpoenas must be issued and enforced pursuant to 2-4-104.

9 (3) The board may send retirement-related material to employers and the campuses of the Montana
10 university system for delivery to employees. To facilitate distribution, employers and those campuses shall each
11 provide the board with a point of contact who is responsible for distribution of the material provided by the
12 board.

13 (4) The board shall make available to the state administration and veterans' affairs interim committee
14 and to the legislature pursuant to 5-11-210 copies of the annual actuarial valuation and reports required
15 pursuant to subsections (1)(d), (1)(f), and (1)(g).

16 (5) Jurisdiction and venue for judicial review of the board's final administrative decisions is the judicial
17 district in which the appealing party resides or, if the person resides outside the state, the first judicial district,
18 Lewis and Clark County, unless otherwise stipulated by the parties."

19

20 **Section 7.** Section 22-3-429, MCA, is amended to read:

21 **"22-3-429. Requests for consultation -- public notice -- appeal of findings.** (1) A federal or state
22 entity that acts upon a proposed federal or state action or an application for a federal, state, or local permit,
23 license, lease, or funding may request the views of the historic preservation officer concerning:

24 (a) the recommended eligibility for a register listing of any heritage property or paleontological
25 remains;

26 (b) the effects of a proposed action, activity, or undertaking on heritage property or remains that are
27 found to be eligible for register listing; and

28 (c) the appropriateness of a proposed plan for the avoidance or mitigation of effects.

1 (2) A request for comment pursuant to 16 U.S.C. 470f may be made simultaneously with a request
2 pursuant to subsection (1). The historic preservation officer shall respond in writing to a request within 30
3 calendar days of receiving the request and shall address each property in the request and each topic of the
4 request. In the event that an agency requests simultaneous consultation for two or more criteria under this
5 section, the agency and historic preservation officer may extend the 30-day review period by mutual
6 agreement. If the historic preservation officer fails to comment within that time, that failure is construed as
7 concurrence with the agency's recommendation. In the event of failure to comment on a specific undertaking,
8 the historic preservation officer may not change a finding for a heritage property at a later date.

9 (3) If the proposed finding is that a heritage property or paleontological remains are involved and that
10 a proposed activity will have an adverse impact on the property or remains, the proposed finding must address
11 all properties or remains involved and describe the characteristics that illustrate the qualities that make the
12 property or remains eligible for inclusion in the register. If the proposed finding includes a conclusion that a
13 property or remains may be eligible but additional information or study is needed to reach an eligibility finding,
14 the finding must specify the type and amount of information required in accordance with standards and
15 guidelines as provided in 22-3-428.

16 (4) At the time that the state or federal agency requests the views of the historic preservation officer
17 as provided in subsection (1), the agency shall provide notice to the applicant, affected property owners, and
18 other interested persons of the request for consultation and shall identify locations where the submitted
19 materials may be reviewed.

20 (5) The applicant and any affected property owners have 20 days in which to appeal the historic
21 preservation officer's finding to the director. The appeal notice must include a written statement of reasons for
22 the appeal and any additional supporting information.

23 (6) The director of the historical society shall issue a final finding within 30 days of the expiration of
24 the 20-day appeal period provided for under subsection (5). The issuance of this finding does not limit the rights
25 of any applicant or affected property owner to challenge a finding under an existing federal law, regulation, or
26 regulatory or administrative process.

27 (7) If the applicant or an affected property owner is not satisfied with the finding of the director of the
28 historical society concerning the eligibility of the property or remains for listing in the register or a finding of

1 adverse effect to the property, the entity or property owner may appeal the finding to the district court in ~~either~~
 2 ~~Lewis and Clark County~~ or a county in which affected property is located. Appeal may be taken by filing a
 3 petition with the district court citing the decision by the director of the historical society and the evidence upon
 4 which the director relied. On appeal, the district court may consider any documents supporting or not supporting
 5 the finding, the written comments received by the director of the historical society, and any additional evidence
 6 that may be submitted to the court. The district court may substitute its judgment for the judgment of the director
 7 of the historical society as to the weight of the evidence.

8 (8) A state agency may not require a historical or archaeological survey as a condition of applying for
 9 or receiving a state or local permit, license, lease, or funding for a project to reconstruct or maintain an irrigation
 10 ditch or appurtenant structures or equipment when the ditch or appurtenant structures or equipment are in use
 11 or have been in use within the past 10 years, if the reconstruction or maintenance will occur within the existing
 12 ditch easement and if the project is not on land owned by the state."
 13

14 **Section 8.** Section 25-2-126, MCA, is amended to read:

15 **"25-2-126. Against state and political subdivisions.** (1) ~~The~~ Except as provided in subsection (2),
 16 the proper place of trial for an action against the state is in the county in which the claim arose or in Lewis and
 17 Clark County. In an action against the state brought by a resident of the state, the county of the plaintiff's
 18 residence is also a proper place of trial.

19 (2) For an action that challenges the issuance, approval, renewal, or denial of a permit, license,
 20 authorization, or certificate by a state agency, the action must be brought in the county in which the permitted,
 21 licensed, authorized, or certificated activity would occur. If an activity would occur in more than one county, any
 22 county in which the activity would occur is a proper place for an action.

23 ~~(2)(3)~~ The proper place of trial for an action against a political subdivision is in the county in which the
 24 claim arose or in any county where the political subdivision is located."
 25

26 **Section 9.** Section 30-14-111, MCA, is amended to read:

27 **"30-14-111. Department to restrain unlawful acts.** (1) Whenever the department has reason to
 28 believe that a person is using, has used, or is about to knowingly use any method, act, or practice declared by

1 30-14-103 to be unlawful and that proceeding would be in the public interest, the department may bring an
 2 action in the name of the state against the person to restrain by temporary or permanent injunction or
 3 temporary restraining order the use of the unlawful method, act, or practice upon giving appropriate notice to
 4 that person.

5 (2) The notice must state generally the relief sought and be served in accordance with 30-14-115 at
 6 least 20 days before the hearing of the action in which the relief sought is a temporary or permanent injunction.
 7 The notice for a temporary restraining order is governed by 27-19-315.

8 (3) An action under this section may be brought in the district court in the county in which a person
 9 resides or has the person's principal place of business or in the district court of Lewis and Clark County if the
 10 person is not a resident of this state or does not maintain a place of business in this state.

11 (4) A district court is authorized to issue temporary or permanent injunctions or temporary restraining
 12 orders to restrain and prevent violations of this part, and an injunction must be issued without bond."
 13

14 **Section 10.** Section 30-14-1413, MCA, is amended to read:

15 **"30-14-1413. Civil remedies -- venue -- burden of proof.** (1) The sale of any goods or services by
 16 an unregistered seller or telemarketer that is required to register is void. A person obtaining a judgment for
 17 damages, attorney fees, or costs against a seller or telemarketer pursuant to this section has the right to be
 18 reimbursed for those damages, attorney fees, or costs from any bond or security posted by the seller or
 19 telemarketer pursuant to the provisions of 30-14-1404.

20 (2) A person that suffers a loss or harm as a result of an unfair and deceptive act or practice or a
 21 prohibited act or practice is entitled to recover actual damages or \$500, whichever is greater, attorney fees,
 22 court costs, and any other remedies provided by law.

23 (3) In addition to the remedies provided in subsection (2), a person that suffers harm as a result of an
 24 abusive act or practice is entitled to receive injunctive or declaratory relief.

25 (4) (a) The department or a county attorney, on behalf of state residents who have suffered a loss or
 26 harm as a result of a violation of this part, may seek any remedy provided by Title 30, chapter 14, part 1.

27 (b) The proper place for trial for an action based on a claim of a violation of this part is the district
 28 court of Lewis and Clark County or in the county in which the alleged violation occurred.

1 (5) In a civil proceeding alleging a violation of this part, the burden of proving an exemption under 30-
 2 14-1405 or an exception to a definition contained in 30-14-1403 is on the person claiming the exemption or
 3 exception."

5 **Section 11.** Section 31-1-726, MCA, is amended to read:

6 **"31-1-726. Investigations by department -- subpoenas -- oaths -- examination of witnesses and**
 7 **evidence.** (1) The department may investigate any matter, upon complaint or otherwise, if it appears that a
 8 person has engaged in or offered to engage in any act or practice that is in violation of any provision of this part
 9 or any rule adopted or order issued by the department pursuant to this part.

10 (2) The department may issue subpoenas to compel the attendance of witnesses and the production
 11 of documents, papers, books, records, and other evidence before it in any matter over which it has jurisdiction,
 12 control, or supervision pertaining to this part. The department may administer oaths and affirmations to a
 13 person whose testimony is required.

14 (3) If a person refuses to obey a subpoena or to give testimony or produce evidence as required by
 15 the subpoena, a judge of the district court of ~~Lewis and Clark County~~ or in the county in which the licensed
 16 premises are located or the person's principal place of business is located or where the person resides may,
 17 upon application and proof of the refusal, issue a subpoena or subpoena duces tecum for the witness to appear
 18 before the department to give testimony and produce evidence as may be required. The clerk of court shall
 19 then issue the subpoena, as directed, under the seal of the court, requiring the person to whom it is directed to
 20 appear at the time and place designated in the subpoena.

21 (4) If a person served with a subpoena refuses to obey the subpoena or to give testimony or produce
 22 evidence as required by the subpoena, the department may proceed under the contempt provisions of Title 3,
 23 chapter 1, part 5.

24 (5) Failure to comply with a court-ordered subpoena is punishable pursuant to 45-7-309."
 25

26 **Section 12.** Section 32-1-912, MCA, is amended to read:

27 **"32-1-912. Enforcement of notices or orders.** The director may apply to the district court of the
 28 county in which the home office of the institution is located or to the district court for Lewis and Clark County if

1 the institution does not have a home office in this state for the enforcement of any effective and outstanding
2 notice or order issued under this part. The court has jurisdiction to require compliance therewith."

3

4 **Section 13.** Section 32-5-402, MCA, is amended to read:

5 **"32-5-402. Investigations by department -- subpoenas -- oaths -- examination of witnesses and**
6 **evidence.** (1) The department may at any time investigate any transaction with borrowers and may examine
7 the books, accounts, and records to discover violations of this chapter by:

8 (a) a licensee; or

9 (b) a person who the department has reason to believe is violating or is about to violate this chapter.

10 (2) The department or the department's authorized representatives must be given free access to the
11 offices and places of business and files of all licensees. The department may investigate any matter, upon
12 complaint or otherwise, if it appears that a person has engaged in or offered to engage in any act or practice
13 that is in violation of any provision of this chapter or any rule adopted or order issued by the department
14 pursuant to this chapter.

15 (3) The department may issue subpoenas to compel the attendance of witnesses and the production
16 of documents, papers, books, records, and other evidence before it in any matter over which it has jurisdiction,
17 control, or supervision pertaining to this chapter. The department may administer oaths and affirmations to a
18 person whose testimony is required.

19 (4) If a person refuses to obey a subpoena or to give testimony or produce evidence as required by
20 the subpoena, a judge of the district court ~~of Lewis and Clark County or in~~ the county in which the licensed
21 premises are located or in the district court of Lewis and Clark County if no licensed premises are maintained in
22 the state may, upon application and proof of the refusal, issue a subpoena or subpoena duces tecum for the
23 witness to appear before the department to give testimony and produce evidence as may be required. The clerk
24 of court shall then issue the subpoena, as directed, under the seal of the court, requiring the person to whom it
25 is directed to appear at the time and place designated in the subpoena.

26 (5) If a person served with a subpoena refuses to obey the subpoena or to give testimony or produce
27 evidence as required by the subpoena, the department may proceed under the contempt provisions of Title 3,
28 chapter 1, part 5.

1 (6) Failure to comply with the requirements of a court-ordered subpoena is punishable pursuant to 45-
2 7-309."

3

4 **Section 14.** Section 33-1-804, MCA, is amended to read:

5 **"33-1-804. Civil penalty -- civil action for collection of penalty.** (1) A health carrier or a managed
6 care organization violating 33-1-802 or 33-1-803 is subject to a civil penalty, as provided in 33-1-317, for each
7 violation. Each day of violation constitutes a separate violation for the purposes of this section.

8 (2) In addition to other enforcement methods provided by law, the commissioner may bring a civil
9 ~~action in the district court of the first judicial district~~ in the district court in the county in which the violation
10 occurred to collect the civil penalty provided for in subsection (1) from a person violating a provision of this part.
11 If the violation occurred in more than one county, any county in which the violation occurred is a proper venue
12 for a civil action. An amount collected by the commissioner pursuant to this section must be deposited in the
13 general fund."

14

15 **Section 15.** Section 37-1-332, MCA, is amended to read:

16 **"37-1-332. Administrative proceedings to stop unlicensed practice -- board of realty regulation**
17 **-- state electrical board -- board of plumbers.** (1) For purposes of this section, the term "board" means the
18 board of realty regulation provided for in 2-15-1757, the state electrical board provided for in 2-15-1764, or the
19 board of plumbers provided for in 2-15-1765.

20 (2) (a) After investigation under 37-1-317, the board may establish a screening panel to determine if
21 there is reasonable cause to believe a person has engaged in or is engaging in any act or practice constituting
22 unlicensed practice of a profession or occupation.

23 (b) If reasonable cause is found under subsection (2)(a), the board may initiate a contested case
24 proceeding against the person pursuant to the Montana Administrative Procedure Act in Title 2, chapter 4, part
25 6.

26 (3) Following a contested case proceeding, the board may apply any of the following sanctions to a
27 person found to have engaged in the unlicensed practice of a profession or occupation:

28 (a) impose a civil penalty not to exceed \$1,500 for each violation and not to exceed a total of \$5,000

1 for all related violations; and

2 (b) require the person to pay up to \$5,000 for the costs of the administrative proceedings, including
3 but not limited to costs allowable under Title 25, chapter 10, but excluding the costs of investigation and the
4 board's attorney fees.

17 (b) a person who at the time of disposal of a hazardous or deleterious substance owned or operated a
18 facility where the hazardous or deleterious substance was disposed of;

19 (c) a person who generated, possessed, or was otherwise responsible for a hazardous or deleterious
20 substance and who, by contract, agreement, or otherwise, arranged for disposal or treatment of the substance
21 or arranged with a transporter for transport of the substance for disposal or treatment; and

22 (d) a person who accepts or has accepted a hazardous or deleterious substance for transport to a
23 disposal or treatment facility.

24 (2) A person identified in subsection (1) is liable for the following costs:

25 (a) all remedial action costs incurred by the state; and

26 (b) damages for injury to, destruction of, or loss of natural resources caused by the release or
27 threatened release, including the reasonable technical and legal costs of assessing and enforcing a claim for
28 the injury, destruction, or loss resulting from the release, unless the impaired natural resources were specifically

1 identified as an irreversible and irretrievable commitment of natural resources in an approved final state or
2 federal environmental impact statement or other comparable approved final environmental analysis for a project

8 two times the amount of any costs incurred by the state pursuant to this section.

3 (B) took precautions against foreseeable acts or omissions of a third party and the consequences that
4 could foreseeably result from those acts or omissions;

5 (d) the release or threatened release occurred solely as the result of an act of God or an act of war;

6 (e) the release or threatened release was from a facility for which a permit had been issued by the
7 department, the hazardous or deleterious substance was specifically identified in the permit, and the release
8 was within the limits allowed in the permit;

9 (f) in the case of assessment of penalties under subsection (3), factors beyond the control of the
10 person prevented the person from taking timely remedial action; or

11 (g) the person transported only household refuse, unless that person knew or reasonably should have
12 known that the hazardous or deleterious substance was present in the refuse.

13 (6) (a) For the purpose of subsection (5)(c)(ii), the term "contractual relationship" includes but is not
14 limited to land contracts, deeds, or other instruments transferring title or possession, unless the real property on
15 which the facility is located was acquired by the person after the disposal or placement of the hazardous or
16 deleterious substance on, in, or at the facility and one or more of the following circumstances is also
17 established by the person by a preponderance of the evidence:

18 (i) At the time the person acquired the facility, the person did not know and had no reason to know
19 that a hazardous or deleterious substance that is the subject of the release or threatened release was disposed
20 of on, in, or at the facility.

21 (ii) The person is a governmental entity that acquired the facility by escheat, lien foreclosure, or
22 through any other involuntary transfer or acquisition or through the exercise of eminent domain authority by
23 purchase or condemnation pursuant to Title 70, chapter 30.

24 (iii) The person acquired the facility by inheritance or bequest.

25 (b) In addition to establishing one or more of the circumstances in subsection (6)(a)(i) through
26 (6)(a)(iii), the person shall establish that the person has satisfied the requirements of subsection (5)(c)(i) or
27 (5)(c)(ii).

28 (c) To establish that the person had no reason to know, as provided in subsection (6)(a)(i), the person

1 must have undertaken, at the time of acquisition, all appropriate inquiry into the previous ownership and uses of
2 the property consistent with good commercial or customary practice in an effort to minimize liability. For
3 purposes of assessing this inquiry, the following must be taken into account:

- 4 (i) any specialized knowledge or experience on the part of the person;
- 5 (ii) the relationship of the purchase price to the value of the property if uncontaminated;
- 6 (iii) commonly known or reasonably ascertainable information about the property;
- 7 (iv) the obviousness of the presence or the likely presence of contamination on the property; and
- 8 (v) the ability to detect the contamination by appropriate inspection.

9 (d) (i) Subsections (5)(b) and (5)(c) or this subsection (6) may not diminish the liability of a previous
10 owner or operator of the facility who would otherwise be liable under this part.

11 (ii) Notwithstanding this subsection (6), if the previous owner or operator obtained actual knowledge of
12 the release or threatened release of a hazardous or deleterious substance at the facility when the person
13 owned the real property and then subsequently transferred ownership of the property to another person without
14 disclosing the knowledge, the previous owner is liable under subsections (1), (2), and (3) and a defense under
15 subsection (5)(b) or (5)(c) is not available to that person.

16 (e) This subsection (6) does not affect the liability under this part of a person who, by any act or
17 omission, caused or contributed to the release or threatened release of a hazardous or deleterious substance
18 that is the subject of the action relating to the facility.

19 (7) A person has an exclusion and is not liable under this section if:

20 (a) the person generated or disposed of only household refuse, unless the person knew or reasonably
21 should have known that the hazardous or deleterious substance was present in the refuse;

22 (b) the person owns or operates real property where hazardous or deleterious substances have come
23 to be located solely as a result of subsurface migration in an aquifer from a source or sources outside the
24 person's property, provided that the following conditions are met:

25 (i) the owner or operator did not cause, contribute to, or exacerbate the release or threatened release
26 of any hazardous or deleterious substances through any act or omission. The failure to take affirmative steps to
27 mitigate or address contamination that has migrated from a source outside the owner's or operator's property
28 does not, in the absence of exceptional circumstances, constitute an omission by the owner or operator.

1 (ii) the person who caused, contributed to, or exacerbated the release or threatened release of any
2 hazardous or deleterious substance is not and was not an agent or employee of the owner or operator and is
3 not or was not in a direct or indirect contractual relationship with the owner or operator, unless the department
4 provides a written determination that an existing or proposed contractual relationship is an insufficient basis to
5 establish liability under this section;

6 (iii) there is no other basis of liability under subsection (1) for the owner or operator for the release or
7 threatened release of a hazardous or deleterious substance; and

8 (iv) the owner or operator cooperates with the department and all persons conducting department-
9 approved remedial actions on the property, including granting access and complying with and implementing all
10 required institutional controls;

11 (c) the person owns or occupies real property of 20 acres or less for residential purposes, provided
12 that the following conditions are met:

13 (i) the person did not cause, contribute to, or exacerbate the release or threatened release of any
14 hazardous or deleterious substance through any act or omission;

15 (ii) the person uses or allows the use of the real property for residential purposes. This exclusion does
16 not apply to any person who acquires or develops real property for commercial use or any use other than
17 residential use.

18 (iii) at the time the person purchased or occupied the real property, there were no visible indications of
19 contamination on the surface of the real property;

20 (iv) the person cooperates with the department and all persons conducting department-approved
21 remedial actions on the property, including granting access and complying with and implementing all required
22 institutional controls; and

23 (v) there is no other basis of liability under subsection (1) for the owner or occupier for the release or
24 threatened release of a hazardous or deleterious substance.

25 (8) A person is liable under this section if the department provides substantial credible evidence that
26 the person fails to satisfy any element of each exclusion in subsections (7)(a) through (7)(c).

27 (9) The liability of a fiduciary under the provisions of this part for a release or a threatened release of
28 a hazardous or deleterious substance from a facility held in a fiduciary capacity may not exceed the assets held

1 in the fiduciary capacity that are available to indemnify the fiduciary unless the fiduciary is liable under this part
2 independent of the person's ownership or actions taken in a fiduciary capacity.

3 (10) A person who holds indicia of ownership in a facility primarily to protect a security interest is not
4 liable under subsections (1)(a) and (1)(b) for having participated in the management of a facility within the
5 meaning of 75-10-701(15)(b) because of any one or any combination of the following:

6 (a) holding an interest in real or personal property when the interest is being held as security for
7 payment or performance of an obligation, including but not limited to a mortgage, deed of trust, lien, security
8 interest, assignment, pledge, or other right or encumbrance against real or personal property that is furnished
9 by the owner to ensure repayment of a financial obligation;

10 (b) requiring or conducting financial or environmental assessments of a facility or a portion of a
11 facility, making financing conditional upon environmental compliance, or providing environmental information or
12 reports;

13 (c) monitoring the operations conducted at a facility or providing access to a facility to the department
14 or its agents or to remedial action contractors;

15 (d) having the mere capacity or unexercised right to influence a facility's management of hazardous or
16 deleterious substances;

17 (e) giving advice, information, guidance, or direction concerning the administrative and financial
18 aspects, as opposed to day-to-day operational aspects, of a borrower's operations;

19 (f) providing general information concerning federal, state, or local laws governing the transportation,
20 storage, treatment, and disposal of hazardous or deleterious substances and concerning the hiring of remedial
21 action contractors;

22 (g) engaging in financial workouts, restructuring, or refinancing of a borrower's obligations;

23 (h) collecting rent, maintaining utility services, securing a facility from unauthorized entry, or
24 undertaking other activities to protect or preserve the value of the security interest in a facility;

25 (i) extending or denying credit to a person owning or in lawful possession of a facility;

26 (j) in an emergency, requiring or undertaking activities to prevent exposure of persons to hazardous
27 or deleterious substances or to contain a release;

28 (k) requiring or conducting remedial action in response to a release or threatened release if prior

1 notice is given to the department and the department approves of the remedial action; or

2 (l) taking title to a facility by foreclosure, provided that the holder of indicia of ownership, from the time
3 the holder acquires title, undertakes to sell, re-lease property held pursuant to a lease financing transaction
4 (whether by a new lease financing transaction or substitution of the lessee), or otherwise divest itself of the
5 property in a reasonably expeditious manner, using whatever commercially reasonable means are relevant or
6 appropriate with respect to the facility and taking all facts and circumstances into consideration and provided
7 that the holder does not:

8 (i) outbid or refuse a bid for fair consideration for the property or outbid or refuse a bid that would
9 effectively compensate the holder for the amount secured by the facility;

10 (ii) worsen the contamination at the facility;

11 (iii) incur liability under subsection (1)(c) or (1)(d) by arranging for disposal of or transporting
12 hazardous or deleterious substances; or

13 (iv) engage in conduct described in subsection (11).

14 (11) The protection from liability provided in subsections (9) and (10) is not available to a fiduciary or to
15 a person holding indicia of ownership primarily to protect a security interest if the fiduciary or person through
16 affirmative conduct:

17 (a) causes or contributes to a release of hazardous or deleterious substances from the facility;

18 (b) allows others to cause or contribute to a release of hazardous or deleterious substances; or

19 (c) in the case of a person holding indicia of ownership primarily to protect a security interest, actually

21 (i) exercising decisionmaking control over environmental compliance; or

22 (ii) exercising control at a level comparable to that of a manager of the enterprise with responsibility for

23 issue an order if it has credible information that a violation listed in subsection (2) has occurred. The order must
24 specify the provision of the part, rule, order, or permit alleged to be violated and the facts alleged to constitute
25 the violation. The order may require necessary corrective action within a reasonable period of time, may assess
26 an administrative penalty determined in accordance with this section, or both. The order must be served
27 personally or by certified mail.

28 (b) An order issued pursuant to subsection (5)(a) becomes final unless, within 30 days after the order

15 **"82-15-120. Department of environmental quality to enforce prohibition on methyl tertiary butyl**
16 **ether -- notice requirements -- hearing -- penalties.** (1) (a) Whenever the department of environmental
17 quality believes that a violation of 82-15-110(8) or of the rules adopted pursuant to 82-15-102(3) has occurred,
18 it may serve written notice of the violation on the alleged violator or an agent of the alleged violator.

19 (b) The notice must specify the facts alleged to constitute a violation and may include an order
20 assessing an administrative penalty pursuant to subsection (3), an order to take necessary corrective action
21 within a reasonable period of time stated in the order, or both.

22 (c) The order becomes final unless, within 30 days after the notice is served, the person named in the
23 order requests in writing a hearing before the board of environmental review. Service by mail is complete on the
24 date of mailing.

25 (d) Upon receipt of the request, the board of environmental review shall schedule a hearing. The

 21 ~~for the first judicial district. At the discretion of the department, the judgment may be certified to the district court~~
 22 in the county where the real property is located.

23 (3) Any penalty fee collected under this section must be deposited in the water right appropriation

27 **"85-6-109. Operation of projects with water users' association -- definitions.** (1) As used in this

2 (b) "Department" means the department of natural resources and conservation provided for in Title 2,
3 chapter 15, part 33.

4 (2) Whenever the department proposes a program of maintenance, repair, operation, or alteration of a
5 project in excess of \$25,000, the cost of which will be borne by an association pursuant to the terms of a water
6 marketing contract, the association must be informed of the program and given an opportunity to comment. The
7 department shall notify the association of its decision. If the association believes the program to be
8 unnecessary or excessive in cost, it may appeal the department decision to the district court in any county
9 where all or part of the project works is located ~~or to the district court in Lewis and Clark County.~~

10 (3) If an appeal is filed under subsection (2), the court shall hold a trial de novo on the question of
11 necessity of the department program and the question of excessive costs. If the association prevails, the court
12 may award costs to the association. The court may specify an acceptable program of maintenance, repair,
13 operation, or alteration or may order the department and the association to develop a program, subject to court
14 approval.

15 (4) Whenever a program of maintenance, repair, operation, or alteration is proposed, the department
16 shall assist the association in attempting to secure sources of financing, including federal funds.

17 (5) Whenever the department proposes to abandon, sell, or otherwise dispose of a project that
18 involves a water users' association, the department shall notify the association. Before the department may
19 take further action to abandon, sell, or otherwise dispose of a project that involves a water users' association,
20 the department must receive a petition approving the abandonment, sale, or disposition. The petition must be
21 signed by stockholders of the association who represent 66 2/3% or more of the issued and outstanding stock
22 of the association. If, within 30 days of receipt of the final proposal of abandonment, sale, or other disposal,

24 association file a petition of protest with the department, the project may not be abandoned, sold, or otherwise
25 disposed of without the consent of the legislature."
