8 A BILL FOR AN ACT ENTITLED: "AN ACT PROHIBITING THE USE OF VACCINATION STATUS OR
9 IMMUNITY PASSPORT FOR CERTAIN PURPOSES; PROVIDING AN APPROPRIATION; AMENDING
10 SECTIONS 13-1-116 AND 49-2-101, MCA; AND PROVIDING AN IMMEDIATE EFFECTIVE DATE."

11
12 WHEREAS, as noted in section 50-16-502, MCA, "health care information is personal and sensitive
13 information that if improperly used or released may do significant harm to a patient's interests in privacy and
14 health care or other interests"; and

15 WHEREAS, the Montana Supreme Court has concluded that "medical records fall within the zone of
16 privacy protected by Article II, section 10, of the Montana Constitution" and "are quintessentially private and
17 deserve the utmost constitutional protection"; and

18 WHEREAS, government adoption of tracking immunity passports or medical data can lead to new
19 forms of discrimination that could easily be expanded to include other forms of personal health data, such as
20 mental health records and genetic test results.

22 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

23
24 **NEW SECTION. Section 1. Use of vaccination status or immunity passport prohibited for**
25 **certain identification cards, benefits, and services -- legislative purpose.** (1) The legislature recognizes
26 that the adoption, use, or sharing of vaccination status or immunity passports is a voluntary act by an individual.
27 The purpose of this section is to recognize that individuals must be free from coercion to provide private
28 sensitive medical data to a third party.

1 (2) A state or local ~~government~~GOVERNMENTAL entity or public accommodation operating in this state
2 may not:

3 (a) connect an individual's ~~medical records~~ VACCINATION STATUS OR IMMUNITY PASSPORT, digitally or
4 otherwise, to an individual's government-issued records or identification, including but not limited to a passport,
5 driver's license, identification card, birth certificate, or social security card;

6 (b) require an individual to offer proof of vaccination status or immunity passport in order to obtain,
7 maintain, or renew any government-issued card, government benefits, OR public assistance as defined in 53-2-
8 101, ~~or membership card related to a private business~~; OR

9 ~~(c) compel or coerce an individual to receive any pharmaceutical product or intervention; or~~

10 ~~(d)~~(C) require vaccination status or immunity passport to access or acquire common life-sustaining
11 goods and services available to the public, including but not limited to food, child care products, and
12 medication.

13 ~~(2) For the purposes of this section, medical records include:~~

14 ~~(a) medical records controlled by a government entity; and~~

15 ~~(b) vaccination status or immunity passport.~~

16 ~~(3)~~(2) A person, public accommodation, or a ~~government~~GOVERNMENTAL entity that requires an
17 individual to present a driver's license or an identification card ~~as proof of driving or~~ FOR traveling privileges may
18 not:

19 (a) require an individual to offer proof of vaccination status or immunity passport in order to travel; or

20 (b) ~~discriminate against~~, deny services or access for services, segregate, publicly identify, or
21 otherwise penalize an individual for not receiving a vaccination or providing proof of immunity from any
22 communicable disease.

23 ~~(4)~~(3) This section does not apply to a person who is confirmed to have a communicable disease and
24 is quarantined under a public isolation order.

26 **Section 2.** Section 13-1-116, MCA, is amended to read:

27 **"13-1-116. Fingerprint, mark, or agent for disabled electors -- rulemaking.** (1) Except as
28 otherwise specified by law, the provisions of this section apply.

1 (2) Whenever a signature is required by an elector under a provision of this title and the elector is
2 unable because of a disability to provide a signature, the elector may provide a fingerprint, subject to
3 subsection (6), or an identifying mark or may request that an agent, election administrator, or election judge
4 sign for the elector as provided in this section.

5 (3) If an elector is unable to provide a fingerprint or an identifying mark and the elector has not
6 established an agent pursuant to subsection (4), the election administrator or an election judge may sign for the
7 elector after reviewing and verifying the elector's identification.

8 (4) (a) An elector who is unable to provide a signature may apply to the election administrator to have
9 another person designated as an agent for purposes of providing a signature or identifying mark required
10 pursuant to this title and for providing any other assistance to the elector throughout the registration and voting
11 process. The use of an agent is a reasonable accommodation under the provisions of 49-2-101(19)(20)(b).

12 (b) An application for designation of an agent by an elector under this section must be made on a
13 form prescribed by the secretary of state. The secretary of state shall by rule establish the criteria that must be
14 met and the process that must be followed in order for a person to become a designated agent for a disabled
15 elector pursuant to this subsection (4).

16 (5) If an election administrator or election judge signs or marks a document for an elector pursuant to
17 this section, the election administrator or election judge shall initial the signature or mark.

18 (6) A disabled elector may not be required to provide a fingerprint."

20 **Section 3.** Section 49-2-101, MCA, is amended to read:

21 **"49-2-101. Definitions.** As used in this chapter, unless the context requires otherwise, the following
22 definitions apply:

23 (1) "Age" means number of years since birth. It does not mean level of maturity or ability to handle
24 responsibility. These latter criteria may represent legitimate considerations as reasonable grounds for
25 discrimination without reference to age.

26 (2) "Aggrieved party" means a person who can demonstrate a specific personal and legal interest, as
27 distinguished from a general interest, and who has been or is likely to be specially and injuriously affected by a
28 violation of this chapter.

- 1 (3) "Commission" means the commission for human rights provided for in 2-15-1706.
- 2 (4) "Commissioner" means the commissioner of labor and industry provided for in 2-15-1701.
- 3 (5) "Credit" means the right granted by a creditor to a person to defer payment of a debt, to incur debt
4 and defer its payment, or to purchase property or services and defer payment. It includes without limitation the
5 right to incur and defer debt that is secured by residential real property.
- 6 (6) "Credit transaction" means any invitation to apply for credit, application for credit, extension of
7 credit, or credit sale.
- 8 (7) "Creditor" means a person who, regularly or as a part of the person's business, arranges for the
9 extension of credit for which the payment of a financial charge or interest is required, whether in connection
10 with loans, sale of property or services, or otherwise.
- 11 (8) "Department" means the department of labor and industry provided for in 2-15-1701.
- 12 (9) "Educational institution" means a public or private institution and includes an academy; college;
13 elementary or secondary school; extension course; kindergarten; nursery; school system; university; business,
14 nursing, professional, secretarial, technical, or vocational school; or agent of an educational institution.
- 15 (10) (a) "Employee" means an individual employed by an employer.
- 16 (b) The term does not include an individual providing services for an employer if the individual has an
17 independent contractor exemption certificate issued under 39-71-417 and is providing services under the terms
18 of that certificate.
- 19 (11) "Employer" means an employer of one or more persons or an agent of the employer but does not
20 include a fraternal, charitable, or religious association or corporation if the association or corporation is not
21 organized either for private profit or to provide accommodations or services that are available on a
22 nonmembership basis.
- 23 (12) "Employment agency" means a person undertaking to procure employees or opportunities to
24 work.
- 25 (13) "Financial institution" means a commercial bank, trust company, savings bank, finance company,
26 savings and loan association, credit union, investment company, or insurance company.
- 27 (14) "Housing accommodation" means a building or portion of a building, whether constructed or to be
28 constructed, that is or will be used as the sleeping quarters of its occupants.

1 (15) "Immunity passport" means a document, digital record, or software application indicating that a
2 person is immune to a disease, either through vaccination or infection and recovery.

3 ~~(15)~~(16) "Labor organization" means an organization or an agent of an organization organized for the
4 purpose, in whole or in part, of collective bargaining, of dealing with employers concerning grievances or terms
5 or conditions of employment, or of other mutual aid and protection of employees.

6 ~~(16)~~(17) "National origin" means ancestry.

7 ~~(17)~~(18) (a) "Organization" means a corporation, association, or any other legal or commercial entity
8 that engages in advocacy of, enforcement of, or compliance with legal interests affected by this chapter.

9 (b) The term does not include a labor organization.

10 ~~(18)~~(19) "Person" means one or more individuals, labor unions, partnerships, associations,
11 corporations, legal representatives, mutual companies, joint-stock companies, trusts, unincorporated
12 employees' associations, employers, employment agencies, organizations, or labor organizations.

13 ~~(19)~~(20) (a) "Physical or mental disability" means:

14 (i) a physical or mental impairment that substantially limits one or more of a person's major life
15 activities;

16 (ii) a record of such an impairment; or

17 (iii) a condition regarded as such an impairment.

18 (b) Discrimination based on, because of, on the basis of, or on the grounds of physical or mental
19 disability includes the failure to make reasonable accommodations that are required by an otherwise qualified
20 person who has a physical or mental disability. An accommodation that would require an undue hardship or that
21 would endanger the health or safety of any person is not a reasonable accommodation.

22 ~~(20)~~(21) (a) "Public accommodation" means a place that caters or offers its services, goods, or
23 facilities to the general public subject only to the conditions and limitations established by law and applicable to
24 all persons. It includes without limitation a public inn, restaurant, eating house, hotel, roadhouse, place where
25 food or alcoholic beverages or malt liquors are sold for consumption, motel, soda fountain, soft drink parlor,
26 tavern, nightclub, trailer park, resort, campground, barbering, barbering nonchemical, cosmetology, electrology,
27 esthetics, or manicuring salon or shop, bathroom, resthouse, theater, swimming pool, skating rink, golf course,
28 cafe, ice cream parlor, transportation company, or hospital and all other public amusement and business

1 establishments.

2 (b) Public accommodation does not include an institution, club, or place of accommodation that
 3 proves that it is by its nature distinctly private. An institution, club, or place of accommodation may not be
 4 considered by its nature distinctly private if it has more than 100 members, provides regular meal service, and
 5 regularly receives payment for dues, fees, use of space, facilities, services, meals, or beverages, directly or
 6 indirectly, from or on behalf of nonmembers, for the furtherance of trade or business. For the purposes of this
 7 subsection ~~(20)~~ (21), any lodge of a recognized national fraternal organization is considered by its nature
 8 distinctly private.

9 (22) "Vaccination status" means an indication of whether a person has received one or more doses of
 10 a vaccination."

11
 12 **NEW SECTION. Section 4. Appropriation.** There is appropriated \$500 from the general fund to the
 13 department of labor and industry for the biennium beginning July 1, 2021, to provide online notice of immunity
 14 passport laws.

15
 16 **NEW SECTION. Section 5. Codification instruction.** [Section 1] is intended to be codified as an
 17 integral part of Title 49, chapter 2, part 3, and the provisions of Title 49, chapter 2, part 3, apply to [section 1].

 19 **NEW SECTION. Section 6. Severability.** If a part of [this act] is invalid, all valid parts that are
 20 severable from the invalid part remain in effect. If a part of [this act] is invalid in one or more of its applications,
 21 the part remains in effect in all valid applications that are severable from the invalid applications.

 23 **COORDINATION SECTION. SECTION 7. COORDINATION INSTRUCTION. IF BOTH HOUSE BILL NO. 702 AND**
 24 **[THIS ACT] ARE PASSED AND APPROVED AND IF A SUBSECTION OF [SECTION 1] OF HOUSE BILL NO. 702 DEFINES THE**
 25 **TERMS "IMMUNITY PASSPORT" AND "VACCINATION STATUS" AND [THIS ACT] AMENDS 49-2-101 TO DEFINE THE TERMS**
 26 **"IMMUNITY PASSPORT" AND "VACCINATION STATUS", THEN THE SUBSECTION DEFINING THOSE TERMS IN [SECTION 1] OF**
 27 **HOUSE BILL NO. 702 IS VOID.**
