5	A BILL FOR AN ACT ENTITLED: "AN ACT REVISING TAX CREDITS FOR ENERGY CONSERVATION;
6	INCREASING THE CREDIT FOR ENERGY-CONSERVING EXPENDITURES AND ALLOWING IT TO BE
7	REFUNDED; REPEALING THE OBSOLETE CREDIT FOR UTILITIES AND FINANCIAL INSTITUTIONS THAT
8	MADE LOANS FOR ENERGY CONSERVATION MATERIALS; PROVIDING RULEMAKING AUTHORITY;
9	AMENDING SECTIONS 15-32-101, 15-32-106, 15-32-109, AND 69-3-1209, MCA; REPEALING SECTIONS
10	15-32-107 AND 69-3-713, MCA; AND PROVIDING AN IMMEDIATE EFFECTIVE DATE AND A
11	RETROACTIVE APPLICABILITY DATE."

13	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:
14	
15	Section 1. Section 15-32-101, MCA, is amended to read:
16	"15-32-101. Purpose. The purpose of this part is to encourage the use of alternative energy sources
17	and the conservation of energy through incentive programs. The incentives are to be made available to the
18	energy user on a basis that requires the energy user to take the initiative in obtaining a particular incentive. This
19	part allows but does not require a public utility to extend credit for energy conservation investments."
20	
21	Section 2. Section 15-32-106, MCA, is amended to read:
22	"15-32-106. Procedure for obtaining benefit of deduction or credit. The department of revenue
23	shall provide forms on which a taxpayer may apply for a tax credit under 15-32-109. The department of revenue
24	shall approve a deduction or credit under 15-32-103 or 15-32-109 that demonstrably promotes energy
25	conservation or uses a recognized nonfossil form of energy generation. The department of revenue may refer a
26	deduction or credit involving energy generation to the department of environmental quality for its advice, and
27	the department of environmental quality shall respond within 60 days. The department of revenue may refer a
28	deduction or credit involving energy conservation to the department of labor and industry or the department of

1	environmental quality for its-advice, and the department of labor and industry agency shall respond within 60
2	days. The department of revenue may deny a deduction or credit that it finds to be impractical or ineffective."
3	
4	Section 3. Section 15-32-109, MCA, is amended to read:
5	"15-32-109. Credit for energy-conserving expenditures. (1) Subject to the restrictions of
6	subsection (2), a resident individual taxpayer may take a credit against the taxpayer's tax liability under chapter
7	30 for 25% of the taxpayer's expenditure for a capital investment in the physical attributes of a building or the
8	installation of a water, heating, or cooling system in the building, so long as either type of investment is for an
9	energy conservation purpose, in an amount not to exceed \$500 <u>\$800</u> .
10	(2) The credit under subsection (1):
11	(a) may not exceed be refunded if it exceeds the taxpayer's tax liability; and
12	(b) is subject to the provisions of 15-32-104."
13	
14	Section 4. Section 69-3-1209, MCA, is amended to read:
15	"69-3-1209. Electric utility demand-side management programs. (1) The commission may
16	establish energy savings and peak demand reduction goals for an electric utility, taking into account the utility's
17	cost-effective demand-side management potential and the need for electricity resources.
18	(2) The commission shall permit electric utilities to implement cost-effective electricity demand-side
19	management programs and conservation in accordance with 69-3-701 through 69-3-71369-3-712 and this part
20	to reduce the need for additional resources.
21	(3) Every 3 years, an electric utility shall submit a report to the commission describing the demand-
22	side management programs and conservation implemented by the electric utility in the previous year. The
23	report must document:
24	(a) program expenditures, including incentive payments;
25	(b) peak demand and energy savings impacts and the techniques used to estimate those impacts;
26	(c) avoided costs and the techniques used to estimate those costs;
27	(d) the estimated cost-effectiveness of the programs;
28	(e) the net economic benefits of the programs; and



1	(f) any other information required by the commission."
2	
3	NEW SECTION. Section 5. Repealer. The following sections of the Montana Code Annotated are
4	repealed:
5	15-32-107. Loans by utilities and financial institutions tax credit for interest differential for loans made
6	prior to July 1, 1995.
7	69-3-713. (Temporary) Prohibition against utility claiming conservation tax credit.
8	
9	NEW SECTION. Section 6. Effective date. [This act] is effective on passage and approval.
10	
11	NEW SECTION. Section 7. Retroactive applicability. [This act] applies retroactively, within the
12	meaning of 1-2-109, to income tax years beginning after December 31, 2020.
