4 A BILL FOR AN ACT ENTITLED: "AN ACT GENERALLY REVISING CAMPAIGN FINANCE LAWS;
 5 INCREASING THE CAMPAIGN FINANCE DISCLOSURE MONETARY THRESHOLD; PROHIBITING THE
 6 COMMISSIONER OF POLITICAL PRACTICES FROM REQUESTING ADDITIONAL INFORMATION IN
 7 DISCLOSURE REPORTS; PROVIDING THAT A PERSON WHO HOSTS A FUNDRAISING RECEPTION OR
 8 OTHER POLITICAL EVENT ON THEIR PROPERTY IS NOT MAKING A CONTRIBUTION; REVISING
 9 REPORTING DEADLINES AND REQUIREMENTS; PROVIDING CERTAIN REPORTING EXCEPTIONS;
 10 REVISING INCIDENTAL COMMITTEE FILING REQUIREMENTS; PROVIDING THAT CERTAIN
 11 CANDIDATES MAY USE THE SAME ACCOUNT IN A CAMPAIGN DEPOSITORY FOR PRIMARY AND
 12 GENERAL ELECTIONS FUNDS UNDER CERTAIN CIRCUMSTANCES; INCREASING AGGREGATE
 13 CONTRIBUTION LIMITS BY A POLITICAL COMMITTEE, POLITICAL PARTY COMMITTEE, AND AN
 14 INDIVIDUAL TO A CANDIDATE; INCREASING LIMITS ON TOTAL COMBINED MONETARY
 15 CONTRIBUTIONS BY CERTAIN POLITICAL COMMITTEES TO CERTAIN CANDIDATES; DIRECTING THE
 16 AMENDMENT OF ARM 44.11.502; REPEALING NAMING AND LABELING PROVISIONS REGARDING
 17 POLITICAL COMMITTEES; REPEALING AGGREGATE CONTRIBUTION LIMITS RECEIVED BY CERTAIN
 18 CANDIDATES; REVISING DEFINITIONS; AMENDING SECTIONS 13-1-101, 13-37-205, 13-37-216, 13-37-
 19 218, AND 13-37-226, 13-37-229, AND 13-37-232, MCA; AND REPEALING SECTIONS SECTION 13-37-210
 20 AND 13-37-218, MCA."

22 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

23

24 **Section 1.** Section 13-1-101, MCA, is amended to read:

25 **"13-1-101. Definitions.** As used in this title, unless the context clearly indicates otherwise, the
 26 following definitions apply:

27 (1) "Active elector" means an elector whose name has not been placed on the inactive list due to
 28 failure to respond to confirmation notices pursuant to 13-2-220 or 13-19-313.

1 (2) "Active list" means a list of active electors maintained pursuant to 13-2-220.

2 (3) "Anything of value" means any goods that have a certain utility to the recipient that is real and that
3 is ordinarily not given away free but is purchased.

4 (4) "Application for voter registration" means a voter registration form prescribed by the secretary of
5 state that is completed and signed by an elector, is submitted to the election administrator, and contains voter
6 registration information subject to verification as provided by law.

7 (5) "Ballot" means a paper ballot counted manually or a paper ballot counted by a machine, such as
8 an optical scan system or other technology that automatically tabulates votes cast by processing the paper
9 ballots.

10 (6) (a) "Ballot issue" or "issue" means a proposal submitted to the people at an election for their
11 approval or rejection, including but not limited to an initiative, referendum, proposed constitutional amendment,
12 recall question, school levy question, bond issue question, or ballot question.

13 (b) For the purposes of chapters 35 and 37, an issue becomes a "ballot issue" upon certification by
14 the proper official that the legal procedure necessary for its qualification and placement on the ballot has been
15 completed, except that a statewide issue becomes a "ballot issue" upon preparation and transmission by the
16 secretary of state of the form of the petition or referral to the person who submitted the proposed issue.

17 (7) "Ballot issue committee" means a political committee specifically organized to support or oppose a
18 ballot issue.

19 (8) "Candidate" means:

20 (a) an individual who has filed a declaration or petition for nomination, acceptance of nomination, or
21 appointment as a candidate for public office as required by law;

22 (b) for the purposes of chapter 35, 36, or 37, an individual who has solicited or received and retained
23 contributions, made expenditures, or given consent to an individual, organization, political party, or committee
24 to solicit or receive and retain contributions or make expenditures on the individual's behalf to secure
25 nomination or election to any office at any time, whether or not the office for which the individual will seek
26 nomination or election is known when the:

27 (i) solicitation is made;

28 (ii) contribution is received and retained; or

1 (iii) expenditure is made; or

2 (c) an officeholder who is the subject of a recall election.

3 (9) (a) "Contribution" means:

4 (i) the receipt by a candidate or a political committee of an advance, gift, loan, conveyance, deposit,
5 payment, or distribution of money or anything of value to support or oppose a candidate or a ballot issue;

6 (ii) an expenditure, including an in-kind expenditure, that is made in coordination with a candidate or
7 ballot issue committee and is reportable by the candidate or ballot issue committee as a contribution;

8 (iii) the receipt by a political committee of funds transferred from another political committee; or

9 (iv) the payment by a person other than a candidate or political committee of compensation for the
10 personal services of another person that are rendered to a candidate or political committee.

11 (b) The term does not mean:

12 (i) services provided without compensation by individuals volunteering a portion or all of their time on
13 behalf of a candidate or political committee;

14 (ii) or meals and lodging provided by individuals in their private residences for a candidate or other
15 individual; or

16 (iii) the use of a person's real property for a fundraising reception or other political event.

17 (c) This definition does not apply to Title 13, chapter 37, part 6.

18 (10) "Coordinated", including any variations of the term, means made in cooperation with, in
19 consultation with, at the request of, or with the express prior consent of a candidate or political committee or an
20 agent of a candidate or political committee.

21 (11) "De minimis act" means an action, contribution, or expenditure that is so small that it does not
22 trigger registration, reporting, disclaimer, or disclosure obligations under Title 13, chapter 35 or 37, or warrant
23 enforcement as a campaign practices violation under Title 13, chapter 37.

24 (12) "Election" means a general, special, or primary election held pursuant to the requirements of state
25 law, regardless of the time or purpose.

26 (13) (a) "Election administrator" means, except as provided in subsection (13)(b), the county clerk and
27 recorder or the individual designated by a county governing body to be responsible for all election
28 administration duties, except that with regard to school elections not administered by the county, the term

1 means the school district clerk.

2 (b) As used in chapter 2 regarding voter registration, the term means the county clerk and recorder or
3 the individual designated by a county governing body to be responsible for all election administration duties
4 even if the school election is administered by the school district clerk.

5 (14) (a) "Election communication" means the following forms of communication to support or oppose a
6 candidate or ballot issue:

7 (i) a paid advertisement broadcast over radio, television, cable, or satellite;

8 (ii) paid placement of content on the internet or other electronic communication network;

9 (iii) a paid advertisement published in a newspaper or periodical or on a billboard;

10 (iv) a mailing; or

11 (v) printed materials.

12 (b) The term does not mean:

13 (i) an activity or communication for the purpose of encouraging individuals to register to vote or to
14 vote, if that activity or communication does not mention or depict a clearly identified candidate or ballot issue;

15 (ii) a communication that does not support or oppose a candidate or ballot issue;

16 (iii) a bona fide news story, commentary, blog, or editorial distributed through the facilities of any
17 broadcasting station, newspaper, magazine, internet website, or other periodical publication of general
18 circulation;

19 (iv) a communication by any membership organization or corporation to its members, stockholders, or
20 employees; or

21 (v) a communication that the commissioner determines by rule is not an election communication.

22 (15) "Election judge" means a person who is appointed pursuant to Title 13, chapter 4, part 1, to
23 perform duties as specified by law.

24 (16) (a) "Electioneering communication" means a paid communication that is publicly distributed by
25 radio, television, cable, satellite, internet website, newspaper, periodical, billboard, mail, or any other
26 distribution of printed materials, that is made within 60 days of the initiation of voting in an election, that does
27 not support or oppose a candidate or ballot issue, that can be received by more than 100 recipients in the
28 district voting on the candidate or ballot issue, and that:

- 1 (i) refers to one or more clearly identified candidates in that election;
- 2 (ii) depicts the name, image, likeness, or voice of one or more clearly identified candidates in that
3 election; or
- 4 (iii) refers to a political party, ballot issue, or other question submitted to the voters in that election.
- 5 (b) The term does not mean:
- 6 (i) a bona fide news story, commentary, blog, or editorial distributed through the facilities of any
7 broadcasting station, newspaper, magazine, internet website, or other periodical publication of general
8 circulation unless the facilities are owned or controlled by a candidate or political committee;
- 9 (ii) a communication by any membership organization or corporation to its members, stockholders, or
10 employees;
- 11 (iii) a commercial communication that depicts a candidate's name, image, likeness, or voice only in the
12 candidate's capacity as owner, operator, or employee of a business that existed prior to the candidacy;
- 13 (iv) a communication that constitutes a candidate debate or forum or that solely promotes a candidate
14 debate or forum and is made by or on behalf of the person sponsoring the debate or forum; or
- 15 (v) a communication that the commissioner determines by rule is not an electioneering
16 communication.
- 17 (17) "Elector" means an individual qualified to vote under state law.
- 18 (18) (a) "Expenditure" means a purchase, payment, distribution, loan, advance, promise, pledge, or
19 gift of money or anything of value:
- 20 (i) made by a candidate or political committee to support or oppose a candidate or a ballot issue; or
- 21 (ii) used or intended for use in making independent expenditures or in producing electioneering
22 communications.
- 23 (b) The term does not mean:
- 24 (i) services, food, or lodging provided in a manner that they are not contributions under subsection
25 (9);
- 26 (ii) payments by a candidate for personal travel expenses, food, clothing, lodging, or personal
27 necessities for the candidate and the candidate's family;
- 28 (iii) the cost of any bona fide news story, commentary, blog, or editorial distributed through the facilities

1 of any broadcasting station, newspaper, magazine, or other periodical publication of general circulation; ~~or~~
2 (iv) the cost of any communication by any membership organization or corporation to its members or
3 stockholders or employees; or

4 (v) the use of a person's real property for a fundraising reception or other political event.

5 (c) This definition does not apply to Title 13, chapter 37, part 6.

6 (19) "Federal election" means an election in even-numbered years in which an elector may vote for
7 individuals for the office of president of the United States or for the United States congress.

8 (20) "General election" means an election that is held for offices that first appear on a primary election
9 ballot, unless the primary is canceled as authorized by law, and that is held on a date specified in 13-1-104.

10 (21) "Inactive elector" means an individual who failed to respond to confirmation notices and whose
11 name was placed on the inactive list pursuant to 13-2-220 or 13-19-313.

12 (22) "Inactive list" means a list of inactive electors maintained pursuant to 13-2-220 or 13-19-313.

13 (23) (a) "Incidental committee" means a political committee that is not specifically organized or
14 operating for the primary purpose of supporting or opposing candidates or ballot issues but that may
15 incidentally become a political committee by receiving a contribution or making an expenditure.

16 (b) For the purpose of this subsection (23), the primary purpose is determined by the commissioner
17 by rule and includes criteria such as the allocation of budget, staff, or members' activity or the statement of
18 purpose or goal of the person or individuals that form the committee.

19 (24) "Independent committee" means a political committee organized for the primary purpose of
20 receiving contributions and making expenditures that is not controlled either directly or indirectly by a candidate
21 and that does not coordinate with a candidate in conjunction with the making of expenditures except pursuant
22 to the limits set forth in 13-37-216(1).

23 (25) "Independent expenditure" means an expenditure for an election communication to support or
24 oppose a candidate or ballot issue made at any time that is not coordinated with a candidate or ballot issue
25 committee.

26 (26) "Individual" means a human being.

27 (27) "Legally registered elector" means an individual whose application for voter registration was
28 accepted, processed, and verified as provided by law.

1 (28) "Mail ballot election" means any election that is conducted under Title 13, chapter 19, by mailing
2 ballots to all active electors.

3 (29) "Person" means an individual, corporation, association, firm, partnership, cooperative, committee,
4 including a political committee, club, union, or other organization or group of individuals or a candidate as
5 defined in subsection (8).

6 (30) "Place of deposit" means a location designated by the election administrator pursuant to 13-19-
7 307 for a mail ballot election conducted under Title 13, chapter 19.

8 (31) (a) "Political committee" means a combination of two or more individuals or a person other than
9 an individual who receives a contribution or makes an expenditure:

10 (i) to support or oppose a candidate or a committee organized to support or oppose a candidate or a
11 petition for nomination;

12 (ii) to support or oppose a ballot issue or a committee organized to support or oppose a ballot issue; or

13 (iii) to prepare or disseminate an election communication, an electioneering communication, or an
14 independent expenditure.

15 (b) Political committees include ballot issue committees, incidental committees, independent
16 committees, and political party committees.

17 (c) A candidate and the candidate's treasurer do not constitute a political committee.

18 (d) A political committee is not formed when a combination of two or more individuals or a person
19 other than an individual makes an election communication, an electioneering communication, or an
20 independent expenditure of \$250 or less.

21 (32) "Political party committee" means a political committee formed by a political party organization
22 and includes all county and city central committees.

23 (33) "Political party organization" means a political organization that:

24 (a) was represented on the official ballot in either of the two most recent statewide general elections;

25 or

26 (b) has met the petition requirements provided in Title 13, chapter 10, part 5.

27 (34) "Political subdivision" means a county, consolidated municipal-county government, municipality,
28 special purpose district, or any other unit of government, except school districts, having authority to hold an

1 election.

2 (35) "Polling place election" means an election primarily conducted at polling places rather than by
3 mail under the provisions of Title 13, chapter 19.

4 (36) "Primary" or "primary election" means an election held on a date specified in 13-1-107 to nominate
5 candidates for offices filled at a general election.

6 (37) "Provisional ballot" means a ballot cast by an elector whose identity or eligibility to vote has not
7 been verified as provided by law.

8 (38) "Provisionally registered elector" means an individual whose application for voter registration was
9 accepted but whose identity or eligibility has not yet been verified as provided by law.

10 (39) "Public office" means a state, county, municipal, school, or other district office that is filled by the
11 people at an election.

12 (40) "Random-sample audit" means an audit involving a manual count of ballots from designated races
13 and ballot issues in precincts selected through a random process as provided in 13-17-503.

14 (41) "Registrar" means the county election administrator and any regularly appointed deputy or
15 assistant election administrator.

16 (42) "Regular school election" means the school trustee election provided for in 20-20-105(1).

17 (43) "School election" has the meaning provided in 20-1-101.

18 (44) "School election filing officer" means the filing officer with whom the declarations for nomination
19 for school district office were filed or with whom the school ballot issue was filed.

20 (45) "School recount board" means the board authorized pursuant to 20-20-420 to perform recount
21 duties in school elections.

22 (46) "Signature envelope" means an envelope that contains a secrecy envelope and ballot and that is
23 designed to:

24 (a) allow election officials, upon examination of the outside of the envelope, to determine that the
25 ballot is being submitted by someone who is in fact a qualified elector and who has not already voted; and

26 (b) allow it to be used in the United States mail.

27 (47) "Special election" means an election held on a day other than the day specified for a primary
28 election, general election, or regular school election.

1 (48) "Special purpose district" means an area with special boundaries created as authorized by law for
2 a specialized and limited purpose.

3 (49) "Statewide voter registration list" means the voter registration list established and maintained
4 pursuant to 13-2-107 and 13-2-108.

5 (50) "Support or oppose", including any variations of the term, means:

6 (a) using express words, including but not limited to "vote", "oppose", "support", "elect", "defeat", or
7 "reject", that call for the nomination, election, or defeat of one or more clearly identified candidates, the election
8 or defeat of one or more political parties, or the passage or defeat of one or more ballot issues submitted to
9 voters in an election; or

10 (b) otherwise referring to or depicting one or more clearly identified candidates, political parties, or
11 ballot issues in a manner that is susceptible of no reasonable interpretation other than as a call for the
12 nomination, election, or defeat of the candidate in an election, the election or defeat of the political party, or the
13 passage or defeat of the ballot issue or other question submitted to the voters in an election.

14 (51) "Valid vote" means a vote that has been counted as valid or determined to be valid as provided in
15 13-15-206.

16 (52) "Voted ballot" means a ballot that is:

- 17 (a) deposited in the ballot box at a polling place;
18 (b) received at the election administrator's office; or
19 (c) returned to a place of deposit.

20 (53) "Voter interface device" means a voting system that:

- 21 (a) is accessible to electors with disabilities;
22 (b) communicates voting instructions and ballot information to a voter;
23 (c) allows the voter to select and vote for candidates and issues and to verify and change selections;

24 and

25 (d) produces a paper ballot that displays electors' choices so the elector can confirm the ballot's
26 accuracy and that may be manually counted.

27 (54) "Voting system" or "system" means any machine, device, technology, or equipment used to
28 automatically record, tabulate, or process the vote of an elector cast on a paper ballot."

SECTION 2. SECTION 13-37-205, MCA, IS AMENDED TO READ:

"13-37-205. Campaign depositories. (1) Except as provided in 13-37-206, each candidate and each political committee shall designate one primary campaign depository for the purpose of depositing all contributions received and disbursing all expenditures made by the candidate or political committee.

(2) The candidate or political committee may also designate one secondary depository in each county in which an election is held and in which the candidate or committee participates. Deputy campaign treasurers may make deposits in and expenditures from secondary depositories when authorized to do so as provided in 13-37-202(2).

(3) Only a bank, credit union, savings and loan association, or building and loan association authorized to transact business in Montana may be designated as a campaign depository.

(4) The candidate or political committee shall file the name and address of each designated primary and secondary depository at the same time and with the same officer with whom the candidate or committee files the name of the candidate's or committee's campaign treasurer pursuant to 13-37-201.

(5) This section does not prevent a political committee or candidate from having more than one campaign account in the same depository, but a candidate may not utilize the candidate's regular or personal account in the depository as a campaign account.

(6) A candidate for the legislature may use the same account in a campaign depository for primary election contributions received and general election contributions received and is not required to segregate the funds if:

(a) the candidate maintains records concerning whether contributions received are designated for the primary election or the general election; and

(b) the balance in the account that contains co-mingled primary election funds and general election funds does not drop below the amount of general election contributions received until after the day of the primary election."

SECTION 3. SECTION 13-37-216, MCA, IS AMENDED TO READ:

"13-37-216. Limitations on contributions -- adjustment. (1) (a) Subject to adjustment as provided

1 for in subsection (3) and subject to 13-35-227 and 13-37-219, aggregate contributions for each election in a
2 campaign by a political committee or by an individual, other than the candidate, to a candidate are limited as
3 follows:

4 (i) for candidates filed jointly for the office of governor and lieutenant governor, not to exceed ~~\$500~~
5 \$750;

6 (ii) for a candidate to be elected for state office in a statewide election, other than the candidates for
7 governor and lieutenant governor, not to exceed ~~\$250~~ \$500;

8 (iii) for a candidate for any other public office, not to exceed ~~\$130~~ \$400.

9 (b) A contribution to a candidate includes contributions made to any political committee organized on
10 the candidate's behalf. A political committee that is not independent of the candidate is considered to be
11 organized on the candidate's behalf.

12 (2) All political committees except those of political party organizations are subject to the provisions of
13 subsection (1). Political party organizations may form political committees that are subject to the following
14 aggregate limitations, adjusted as provided for in subsection (3) and subject to 13-37-219, from all political party
15 committees:

16 (a) for candidates filed jointly for the offices of governor and lieutenant governor, not to exceed
17 ~~\$18,000~~ \$27,000;

18 (b) for a candidate to be elected for state office in a statewide election, other than the candidates for
19 governor and lieutenant governor, not to exceed ~~\$6,500~~ \$9,000;

20 (c) for a candidate for public service commissioner, not to exceed ~~\$2,600~~ \$4,000;

21 (d) for a candidate for the state senate, not to exceed ~~\$1,050~~ \$2,000;

22 (e) for a candidate for any other public office, not to exceed ~~\$650~~ \$1,500.

23 (3) (a) The commissioner shall adjust the limitations in subsections (1) and (2) by multiplying each
24 limit by an inflation factor, which is determined by dividing the consumer price index for June of the year prior to
25 the year in which a general election is held by the consumer price index for June ~~2002~~ 2021.

26 (b) The resulting figure must be rounded up or down to the nearest:

27 (i) \$10 increment for the limits established in subsection (1); and

28 (ii) \$50 increment for the limits established in subsection (2).

1 (c) The commissioner shall publish the revised limitations as a rule.

2 (4) A candidate may not accept any contributions, including in-kind contributions, in excess of the
3 limits in this section.

4 (5) For purposes of this section, "election" means the general election or a primary election that
5 involves two or more candidates for the same nomination. If there is not a contested primary, there is only one
6 election to which the contribution limits apply. If there is a contested primary, then there are two elections to
7 which the contribution limits apply."

8

9 **SECTION 4. SECTION 13-37-218, MCA, IS AMENDED TO READ:**

10 **"13-37-218. Limitations on receipts from political committees.** A candidate for the state senate
11 may receive no more than ~~\$2,150~~ \$9,000 in total combined monetary contributions from all political committees
12 contributing to the candidate's campaign, and a candidate for the state house of representatives may receive no
13 more than ~~\$1,300~~ \$5,000 in total combined monetary contributions from all political committees contributing to
14 the candidate's campaign. The limitations in this section must be multiplied by an inflation factor, which is
15 determined by dividing the consumer price index for June of the year prior to the year in which a general
16 election is held by the consumer price index for June ~~2003~~ 2021. The resulting figure must be rounded up or
17 down to the nearest \$50 increment. The commissioner shall publish the revised limitations as a rule. In-kind
18 contributions must be included in computing these limitation totals. The limitation provided in this section does
19 not apply to contributions made by a political party eligible for a primary election under 13-10-601."

20

21 **Section 5. SECTION 13-37-226, MCA, IS AMENDED TO READ:**

22 **"13-37-226. Time for filing reports.** (1) Except as provided in 13-37-206 and 13-37-225(3), a
23 candidate shall file reports required by 13-37-225(1)(a) containing the information required by 13-37-229, 13-
24 37-231, and 13-37-232 as follows:

25 (a) quarterly, due on the 5th day following a calendar quarter, beginning with the calendar quarter in
26 which funds are received or expended during the year or years prior to the election year that the candidate
27 expects to be on the ballot and ending in the final quarter of the year preceding the year of an election in which
28 the candidate participates;

1 (b) the 20th day of March, April, May, June, August, September, October, and November in the year
2 of an election in which the candidate participates;

3 (c) within 2 business days of receiving a contribution of ~~\$100~~ \$250 or more if the candidate is a
4 candidate for a statewide office or \$125 or more for any other candidate if the contribution is received between
5 the 15th day of the month preceding an election in which the candidate participates and the day ~~of~~ before the
6 election;

7 (d) within 2 business days of making an expenditure of ~~\$100~~ \$250 or more if the candidate is a
8 candidate for statewide office or \$125 or more for any other candidate if made between the 15th day of the
9 month preceding an election in which the candidate participates and the day ~~of~~ before the election;

10 (e) semiannually on the 10th day of March and September, starting in the year following an election in
11 which the candidate participates until the candidate files a closing report as specified in 13-37-228(3); and

12 (f) as provided by subsection (3).

13 (2) Except as provided in 13-37-206, 13-37-225(3), and 13-37-227, a political committee shall file
14 reports required by 13-35-225(1)(a) containing the information required by 13-37-229, 13-37-231, and 13-37-
15 232 as follows:

16 (a) quarterly, due on the 5th day following a calendar quarter, beginning with the calendar quarter in
17 which the political committee receives a contribution or makes an expenditure after an individual becomes a
18 candidate or an issue becomes a ballot issue, as defined in 13-1-101(6)(b), and ending in the final quarter of
19 the year preceding the year in which the candidate or the ballot issue appears on the ballot;

20 (b) the 30th day of March, April, May, June, August, September, October, and November in the year
21 of an election in which the political committee participates;

22 (c) within 2 business days of receiving a contribution, except as provided in 13-37-232, of \$500 or
23 more if received between the 25th day of the month before an election in which the political committee
24 participates and the day ~~of~~ before the election; and

25 (d) within 2 business days of making an expenditure of \$500 or more that is made between the 25th
26 day of the month before an election in which the political committee participates and the day ~~of~~ before the
27 election;

28 (e) quarterly, due on the 5th day following a calendar quarter, beginning in the calendar quarter

1 following a year of an election in which the political committee participates until the political committee files a

10 in his or her own campaign is always coordinated with, and is a campaign expense of, the campaign that must
11 be reported and disclosed as an expense by the campaign in the same manner as an expense paid through the
12 campaign depository account.

13 (2) An obligation to pay for a campaign expenditure is incurred on the date the obligation is made, and
14 shall be reported as a debt of the campaign until the campaign pays the obligation by making an expenditure.

15 (3) An expenditure is made on the date payment is made, or in the case of an in-kind expenditure, on
16 the date the consideration is given.

17 (4) The date of each expenditure shall be reported in the reporting period during which it is made.

18 (5) Expenditures made from the petty cash fund need not be reported, except that an accounting shall
