5 A BILL FOR AN ACT ENTITLED: "AN ACT EXTENDING TERMINATION OF THE MISSING INDIGENOUS
6 PERSONS TASK FORCE AND THE GRANT PROGRAM THE TASK FORCE ADMINISTERS; ADDING A
7 REPRESENTATIVE FROM THE OFFICE OF PUBLIC INSTRUCTION TO THE TASK FORCE; AUTHORIZING
8 THE TASK FORCE TO MAKE RECOMMENDATIONS TO FEDERAL, STATE, AND LOCAL AGENCIES;
9 PROVIDING AN APPROPRIATION; AMENDING SECTION 44-2-411, MCA; AMENDING SECTION 8,
10 CHAPTER 373, LAWS OF 2019, SECTION 3, CHAPTER 243, LAWS OF 2021, AND SECTION 2, CHAPTER
11 268, LAWS OF 2021; AND PROVIDING AN IMMEDIATE EFFECTIVE DATE."

13 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:
14

15 **Section 1.** Section 44-2-411, MCA, is amended to read:

16 **"44-2-411. (Temporary) Missing indigenous persons task force -- membership -- duties --**
17 **reporting.** (1) There is a missing indigenous persons task force. The task force is allocated to the department
18 of justice for staffing services and administrative purposes only.

19 (2) Task force members, including the presiding officer, must be appointed by the attorney general
20 or a designee of the attorney general. The task force membership must include but is not limited to:

- 21 (a) an employee of the department of justice who has expertise in the subject of missing persons;
22 (b) a representative from each federally recognized Indian tribe in Montana;
23 (c) a member from the Montana highway patrol; ~~and~~
24 (d) a representative from the attorney general's office; and
25 (e) a representative from the office of public instruction.

26 (3) While respecting the government-to-government relationship between the state and each tribe,
27 the primary duties of the task force are to:

- 1 (h) a description and the results of any noncompetitive grant awardee activities;
- 2 (i) a description of the activities and progress related to improving interagency communication,
- 3 cooperation, and collaboration and removing interjurisdictional barriers; and
- 4 (j) any other information the task force members find relevant to the task force's mission.
- 5 (6) In addition to the recommendations to federally recognized tribes in the state required under
- 6 subsection (3)(b), the task force may make recommendations to federal, state, and local agencies in carrying
- 7 out the task force's duties. (Terminates June 30, 2023 ~~2025~~ ~~2033~~--sec. 3, Ch. 243, L. 2021, sec. 2, Ch. 268,

22 NEW SECTION. **Section 5. Transfer of funds.** By July 15, 2023, the state treasurer shall transfer

1 indigenous persons task force established in 44-2-411 for the biennium beginning July 1, 2023, for the
2 purposes of providing matching funds to tribal agencies to implement the looping in native communities network
3 grant program established in 44-2-412. Any funds that are unencumbered by June 30, 2025, must revert to the
4 general fund.

5 (2) There is appropriated \$205,162 from the state general fund to the department of justice for the
6 biennium beginning July 1, 2023, for the purposes of filling 1.0 FTE to coordinate and manage the
7 administration of the missing persons indigenous task force in 44-2-411 and perform duties related to other
8 missing persons programs at the department.

9 (3) THE LEGISLATURE INTENDS THAT THE APPROPRIATIONS IN SUBSECTIONS (1) AND (2) BE CONSIDERED
10 PART OF THE ONGOING BASE FOR THE NEXT LEGISLATIVE SESSION.

12 NEW SECTION. Section 7. Notification to tribal governments. The secretary of state shall send a
13 copy of [this act] to each federally recognized tribal government in Montana.

15 NEW SECTION. Section 8. Effective date. [This act] is effective on passage and approval.
