13	prizes for individual live card games. Except during a tournament conducted under 23-5-317, all prizes must be			
14	awarded immediately upon on completion of each hand.			
15	(2) If a licensed operator conducts a promotional game of chance involving a live card game, the prize			
16	limit provided for in subsection (1) applies to prizes awarded as a result of the promotional game of chance.			
17	(2) For games in which a prize for an individual live card game exceeds the value of \$800, the			
18	licensed live card game operator shall pay to the department a tax of 15% of the winnings. The department may			
19	use the collected taxes to support gambling disorder treatment, including but not limited to public outreach and
