HOUSE BILL NO. 261

INTRODUCED BY S. GUNDERSON, R. FITZGERALD, B. BROWN, B. USHER

A BILL FOR AN ACT ENTITLED: "AN ACT REVISING LAWS RELATED TO BICYCLES; PROVIDING REGULATIONS FOR ELECTRICALLY ASSISTED BICYCLES; EXCLUDING ELECTRICALLY ASSISTED BICYCLES FROM THE DEFINITIONS OF "OFF-HIGHWAY VEHICLE", "MOPED", AND "MOTOR VEHICLE"; REVISING THE DEFINITION OF "ELECTRICALLY ASSISTED BICYCLE"; AMENDING SECTIONS 23-2-801, 61-1-101, AND 61-8-102, MCA; AND PROVIDING AN IMMEDIATE EFFECTIVE DATE."

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

NEW SECTION. Section 1. Electrically assisted bicycle. (1) Beginning January 1, 2024, a

manufacturer or distributor of electrically assisted bicycles as defined in 61-8-102 shall apply a label that is permanently affixed, in a prominent location, to each electrically assisted bicycle. The label must contain the classification number, top assisted speed, and motor wattage of the electrically assisted bicycle and must be printed in arial font in at least 9-point font size.

(2) A person may not tamper with or modify an electrically assisted bicycle in order to change the motor-powered speed capability or engagement of an electrically assisted bicycle unless the label required in subsection (1) indicating the classification is replaced after modification.

(3) An electrically assisted bicycle must comply with the equipment and manufacturing requirements of the United States consumer product safety commission as set forth in 16 CFR, part 1512, as of December 12, 2022.

(4) An electrically assisted bicycle must operate in a manner in which the electric motor is disengaged or ceases to function when the rider stops pedaling or when the brakes are applied.

(5) (a) Except as provided in subsections (5)(b) and (5)(c), an electrically assisted bicycle may be ridden, with the motor in operation, in places where bicycles that are solely human powered are allowed, including but not limited to streets, highways, roadways, bicycle lanes, and bicycle or shared-use paths.

(b) Following notice and a public hearing, a local authority or state agency having jurisdiction over

1 a bicycle or shared-use path may prohibit the motorized operation of a class 1 electrically assisted bicycle on
2 that path if it finds that a restriction is needed for safety reasons or compliance with other laws or legal
3 obligations.

4 (c) A local authority or state agency having jurisdiction over a bicycle or shared-use path may
5 prohibit the motorized operation of a class 2 or class 3 electrically assisted bicycle on that path.

6 (d) This section does not apply to a trail that is specifically designated as nonmotorized and that
7 has a natural surface tread that is made by clearing and grading the native soil with no added surfacing
8 materials. A local authority or state agency having jurisdiction over a trail described in this subsection (5)(d)
9 may regulate the use of an electric bicycle on that trail.

10 (6) No person under 16 years of age may operate a class 3 electrically assisted bicycle. A person
11 under 16 years of age may ride as a passenger on a class 3 electrically assisted bicycle that is designed to
12 accommodate passengers.

13 (7) All class 3 electrically assisted bicycles must be equipped with a speedometer that displays the
14 speed the bicycle is traveling in miles an hour.

16 **Section 2.** Section 23-2-801, MCA, is amended to read:

17 **"23-2-801. Definition.** (1) As used in this part, "off-highway vehicle" means a self-propelled vehicle
18 used for recreation or cross-country travel on public lands, trails, easements, lakes, rivers, or streams. The term
19 includes but is not limited to motorcycles, quadricycles, dune buggies, amphibious vehicles, air cushion
20 vehicles, and any other means of land transportation deriving motive power from any source other than muscle
21 or wind.

22 (2) ~~Off-highway vehicle~~ The term does not include:

23 (a) vehicles designed primarily for travel on, over, or in the water;

24 (b) snowmobiles; ~~or~~

25 (c) except as provided in 23-2-804, vehicles otherwise issued a certificate of title and registered
26 under the laws of the state, unless the vehicle is used for off-road recreation on public lands; or

27 (d) electrically assisted bicycles as defined in 61-8-102."

1 **Section 3.** Section 61-1-101, MCA, is amended to read:

2 **"61-1-101. Definitions.** As used in this title, unless the context indicates otherwise, the following
3 definitions apply:

4 (1) (a) "Authorized agent" means a person who has executed a written agreement with the
5 department and is specifically authorized by the department to electronically access and update the
6 department's motor vehicle titling, registration, or driver records, using an approved automated interface, for
7 specific functions or purposes on behalf of a third party.

8 (b) For purposes of this subsection (1), "person" means an individual, corporation, partnership,
9 limited partnership, limited liability company, association, joint venture, state agency, local government unit,
10 another state government, the United States, a political subdivision of this or another state, or any other legal or
11 commercial entity.

12 (2) "Authorized agent agreement" means the written agreement executed between an authorized
13 agent and the department that sets the technical and operational program standards, compliance criteria,
14 payment options, and service expectations by which the authorized agent is required to operate in performing
15 specific motor vehicle or driver-related record functions.

16 (3) "Autocycle" means a three-wheeled motorcycle that is equipped with safety belts, roll bars or
17 roll hoops, a steering wheel, and seating that does not require the operator to straddle or sit astride it.

18 (4) "Bus" means a motor vehicle designed for carrying more than 10 passengers and used for the
19 transportation of persons and any other motor vehicle, other than a taxicab, designed and used for the
20 transportation of persons for compensation.

21 (5) (a) "Business entity" means a corporation, association, partnership, limited liability partnership,
22 limited liability company, or other legal entity recognized under state law.

23 (b) The term does not include an individual.

24 (6) (a) "Camper" means a structure designed to be mounted in the cargo area of a truck or
25 attached to an incomplete vehicle for the purpose of providing shelter for persons. The term includes but is not
26 limited to a cab-over, half cab-over, noncab-over, telescopic, and telescopic cab-over.

27 (b) The term does not include a truck canopy cover or topper.

28 (7) "CDLIS driver record" means the electronic record of a person's commercial driver's license

1 status and history stored as part of the commercial driver's license system established under 49 U.S.C. 31309.

2 (8) "Certificate of title" means the paper record issued by the department or by the appropriate
3 agency of another jurisdiction that establishes a verifiable record of ownership between an identified person or
4 persons and the motor vehicle specifically described in the record and that provides notice of a perfected
5 security interest in the motor vehicle.

6 (9) "Commercial driver's license" means:

7 (a) a driver's license issued under or granted by the laws of this state that authorizes a person to
8 operate a class of commercial motor vehicle; or

9 (b) the privilege of a person to drive a commercial motor vehicle, whether or not the person holds a
10 valid commercial driver's license.

11 (10) (a) "Commercial motor vehicle" means a motor vehicle or combination of motor vehicles used
12 in commerce to transport passengers or property if the vehicle:

13 (i) has a gross combination weight rating or a gross combination weight of 26,001 pounds or
14 more, whichever is greater, inclusive of a towed unit with a gross vehicle weight rating of more than 10,000
15 pounds;

16 (ii) has a gross vehicle weight rating or a gross vehicle weight of 26,001 pounds or more,
17 whichever is greater;

18 (iii) is designed to transport at least 16 passengers, including the driver;

19 (iv) is a school bus; or

20 (v) is of any size and is used in the transportation of hazardous materials.

21 (b) The following vehicles are not commercial motor vehicles:

22 (i) an authorized emergency vehicle:

23 (A) equipped with audible and visual signals as required under 61-9-401 and 61-9-402; and

24 (B) operated when responding to or returning from an emergency call or operated in another
25 official capacity;

26 (ii) a vehicle:

27 (A) controlled and operated by a farmer, family member of the farmer, or person employed by the
28 farmer;

1 (B) used to transport farm products, farm machinery, or farm supplies to or from the farm within
2 Montana within 150 miles of the farm or, if there is a reciprocity agreement with a state adjoining Montana,
3 within 150 miles of the farm, including any area within that perimeter that is in the adjoining state; and

4 (C) not used to transport goods for compensation or for hire; or

5 (iii) a vehicle operated for military purposes by active duty military personnel, a member of the
6 military reserves, a member of the national guard on active duty, including personnel on full-time national guard
7 duty, personnel in part-time national guard training, and national guard military technicians, or active duty
8 United States coast guard personnel.

9 (c) For purposes of this subsection (10):

10 (i) "farmer" means a person who operates a farm or who is directly involved in the cultivation of
11 land or crops or the raising of livestock owned by or under the direct control of that person;

12 (ii) "gross combination weight rating" means the value specified by the manufacturer as the loaded
13 weight of a combination or articulated vehicle;

14 (iii) "gross vehicle weight rating" means the value specified by the manufacturer as the loaded
15 weight of a single vehicle; and

16 (iv) "school bus" has the meaning provided in 49 CFR 383.5.

17 (11) "Commission" means the state transportation commission.

18 (12) "Custom-built motorcycle" means a motorcycle that is equipped with:

19 (a) an engine that was manufactured 20 years prior to the current calendar year and that has been
20 altered from the manufacturer's original design; or

21 (b) an engine that was manufactured to resemble an engine 20 or more years old and that has
22 been constructed in whole or in part from nonoriginal materials.

23 (13) "Custom vehicle" means a motor vehicle other than a motorcycle that:

24 (a) (i) was manufactured with a model year after 1948 and that is at least 25 years old; or

25 (ii) was built to resemble a vehicle manufactured after 1948 and at least 25 years before the
26 current calendar year, including a kit vehicle intended to resemble a vehicle manufactured after 1948 and that is
27 at least 25 years old; and

28 (b) has been altered from the manufacturer's original design or has a body constructed from

1 nonoriginal materials.

2 (14) "Customer identification number" means:

3 (a) a driver's license or identification card number when the customer is an individual who has
4 been issued a driver's license or identification card by a state driver licensing authority;

5 (b) a federal employer or tax identification number when the customer is a business entity that has
6 been issued a federal employer or tax identification number;

7 (c) the identification number assigned by the secretary of state to a business entity authorized to
8 do business in this state under Title 35 if the customer is a business entity that does not have a federal
9 employer or tax identification number other than a social security number; or

10 (d) if the customer has not been issued one of the numbers described in subsections (14)(a)
11 through (14)(c), a number assigned to the customer by the department when a transaction is initiated under this
12 title.

13 (15) (a) "Dealer" means a person that, for commission or profit, engages in whole or in part in the
14 business of buying, selling, exchanging, or accepting on consignment new or used motor vehicles, trailers,
15 semitrailers, pole trailers, travel trailers, motorboats, sailboats, snowmobiles, off-highway vehicles, or special
16 mobile equipment that is not registered in the name of the person.

17 (b) The term does not include the following:

18 (i) receivers, trustees, administrators, executors, guardians, or other persons appointed by or
19 acting under a judgment or order of any court of competent jurisdiction;

20 (ii) employees of the persons included in subsection (15)(b)(i) when engaged in the specific
21 performance of their duties as employees; or

22 (iii) public officers while performing or in the operation of their duties.

23 (16) "Declared weight" means the total unladen weight of a vehicle plus the weight of the maximum
24 load to be carried on the vehicle as stated by the registrant in the application for registration.

25 (17) "Department" means the department of justice acting directly or through its duly authorized
26 officers or agents.

27 (18) "Dolly or converter gear" means a device consisting of one or two axles with a fifth wheel and
28 trailer tongue used to support the forward end of a semitrailer, converting a semitrailer into a trailer.

1 (19) "Domiciled" means a place where:

2 (a) an individual establishes residence;

3 (b) a business entity maintains its principal place of business;

4 (c) the business entity's registered agent maintains an address; or

5 (d) a business entity most frequently uses, dispatches, or controls a motor vehicle, trailer,
6 semitrailer, or pole trailer that it owns or leases.

7 (20) "Downgrade" means the removal of a person's privilege to operate a commercial motor vehicle,
8 as maintained by the department on the individual Montana driving record and the CDLIS driver record for that
9 person.

10 (21) "Driver" means a person who drives or is in actual physical control of a vehicle.

11 (22) "Driver's license" means a license or permit to operate a motor vehicle issued under or granted
12 by the laws of this state, including:

13 (a) any temporary license or learner license;

14 (b) the privilege of any person to drive a motor vehicle, whether or not the person holds a valid
15 license;

16 (c) any nonresident's driving privilege;

17 (d) a motorcycle endorsement; or

18 (e) a commercial driver's license.

19 (23) "Electric personal assistive mobility device" means a device that has two nontandem wheels, is
20 self-balancing, and is designed to transport only one person with an electric propulsion system that limits the
21 maximum speed of the device to 12½ miles an hour.

22 (24) "For hire" means an action performed for remuneration of any kind, whether paid or promised,
23 either directly or indirectly, or received or obtained through leasing, brokering, or buy-and-sell arrangements
24 from which a remuneration is obtained or derived for transportation service.

25 (25) (a) "Golf cart" means a motor vehicle that is designed for use on a golf course to carry a person
26 or persons and golf equipment and that has an average speed of less than 15 miles per hour.

27 (b) Except as provided in 61-3-201, a golf cart is exempt from titling, registration, and mandatory
28 liability insurance requirements under this title.

1 (26) "Gross vehicle weight" means the weight of a vehicle without load plus the weight of any load
2 on the vehicle.

3 (27) "Hazardous material" means:

4 (a) any material that has been designated as hazardous under 49 U.S.C. 5103 and is required to
5 be placarded under 49 CFR, part 172; or

6 (b) any quantity of a material listed as a select agent or toxin in 42 CFR, part 73.

7 (28) "Highway" or "public highway" means the entire width between the boundary lines of every
8 publicly maintained way when any part of the publicly maintained way is open to the use of the public for
9 purposes of vehicular travel.

10 (29) "Highway patrol officer" means a state officer authorized to direct or regulate traffic or to make
11 arrests for violations of traffic regulations.

12 (30) "Implement of husbandry" means a vehicle that is designed for agricultural purposes and
13 exclusively used by the owner of the vehicle in the conduct of the owner's agricultural operations.

14 (31) "Kit vehicle" is a motor vehicle assembled from a manufactured kit either as:

15 (a) a complete kit, consisting of a prefabricated body and chassis, to construct a new motor
16 vehicle; or

17 (b) a kit with a prefabricated body to be mounted to an existing motor vehicle chassis and
18 drivetrain, commonly referred to as a donor vehicle.

19 (32) "Light vehicle" means a motor vehicle commonly referred to as an automobile, van, sport utility
20 vehicle, or truck having a manufacturer's rated capacity of 1 ton or less.

21 (33) "Low-speed electric vehicle" means a motor vehicle, on or by which a person may be
22 transported, that:

23 (a) has four wheels;

24 (b) has a maximum speed of at least 20 miles an hour and no greater than 40 miles an hour as
25 certified by the manufacturer;

26 (c) is propelled by its own power, using an electric motor or other device that transforms stored
27 electrical energy into the motion of the vehicle;

28 (d) stores electricity in batteries, ultracapacitors, or similar devices, which are charged from the

1 power grid or from renewable electrical energy sources;

2 (e) has a wheelbase of 40 inches or greater and a wheel diameter of 10 inches or greater;

3 (f) exhibits a manufacturer's compliance with 49 CFR, part 565, or displays a 17-character vehicle

4 identification number as provided in 49 CFR, part 565; and

5 (g) is equipped as provided in 61-9-432.

6 (34) "Low-speed restricted driver's license" means a license limited to the operation of a low-speed

7 electric vehicle or a golf cart issued under or granted by the laws of this state, including:

8 (a) a temporary license or learner license;

9 (b) the privilege of a person to drive a low-speed electric vehicle or golf cart under the authority of
10 61-5-122, whether or not the person holds a valid driver's license; and

11 (c) a nonresident's similarly restricted driving privilege.

12 (35) "Manufactured home" has the meaning provided in 15-24-201.

13 (36) "Manufacturer" includes any person engaged in the manufacture of motor vehicles, trailers,
14 semitrailers, pole trailers, travel trailers, motorboats, sailboats, snowmobiles, or off-highway vehicles as a
15 regular business.

16 (37) "Manufacturer's certificate of origin" means the original paper record produced and issued by
17 the manufacturer of a vehicle or, if in a medium authorized by the department, an electronic record created and
18 transmitted by the manufacturer of a vehicle to the manufacturer's agent or a licensed dealer. The record must
19 establish the origin of the vehicle specifically described in the record and, upon assignment, transfers of
20 ownership of the vehicle to the person or persons named in the certificate.

21 (38) (a) "Medium-speed electric vehicle" is a motor vehicle, on or by which a person may be
22 transported, that:

23 (i) has a maximum speed of 45 miles an hour as certified by the manufacturer;

24 (ii) is propelled by its own power, using an electric motor or other device that transforms stored
25 electrical energy into the motion of the vehicle;

26 (iii) stores electricity in batteries, ultracapacitors, or similar devices, which are charged from the
27 power grid or from renewable electrical energy sources;

28 (iv) is fully enclosed and includes at least one door for entry;

5 (i) a vehicle propelled by its own power and designed or used to transport persons or property on

8 (iii) a golf cart only if it is equipped for use on the highways as prescribed in chapter 9 and is

10 (b) The term does not include a bicycle or a moped as defined in 61-8-102, an electrically assisted
11 bicycle as defined in 61-8-102, an electric personal assistive mobility device, a motorized nonstandard vehicle,
12 or a motorized wheelchair or other low-powered, mechanically propelled vehicle that is designed specifically for
13 use by a physically disabled person and that is used as a means of mobility for that person.

14 (44) (a) "Motorboat" means a vessel, including a personal watercraft or pontoon, propelled by any
15 machinery, motor, or engine of any description, whether or not the machinery, motor, or engine is the principal
16 source of propulsion. The term includes boats temporarily equipped with detachable motors or engines.

17 (b) The term does not include a vessel that has a valid marine document issued by the United
18 States coast guard or any successor federal agency.

19 (45) (a) "Motorcycle" means a motor vehicle that has a seat or saddle for the use of the operator
20 and that is designated to travel on not more than three wheels in contact with the ground. A motorcycle may
21 carry one or more attachments and a seat for the conveyance of a passenger.

22 (b) A motorcycle designed for use on highways is a motor vehicle unless otherwise prescribed.

23 (c) A motorcycle designed for off-road recreational use is an off-highway vehicle unless it has been
24 modified to meet the equipment standards specified in chapter 9 and has been registered for highway use.

25 (d) The term includes an autocycle.

26 (e) The term does not include a tractor, a bicycle or a moped as defined in 61-8-102, a motorized
27 nonstandard vehicle, or a two- or three-wheeled all-terrain vehicle that is used exclusively on private property.

28 (46) (a) "Motor-driven cycle" means a motorcycle, including a motor scooter, with a motor that

1 produces 5 horsepower or less.

2 (b) The term does not include a bicycle or a moped, as defined in 61-8-102, or a motorized
3 nonstandard vehicle.

4 (47) (a) "Motorized nonstandard vehicle" means a vehicle, on or by which a person may be
5 transported, that:

6 (i) is propelled by its own power, using an internal combustion engine or an electric motor;

7 (ii) has a wheelbase of less than 40 inches and a wheel diameter of less than 10 inches; and

8 (iii) does not display a manufacturer's certification in accordance with 49 CFR, part 567, or have a
9 17-character vehicle identification number assigned by the manufacturer in accordance with 49 CFR, part 565.

10 (b) The term includes but is not limited to a motorized skateboard and a vehicle commonly known
11 as a "pocket rocket".

12 (c) The term does not include a moped as defined in 61-8-102, an electric personal assistive
13 mobility device, or a motorized wheelchair or other low-powered, mechanically propelled vehicle designed
14 specifically for use by a physically disabled person.

15 (48) "New motor vehicle" means a motor vehicle, regardless of the mileage of the vehicle, the legal
16 or equitable title to which has never been transferred by a manufacturer, distributor, or dealer to another person
17 as the result of a retail sale.

18 (49) "Nonresident" means a person who is not a Montana resident.

19 (50) (a) "Not used for general transportation purposes" means the operation of a motor vehicle
20 registered as a collector's item, a custom vehicle, a street rod, or a custom-built motorcycle to or from a car or
21 motorcycle club activity or event or an exhibit, show, cruise night, or parade, or for other occasional
22 transportation activity.

23 (b) The term does not include operation of a motor vehicle for routine or ordinary household
24 maintenance, employment, education, or other similar purposes.

25 (51) (a) "Off-highway vehicle" means a self-propelled vehicle designed for recreation or cross-
26 country travel on public lands, trails, easements, lakes, rivers, or streams. The term includes but is not limited to
27 motorcycles, quadricycles, dune buggies, amphibious vehicles, air cushion vehicles, and any other means of
28 land transportation deriving motive power from any source other than muscle or wind.
