13	NEW SECTION. Section 1. Veterans townhall meetings. (1) Prior to December 31, 2024, the board
14	of veterans' affairs shall hold-six five townhall meetings to:
15	(a) provide a forum for veterans and their families to learn about the services and resources
16	available in their own communities; and
17	(b) educate the board of veterans' affairs on issues that are important to veterans and their families
18	across the state.
19	(2) The six five townhall meetings shall be divided equally in the following three areas: must be
20	held in the five geographic regions referenced in 2-15-1205(2)(b)(i). There must be one meeting in each region.
21	(a) Billings and east of Billings;
22	(b) Great Falls and the high line; and
23	(c) the Rocky Mountains.
24	(3) The townhall meetings may be held in conjunction with a regular meeting of the board of
25	veterans' affairs as long as the board allots sufficient time for public comment and participation.
26	(4) The townhall meetings must be held in free or low-cost venues, with preference given to halls
27	of the American legion and the veterans of foreign wars.
