11 DEFINING TERMS; PROVIDING RULEMAKING AUTHORITY; AMENDING SECTIONS 61-8-1001, 61-8-1002,  
12 61-8-1016, AND 61-8-1018, MCA; AND PROVIDING AN EFFECTIVE DATE AND A TERMINATION DATE."

16 NEW SECTION. Section 1. Definitions. As used in [sections 1 ~~through 7 and 2~~], the following  
17 definitions apply:

18 ~~(1) "Automated driving system" means, unless the context clearly indicates otherwise, the~~  
19 ~~hardware and software that are collectively capable of performing the entire dynamic driving task on a~~  
20 ~~sustained basis, regardless of whether the automated driving system is limited to a specific operational design~~  
21 ~~domain.~~

22 ~~(2) "Developer or manufacturer" means any entity in the chain of manufacture of a vehicle with an~~  
23 ~~automated driving system, including entities in the chain of manufacture of the automated driving system.~~

24 ~~(3)(2) (a) "Dynamic driving task" means all of the real-time operational and tactical functions required~~  
25 ~~to operate a motor vehicle in highway traffic, including:~~

26 ~~(i) lateral vehicle motion control through steering;~~

27 ~~(ii) longitudinal motion control through acceleration and deceleration;~~

14 ~~(6)(5) — "Level 1 automated driving system" means a system that provides to a driver one of the~~  
15 ~~following:~~

16 ~~(a) — braking and accelerating support; or~~

17 ~~(b) — steering support.~~

18 ~~(7)(6) — "Level 2 automated driving system" means a system that provides to a driver both of the~~  
19 ~~following:~~

21 ~~(b) — steering support.~~

22 ~~(8)(7) — "Level 3 automated driving system" means an automated driving system feature that:~~

23 ~~(a) — has the capability to perform on a sustained basis the entire dynamic driving task within its~~

25 ~~(b) — requires a fallback-ready user to operate the vehicle after receiving a request to intervene or in~~  
26 ~~response to a system failure.~~

27 ~~(9)(8) — "Level 4 automated driving system" means an automated driving system feature that, without~~

1 ~~any expectation a human user will respond to a request to intervene, has the capability to perform:~~

2 ~~(a) — on a sustained basis the entire dynamic driving task within its operational design domain; and~~

3 ~~(b) — any maneuvers necessary to achieve a minimal risk condition in response to:~~

4 ~~(i) — an exit from the operational design domain of the automated driving system; or~~

5 ~~(ii) — a system failure.~~

6 ~~(10)(9) "Level 5 automated driving system" means an automated driving system feature that, without~~

7 ~~any expectation a human user will respond to a request to intervene, has the capability to perform:~~

8 ~~(a) — on a sustained basis the entire dynamic driving task under all conditions that can reasonably~~

9 ~~be managed by a human driver; and~~

10 ~~(b) — any maneuvers necessary to respond to a system failure.~~

11 ~~(11)(10) "Minimal risk condition" means a condition to which a user or an automated driving system~~

12 ~~brings a motor vehicle to reduce the risk of a crash when a trip cannot or should not be completed.~~

13 ~~(12)(11) "Object and event detection" and "object and event response" mean the subtasks of the~~

14 ~~dynamic driving tasks that include:~~

15 ~~(a) — monitoring the driving environment; and~~

16 ~~(b) — executing an appropriate response to perform the dynamic driving task.~~

17 ~~(13)(12) "Operate" means the activities performed in order to perform the entire dynamic driving task for~~

18 ~~a motor vehicle, including testing of an automated driving system, by:~~

19 ~~(a) — a human driver; or~~

20 ~~(b) — an engaged automated driving system.~~

21 ~~(14)(13) "Operational design domain" means the operating conditions under which an automated driving~~

22 ~~system or a feature of an automated driving system is specifically designed to function, including:~~

23 ~~(a) — speed range, environmental, geographical, and time-of-day restrictions; or~~

24 ~~(b) — the requisite presence or absence of certain traffic or roadway characteristics.~~

4 **NEW SECTION. Section 4. — Presumption s of liability -- level 3 system.** (1) There is a rebuttable  
5 presumption that the developer or manufacturer of a vehicle using a level 3 automated driving system is liable  
6 for damages to persons or property caused by the operation of the vehicle and for penalties associated with  
7 traffic regulations violated by the operation of the vehicle:

8 (a) — prior to a request to intervene or a system failure; or

9 (b) — resulting immediately from a system failure.

10 (2) — There is a rebuttable presumption that the human driver or fallback ready user of a vehicle  
11 using a level 3 automated driving system is liable for physical harm caused by the vehicle after:

12 (a) — a request to intervene; or

13 (b) — failing to respond timely to a system failure.

14  
15 **NEW SECTION. Section 5. — Presumption of liability -- level 4 and level 5 systems.** There is a  
16 rebuttable presumption that the developer or manufacturer of a vehicle using a level 4 or level 5 automated  
17 driving system is liable for damages to persons or property caused by the operation of the vehicle and for  
18 penalties associated with traffic regulations violated by the operation of the vehicle.

19  
20 **NEW SECTION. Section 2. — Level 4 and level 5 automated driving systems prohibited except as**  
21 **regulated -- rulemaking authority. (1) LEVEL 1, LEVEL 2, AND LEVEL 3 AUTOMATED DRIVING SYSTEMS MAY BE USED**  
22 **ON PUBLIC HIGHWAYS OF THIS STATE.**

23 (1)(2) Level 4 and level 5 automated driving systems may not be used on public highways of this state,  
24 except as provided BUT MUST BE REGULATED by department of transportation rulemaking.

16           **"61-8-1001. Definitions.** As used in this part, unless the context requires otherwise and unless a  
17 different meaning plainly is required, the following definitions apply:

18           (1) "Aggravated driving under the influence" means a person is in violation of 61-8-1002(1)(a),  
19 (1)(b), (1)(c), or (1)(d) and:

20           (a) the person's alcohol concentration, as shown by analysis of the person's blood, breath, or other  
21 bodily substance, is 0.16 or more;

22           (b) the person is under the order of a court or the department to equip any motor vehicle the  
23 person operates with an approved ignition interlock device;

24           (c) the person's driver's license or privilege to drive is suspended, cancelled, or revoked as a result  
25 of a prior violation of driving under the influence, including a violation of 61-8-1002(1)(a), (1)(b), (1)(c), or (1)(d),  
26 an offense that meets the definition of aggravated driving under the influence, or a similar offense under  
27 previous laws of this state or the laws of another state; or

8 (4) "Bus" means a motor vehicle with a manufacturer's rated seating capacity of 11 or more

15           (a) a vehicle or a commercial motor vehicle upon the ways of this state open to the public while  
16 under the influence of alcohol, any drug, or a combination of alcohol and any drug;

17           (b) a noncommercial vehicle upon the ways of this state open to the public while the person's  
18 alcohol concentration, as shown by analysis of the person's blood, breath, or other bodily substance, is 0.08 or  
19 more;

20           (c) a commercial motor vehicle within this state while the person's alcohol concentration, as shown  
21 by analysis of the person's blood, breath, or other bodily substance, is 0.04 or more;

22           (d) a noncommercial vehicle or commercial motor vehicle within this state while the person's delta-  
23 9-tetrahydrocannabinol level, excluding inactive metabolites, as shown by analysis of the person's blood or  
24 other bodily substance, is 5 ng/ml or more; or

25           (e) a vehicle within this state when the person is under 21 years of age at the time of the offense  
26 while the person's alcohol concentration, as shown by analysis of the person's blood, breath, or other bodily  
27 substance, is 0.02 or more.

1           (2)     Upon the trial of any civil or criminal action or proceeding arising out of acts alleged to have  
2     been committed by any person driving, conducting, or in actual physical control of a vehicle while under the  
3     influence of alcohol, the concentration of alcohol in the person at the time of a test, as shown by analysis of a  
4     sample of the person's blood, breath, or other bodily substance drawn or taken within a reasonable time after  
5     the alleged act, gives rise to the following inferences:

6           (a)     if there was at that time an alcohol concentration of 0.04 or less, it may be inferred that the  
7     person was not under the influence of alcohol;

8           (b)     if there was at that time an alcohol concentration in excess of 0.04 but less than 0.08, that fact  
9     may not give rise to any inference that the person was or was not under the influence of alcohol, but the fact  
10    may be considered with other competent evidence in determining the guilt or innocence of the person; and

11          (c)     if there was at that time an alcohol concentration of 0.08 or more, it may be inferred that the  
12    person was under the influence of alcohol. The inference is rebuttable.

13          (3)     The provisions of subsection (2) do not limit the introduction of any other competent evidence  
14    bearing on the issue of whether the person was under the influence of alcohol, drugs, or a combination of  
15    alcohol and drugs.

16          (4)     Each municipality in this state is given authority to enact this section, with the word "state"  
17    changed to read "municipality", as an ordinance and is given jurisdiction of the enforcement of the ordinance  
18    and the imposition of the fines and penalties provided in the ordinance.

19          (5)     Absolute liability, as provided in 45-2-104, is imposed for a violation of this section.

20          (6)     When the same acts may establish the commission of an offense under subsection (1), a  
21    person charged with the conduct may be prosecuted for a violation of another relevant subsection under  
22    subsection (1). However, the person may be convicted of only one offense under this section or of a similar  
23    offense under previous laws of this state."

2 have given consent to a test or tests of the person's blood or breath for the purpose of determining any  
3 measured amount or detected presence of alcohol or drugs in the person's body.

4 (b) The tests in subsection (1)(a) include but are not limited to a preliminary alcohol screening test  
5 of the person's breath for the purpose of estimating the person's alcohol concentration.

6 (c) A preliminary alcohol screening test may not be conducted or requested under this section  
7 unless both the peace officer and the instrument used to conduct the test have been certified by the department  
8 pursuant to rules adopted under the authority of 61-8-1019(5).

9 (d) The person's obligation to submit to a test in subsection (1)(a) is not satisfied by the person  
10 submitting to a preliminary alcohol screening test pursuant to this section.

11 (2) (a) The test or tests must be administered at the direction of a peace officer when:

12 (i) the peace officer has particularized suspicion to believe that the person has been driving,  
13 conducting, or has been in actual physical control of a vehicle upon ways of this state open to the public while  
14 under the influence of alcohol, drugs, or a combination of the two and the person has been detained for a  
15 violation of driving under the influence as provided in 61-8-1002 or an offense that meets the definition of  
16 aggravated driving under the influence in 61-8-1001;

17 (ii) the person is under the age of 21 and the peace officer has particularized suspicion to believe
