11	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

13	Section 1. Section 37-51-602, MCA, is amended to read:		
14	"37-51-602. Exemptions from requirement of property manager license. (1) The In addition to the		
15	exemptions in 37-51-103, the property manager licensing provisions of this chapter do not apply to:		
16	(a) an owner of a business entity that owns the property;		
17	(b) an owner of a business entity that manages property for an owner that is exempt under		
18	subsection (1)(a). However, all owners of the business entity that owns the property and all owners of the		
19	business entity that manages the property must be relatives as provided in subsection (1)(d). For purposes of		
20	subsections (1)(a) and (1)(b), an owner is a person who is a:		
21	(i) sole proprietor;		
22	(ii) managing member of a limited liability company;		
23	(iii) shareholder of a corporation; or		
24	(iv) partner in a partnership.		
25	(c) An-an owner of the real estate, owners who are relatives as provided in subsection (1)(b)(1)(d),		
26	or to business entities or partnerships owned by the owners of the real estate who are relatives as provided in		
27	subsection (1)(b)(1)(d);		
28	(a)(b)(d) a relative of the owner of the real estate, defined as follows:

14	meant to exclude a single or irregular transaction and may not be routinely used to escape the necessity of		
15	obtaining a license.		
16	<u>(d)(e)</u> ()	an attorney at law in the performance of duties as an attorney;	
17	(e)(f)(h) a receiver, trustee in bankruptcy, personal representative, person acting in regard to real estate		
18	pursuant to a court order, or a trustee under a trust agreement, deed of trust, or will;		
19	(f)<u>(g)</u>(i)	an officer of the state or any of its political subdivisions in the conduct of official duties;	
20	(g) a	person acting as a manager of a housing complex for low-income individuals subsidized either	
21	directly or indirectly by the state, any agency or political subdivision of the state, or the government or an		
22	agency of the United States;		
23	(h) <u>(j)</u>	a person who receives compensation from the owner of the real estate in the form of reduced	
24	rent or salary, unless that person holds signatory authority on the account in which revenue from the real estate		
25	is deposited or disbursed;		
26	(i)(k)	a person employed by the owner of the real estate if that person's property management duties	
27	are incidental to the person's other employment-related duties; or

a person employed on a salaried basis by only one person.
