17	unlawful discriminatory practice pursuant to 49-2-307(2), IF THE BEHAVIOR DOES NOT RISE TO THE DEFINITION OF
18	BULLYING AS PROVIDED IN 20-5-208.

20	Section 2. Section 49-2-307, MCA, is amended to read:
21	"49-2-307. Discrimination in education. (1) It is an unlawful discriminatory practice for an
22	educational institution:
23	(1)(a) to exclude, expel, limit, or otherwise discriminate against an individual seeking admission as a
24	student or an individual enrolled as a student in the terms, conditions, or privileges of the institution because of
25	race, creed, religion, sex, marital status, color, age, physical disability, or national origin or because of mental
26	disability, unless based on reasonable grounds;
27	(2)(b) to make or use a written or oral inquiry or form of application for admission that elicits or
28	attempts to elicit information or to make or keep a record concerning the race, color, sex, marital status, age,
