18	with administrative rules adopted by the department of public health and human services, prophylactic eye		
19	agents to newborn infants. These drugs may be administered only if prescribed by a physician.		
20	(2) A licensed direct-entry midwife who has successfully completed accredited courses in		
21	pharmacology and intravenous therapy may, during the practice of midwifery, directly obtain and administer the		
22	following:		
23	(a) oxygen;		
24	(b) postpartum antihemorrhagic agents, including:		
25	(i) pitocin (intramuscular);		
26	(ii) methylergonovine;
