12	WHEREAS, the State is concerned that the positive attributes of the relationship could be significantly
13	harmed if either the State or the Tribe decide to withdraw from their agreement; and
14	WHEREAS, although the State does not believe it has an obligation to fund law enforcement services
15	in Lake County, it wishes to preserve the status quo between the effective date and the end of the biennium to
16	determine whether the Tribe and Lake County wish to continue the relationship with their collective resources,
17	but in the absence of ongoing appropriations in future bienniums from the State; and
18	WHEREAS, to preserve the status quo, the State is providing an appropriated amount for the biennium
19	to Lake County.
