14	Section 1. Section 13-13-301, MCA, is amended to read:	
15	"13-13	3-301. Challenges. (1) An elector's right to vote may be challenged at any time by any
16	registered elec	ctor by the challenger filling out and signing an affidavit stating the grounds of the challenge and
17	providing any	evidence supporting the challenge to the election administrator or, on election day, to an election
18	judge.	
19	(2)	A challenge may be made on the grounds that the elector:
20	(a)	is of unsound mind, as determined by a court;
21	(b)	has voted before in that election;
22	(c)	has been convicted of a felony and is serving a sentence in a penal institution;
23	(d)	is not registered as required by law;
24	(e)	is not 18 years of age or older;
25	(f)	has not been, for at least 30 days, a resident of the county in which the elector is offering to
26	vote, except as provided in 13-2-514 and 20-20-301(2);	
27	(g)	is a provisionally registered elector whose status has not been changed to a legally registered

The notification 15 must be made: 16 (i) within 5 days of the filing of the challenge if the election is more than 5 days away; or 17 (ii) on or before election day if the election is less than 5 days away. 18 The election administrator or, on election day, the election judge shall also provide to the (c) 19 challenged elector a copy of the challenger's affidavit and any supporting evidence provided. 20 (5) The secretary of state shall adopt rules to implement the provisions of this section and shall 21 provide standardized affidavit forms for challengers and challenged electors." 22 23 Section 2. (1) An-Except as provided in subsection (2), an individual is 25 entitled to vote at school elections if the individual has the qualifications set forth in 13-1-111 and is a resident 26 of the school district or, in a school district that has been apportioned into single-member trustee districts 27 according to 20-3-337, a resident of the trustee district. 28 (2) (a) Subject to subsection (3), an elector, as defined in 13-1-101, individual who is a registered

11	(b) (i) If there are two individuals who own the same real property jointly, only one of the individuals		
12	is entitled to vote under the provisions of subsection (2) in the election.		
13	(ii) If both individuals are registered voters in Montana, the individual whose name appears first on		
14	the title is entitled to vote in the election.		
15	(c) The right to vote under this section is limited to properties without fractional ownership based		
16	<u>on time.</u>		
17	(c)(d) An individual authorized to vote under subsection (2) may only vote in district bond or levy		
18	elections and is considered a qualified elector only for the purposes of district bond or levy elections."

21	"20-20-311. Voter registration . Voter Except as provided in 20-20-301(2) and (3), voter registration		
22	for school elections must be as provided in Title 13, chapter 2."
