4 A BILL FOR AN ACT ENTITLED: "AN ACT REVISING REQUIREMENTS FOR RECREATIONAL USE ON  
5 LANDS MANAGED BY STATE AGENCIES; EXPANDING THE APPLICABILITY OF CONSERVATION  
6 LICENSES TO INCLUDE ALL GENERAL RECREATION; EXPANDING THE EXISTING AGREEMENT  
7 AUTHORITY BETWEEN THE DEPARTMENT OF FISH, WILDLIFE, AND PARKS AND THE DEPARTMENT  
8 OF NATURAL RESOURCES AND CONSERVATION; REVISING "WILDLIFE CONSERVATION LICENSES"  
9 TO "CONSERVATION LICENSES"; ESTABLISHING REPORTING REQUIREMENTS; REVISING PENALTIES;  
10 PROVIDING AN APPROPRIATION; AMENDING SECTIONS 37-47-303, 37-47-304, 40-5-701, 76-17-102, 77-  
11 1-801, 77-1-802, 77-1-804, 77-1-815, 81-7-123, 87-1-266, 87-1-506, 87-2-106, 87-2-201, 87-2-202, 87-2-204,  
12 87-2-403, 87-2-519, 87-2-525, 87-2-801, 87-2-803, 87-2-805, 87-2-815, 87-2-816, 87-2-817, 87-2-818, 87-6-

15 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

17 **Section 1.** Section 37-47-303, MCA, is amended to read:

18 **"37-47-303. Guide's qualifications.** An applicant for a guide's license must:

- 19 (1) be 18 years of age or older and be physically capable and mentally competent to perform the
- 20 duties of a guide;
- 21 (2) be endorsed and recommended by an outfitter with a valid license, unless otherwise qualified
- 22 under guide standards established by the board pursuant to 37-47-201(4); and
- 23 (3) have been issued a valid ~~wildlife~~-conservation license."

24  
25 **Section 2.** Section 37-47-304, MCA, is amended to read:

26 **"37-47-304. Application.** (1) Each applicant for an outfitter's or guide's license shall apply for a  
27 license on a form furnished by the department.

28 (2) The application for an outfitter's license must include:

- 1 (a) the applicant's full name, address, ~~wildlife~~ conservation license number, and telephone  
2 number;
- 3 (b) the applicant's years of experience as an outfitter or guide; and
- 4 (c) components of the outfitter's operations plan as required by board rule, which may include:
- 5 (i) an affidavit by the outfitter to the board that the amount and kind of equipment that is owned,  
6 leased, or contracted for by the applicant is sufficient and satisfactory for the services advertised or  
7 contemplated to be performed by the applicant; and
- 8 (ii) a description of any land, water body, or portion of a water body that will be utilized by the  
9 applicant while providing services. A description is not required for the use of private lands that allow  
10 unrestricted public access and are managed under cooperative agreements with adjacent public lands.
- 11 (3) An application for an outfitter's license must be in the name of an individual person only. An  
12 application involving a business entity must be made by one individual person who qualifies under the  
13 provisions of this part. A license issued pursuant to this part must be in the name of that person. Any revocation  
14 or suspension of a license is binding upon the individual person and the business entity for the use and benefit  
15 of which the license was originally issued.
- 16 (4) Application must be made to and filed with the board.
- 17 (5) Only one application for an outfitter's license may be made in any license year. If an application  
18 is denied, subsequent applications by the same applicant for the license year involved are void, except as  
19 provided in 37-47-308."

21 **Section 3.** Section 40-5-701, MCA, is amended to read:

22 **"40-5-701. Definitions.** As used in this part, the following definitions apply:

- 23 (1) (a) "Child" means:
- 24 (i) a person under 18 years of age who is not emancipated, self-supporting, married, or a member  
25 of the armed forces of the United States;
- 26 (ii) a person under 19 years of age who is still in high school;
- 27 (iii) a person who is mentally or physically incapacitated when the incapacity began prior to that  
28 person reaching 18 years of age; and

- 1 (iv) in IV-D cases, a person for whom:
- 2 (A) support rights are assigned under 53-2-613;
- 3 (B) a public assistance payment has been made;
- 4 (C) the department is providing support enforcement services under 40-5-203; or
- 5 (D) the department has received a referral for IV-D services under the provisions of the Uniform
- 6 Interstate Family Support Act, the Revised Uniform Reciprocal Enforcement of Support Act, the Uniform
- 7 Reciprocal Enforcement of Support Act, or Title IV-D of the Social Security Act.

8 (b) The term may not be construed to limit the ability of the department to enforce a support order

9 according to its terms when the order provides for support extending beyond the time the child reaches 18

10 years of age.

11 (2) "Conservation activity" means an activity for which a ~~wildlife~~-conservation license is issued by

12 the department of fish, wildlife, and parks pursuant to 87-2-201.

13 (3) "Delinquency" means a support debt or support obligation due under a support order in an

14 amount greater than or equal to 6 months' support payments as of the date of service of a notice of intent to

15 suspend a license.

16 (4) "Department" means the department of public health and human services.

17 (5) "License" means a license, certificate, registration, permit, or any other authorization issued by

18 an agency of the state of Montana granting a person a right or privilege to engage in a business, occupation,

19 profession, conservation activity, or any other privilege that is subject to suspension, revocation, forfeiture,

20 termination, or a declaration of ineligibility to purchase by the licensing authority prior to its date of expiration.

21 (6) "Licensing authority" means any department, division, board, agency, or instrumentality of this

22 state that issues a license.

23 (7) "Obligee" means:

24 (a) a person to whom a support debt or support obligation is owed; or

25 (b) a public agency of this or another state or an Indian tribe that has the right to receive current or

26 accrued support payments or that is providing support enforcement services under this chapter.

27 (8) "Obligor" means a person who owes a duty of support or who is subject to a subpoena or

28 warrant in a paternity or child support proceeding.

1           (9)     "Order suspending a license" means an order issued by a support enforcement entity to  
2 suspend a license. The order must contain the name of the obligor, the type of license, and, if known, the social  
3 security number of the obligor.

4           (10)    "Payment plan" includes but is not limited to a plan approved by the support enforcement entity  
5 that provides sufficient security to ensure compliance with a support order and that incorporates voluntary or  
6 involuntary income withholding under part 3 or 4 of this chapter or a similar plan for periodic payment of a  
7 support debt and, if applicable, current and future support.

8           (11)    "Subpoena" means a writ or order issued by a court or the department in a proceeding or as  
9 part of an investigation related to the paternity or support of a child that commands a person to appear at a  
10 particular place and time to testify or produce documents or things under the person's control.

11          (12)    "Support debt" or "support obligation" means the amount created by the failure to provide or  
12 pay:

13          (a)     support to a child under the laws of this or any other state or under a support order;

14          (b)     court-ordered spousal maintenance or other court-ordered support for the child's custodial  
15 parent;

16          (c)     fines, fees, penalties, interest, and other funds and costs that the support enforcement entity is  
17 authorized to collect by the use of any procedure available to the entity for the payment, enforcement, and  
18 collection of child support or spousal maintenance or support; or

19          (d)     contributions ordered pursuant to 41-5-1525.

20          (13)    "Support enforcement entity" means:

21          (a)     in IV-D cases, the department; or

22          (b)     in all other cases, the district court that entered the support order or a district court in which the  
23 support order is registered.

24          (14)    (a) "Support order" means an order that provides a determinable amount for temporary or final  
25 periodic payment of a support debt or support obligation and that may include payment of a determinable or  
26 indeterminable amount for insurance covering the child issued by:

27          (i)     a district court of this state;

28          (ii)    a court of appropriate jurisdiction of another state, an Indian tribe, or a foreign country;

- 1 (iii) an administrative agency pursuant to proceedings under Title 40, chapter 5, part 2; or
- 2 (iv) an administrative agency of another state or an Indian tribe with a hearing function and process
- 3 similar to those of the department.

4 (b) If an action for child support is commenced under this part and the context so requires, support

5 order also includes:

6 (i) judgments and orders providing periodic payments for the maintenance or support of the child's

7 custodial parent; and

8 (ii) amounts for the recovery of fines, fees, penalties, interest, and other funds and costs that the

9 support enforcement entity is authorized to collect by the use of any procedure available to the entity for the

10 payment, enforcement, and collection of child support or spousal maintenance or support.

11 (15) "Suspension" includes the withdrawal, withholding, revocation, forfeiture, or nonissuance of a

12 license and license privileges.

13 (16) "Warrant" means a bench warrant, a warrant to appear, an order to show cause, or any other

14 order issued by a court relating to the appearance of a party in a paternity or child support proceeding.

15 (17) "IV-D case" means a case in which the department is providing support enforcement services

16 as a result of:

17 (a) an assignment of support rights under 53-2-613;

18 (b) a payment of public assistance;

19 (c) an application for support enforcement services under 40-5-203; or

20 (d) a referral for services from an agency of another state or an Indian tribe under the provisions of

21 the Uniform Reciprocal Enforcement of Support Act, the Revised Uniform Reciprocal Enforcement of Support

22 Act, the Uniform Interstate Family Support Act, or Title IV-D of the Social Security Act."

24 **Section 4.** Section 76-17-102, MCA, is amended to read:

25 **"76-17-102. (Temporary) Montana public land access network grant program -- donations --**

26 **rulemaking.** (1) There is a Montana public land access network grant program. An individual or organization

27 may seek a grant from the program to secure public access through private land to public land, as defined in

28 15-30-2380, for which there is no other legal public access or to enhance existing access to public land.

1 (2) The grant program is funded by private donations. State agencies shall, as appropriate,  
2 facilitate private donations to the Montana public land access network account established in 76-17-103,  
3 including but not limited to the following methods:

4 (a) a donation by a person of \$1 or more above the price of a ~~wildlife~~-conservation license  
5 purchased pursuant to 87-2-202; and

6 (b) a donation by a person, as defined in 2-4-102, through the websites of the department of  
7 natural resources and conservation, the department of fish, wildlife, and parks, and the state of Montana.

8 (3) (a) The department of natural resources and conservation shall adopt a logo for the Montana  
9 public land access network grant program, using the acronym "MT-PLAN". The department of natural resources  
10 and conservation and the department of fish, wildlife, and parks shall use the logo on signs and maps indicating  
11 the locations and access points of public lands made accessible through the grant program.

12 (b) Subject to the limitations provided in 76-17-103(4), either department may be reimbursed from  
13 the Montana public land access network account established in 76-17-103 for reasonable costs, as determined  
14 by the board, that are associated with subsection (3)(a).

15 (4) The department of natural resources and conservation may adopt rules to implement the  
16 provisions of this part. (Terminates June 30, 2027--sec. 10, Ch. 374, L. 2017.)"

18 **Section 5.** Section 77-1-801, MCA, is amended to read:

19 **"77-1-801. (Temporary) Recreational use license required to use state lands for general**

20 **recreational purposes -- penalty -- exemption.** (1) Except as provided in subsection ~~(3)~~ (2), a person 12  
21 years of age or older shall obtain an annual recreational use license pursuant to 77-1-802 to use state lands, as  
22 defined in 77-1-101, for general recreational purposes.

23 ~~(2) Except as provided in subsection (3), a person shall, upon the request of a peace officer or fish~~  
24 ~~and game warden, present for inspection the person's recreational use license.~~

25 ~~(3)~~(2) If the department and the department of fish, wildlife, and parks consent to and sign an  
26 agreement for hunting, fishing, and trapping purposes general recreational use pursuant to, as provided in 77-  
27 1-815, a person is ~~not only~~ required to obtain a recreational use conservation license for general recreational  
28 use of legally accessible state trust land ~~for hunting, fishing, and trapping purposes.~~

1           (3) A person shall, on the request of a peace officer or fish and game warden, present for  
2 inspection the person's conservation license.

3           (4) A ~~violator person found in violation~~ of ~~subsection (1) or (2) this section~~ or department rules  
4 pertaining to the use of state trust land:

5           (a) for a first offense, shall be given a warning;

6           (b) for a second offense, is guilty of a misdemeanor and shall be fined not less than twice the cost  
7 of a conservation license; and

8           (c) for a third offense, is guilty of a misdemeanor and shall be fined not \$50 or more than \$500 or  
9 be imprisoned in the county jail for not more than 6 months, or both. (Void on occurrence of contingency--sec.  
10 8, Ch. 596, L. 2003.)

11           **77-1-801. (Effective on occurrence of contingency) Recreational use license required to use**  
12 **state lands for general recreational purposes -- penalty.** (1) A person 12 years of age or older shall obtain  
13 an annual recreational use license pursuant to 77-1-802 to use state lands, as defined in 77-1-101, for general  
14 recreational purposes.

15           (2) A person shall, upon the request of a peace officer or fish and game warden, present for  
16 inspection the person's recreational use license.

17           (3) A ~~violator person found in violation~~ of subsection (1) or (2) pertaining to the use of state trust  
18 land:

19           (a) for first offense, shall be given a warning;

20           (b) for second offense, is guilty of a misdemeanor and shall be fined not less than twice the cost of  
21 a recreational use license; and

22           (c) for a third offense, is guilty of a misdemeanor and shall be fined not \$50 or more than \$500 or  
23 be imprisoned in the county jail for not more than 6 months, or both."

24

25           **Section 6.** Section 77-1-802, MCA, is amended to read:

26           **"77-1-802. (Temporary) Recreational use -- fee.** (1) The fee for general recreational use on state  
27 trust land must attain full market value whether the license is sold ~~on an individual basis or on a group basis~~  
28 ~~through pursuant to 77-1-801 or under~~ an agreement with the department of fish, wildlife, and parks as provided

1 in 77-1-815.

2 (2) Money received by the department ~~from the sale of recreational use licenses for general~~  
3 recreational use of state lands must be credited as follows:

4 (a) Except as provided in subsection (2)(b), ~~license~~ fees must be apportioned on a pro rata basis  
5 to the land trusts, in proportion to the respective trust's percentage of acreage in the total acreage of all state  
6 land trusts.

7 (b) Revenue from recreational use license fees, less 50 cents from the fee for each license that  
8 must be returned to the license dealer as a commission, is distributable revenue and must be deposited  
9 pursuant to 77-1-109 and used to pay for administrative costs as provided in 77-1-108.

10 (3) The department may contract with the department of fish, wildlife, and parks for the distribution  
11 and sale of recreational use licenses through the license agents appointed by and the administrative offices of  
12 the department of fish, wildlife, and parks and in accordance with the provisions of Title 87, chapter 2, part 9.  
13 (Void on occurrence of contingency--sec. 8, Ch. 596, L. 2003.)

14 **77-1-802. (Effective on occurrence of contingency) Recreational use license -- fee.** (1) The fee  
15 for a recreational use license must attain full market value.

16 (2) Money received by the department ~~from the sale of recreational use licenses for general~~  
17 recreational use of state lands must be credited as follows:

18 (a) Except as provided in subsection (2)(b), ~~license~~ fees must be apportioned on a pro rata basis  
19 to the land trusts, in proportion to the respective trust's percentage contribution to the total acreage of all state  
20 land trusts.

21 (b) Revenue from recreational use license fees, less 50 cents from the fee for each license that  
22 must be returned to the license dealer as a commission, is distributable revenue and must be deposited  
23 pursuant to 77-1-109 and used to pay for administrative costs as provided in 77-1-108.

24 (3) The department may contract with the department of fish, wildlife, and parks for the distribution  
25 and sale of recreational use licenses through the license agents appointed by and the administrative offices of  
26 the department of fish, wildlife, and parks and in accordance with the provisions of Title 87, chapter 2, part 9."

**Section 7.** Section 77-1-804, MCA, is amended to read:



1           **"77-1-804. Rules for recreational use of state lands -- penalty.** (1) The board shall adopt rules  
2 authorizing and governing the recreational use of state lands allowed under 77-1-203. The board shall use local  
3 offices of the department to administer this program whenever practical.

4           (2) Rules adopted under this section must address the circumstances under which the board may  
5 close legally accessible state lands to recreational use. Action by the board may be taken upon its own initiative  
6 or upon petition by an individual, organization, corporation, or governmental agency. Closures may be of an  
7 emergency, seasonal, temporary, or permanent nature. State lands may be closed by the board only after  
8 public notice and opportunity for public hearing in the area of the proposed closure, except when the  
9 department is acting under rules adopted by the board for an emergency closure. Closed lands must be posted  
10 by the lessee or by the department at the request of the lessee at customary access points, with signs provided  
11 or authorized by the department.

12           (3) Closure rules adopted pursuant to subsection (2) may categorically close state lands whose  
13 use or status is incompatible with recreational use. Categorical or blanket closures may be imposed on state  
14 lands due to:

- 15           (a) cabin site and home site leases and licenses;
- 16           (b) the seasonal presence of growing crops; and
- 17           (c) active military, commercial, or mineral leases.

18           (4) The board shall adopt rules that provide an opportunity for any individual, organization, or  
19 governmental agency to petition the board for purposes of excluding a specified portion of state land from a  
20 categorical closure that has been imposed under subsection (3).

21           (5) Under rules adopted by the board, state lands may be closed on a case-by-case basis for  
22 certain reasons, including but not limited to:

- 23           (a) damage attributable to recreational use that diminishes the income-generating potential of the  
24 state lands;
- 25           (b) damage to surface improvements of the lessee;
- 26           (c) the presence of threatened, endangered, or sensitive species or plant communities;
- 27           (d) the presence of unique or special natural or cultural features;
- 28           (e) wildlife protection;

- 1 (f) noxious weed control; or
- 2 (g) the presence of buildings, structures, and facilities.
- 3 (6) (a) Rules adopted under this section may impose restrictions on general recreational activities,
- 4 including the discharge of weapons, camping, open fires, vehicle use, and any use that will interfere with the
- 5 presence of livestock.
- 6 (b) The board may also by rule restrict access on state lands in accordance with a block
- 7 management program administered by the department of fish, wildlife, and parks.
- 8 (c) Motorized vehicle use by recreationists on state lands is restricted to federal, state, and
- 9 dedicated county roads, trails developed by the department for motorized use, and roads designated by the
- 10 department to be open to motorized vehicle use.
- 11 (d) Recreational overnight use of state lands in a 30-day period is limited to 16 days:
- 12 (i) in a designated campground; and
- 13 (ii) on unleased, unlicensed lands outside a campground unless otherwise allowed by the
- 14 department.
- 15 (e) Pets on state lands must be on a leash or otherwise controlled to prevent harassment of
- 16 livestock or wildlife.
- 17 (f) Horses may be kept overnight on state lands if:
- 18 (i) the horses do not remain in a stream riparian zone for more than 1 hour; and
- 19 (ii) only feed certified as noxious weed seed free is present on state lands.
- 20 (g) A horse kept overnight on state lands where there is a lease or license must be kept in
- 21 compliance with the provisions of subsection (6)(f) and must be restrained.
- 22 (h) Restrictions on general recreational activities must comply with the following:
- 23 (i) at least 30 days prior to a restriction, except in the case of emergency, the lessee or the
- 24 department if requested by the lessee shall:
- 25 (A) post notice of the proposed restriction at frequent access points to the land where the
- 26 restriction is proposed; and
- 27 (B) issue a press release or a public service announcement detailing the proposed restriction;
- 28 (ii) except for seasonal restrictions and unless required for public safety, a restriction in an area

1 may not exceed 1 year; and

2 (iii) if a misuse of the land, including littering, may lead to a restriction, common access points must  
3 be posted with notice of the possible restriction for 30 days with information detailing the misuse of land and  
4 stating the penalties for the violation. If the misuse persists at the end of 30 days, a proposed restriction notice  
5 may be posted in accordance with subsection (6)(h)(i).

6 (7) The board shall adopt rules providing for the issuance of a recreational special use license.  
7 Commercial or concentrated recreational use, as defined in 77-1-101, is prohibited on state lands unless it  
8 occurs under the provisions of a recreational special use license. The board may also adopt rules requiring a  
9 recreational special use license for recreational use that is not commercial, concentrated, or within the definition  
10 of general recreational use.

11 (8) (a) For a violation of rules adopted by the board pursuant to this section, the department may  
12 assess a civil penalty of up to \$1,000 for each day of violation. The board shall adopt rules providing for notice  
13 and opportunity for hearing in accordance with Title 2, chapter 4, part 6.

14 (b) If the department and the department of fish, wildlife, and parks consent to and sign an  
15 agreement for general recreational use as provided in 77-1-815, a person who violates a department rule that  
16 governs general recreational use is guilty of a misdemeanor and shall be fined not less than \$50 or more than  
17 \$500. In addition, the person, upon conviction or forfeiture of bond or bail, may be subject to forfeiture of any  
18 current hunting, fishing, or trapping license issued by this state and the privilege to hunt, fish, or trap in this  
19 state or to use state lands, as defined in 77-1-101, for recreational purposes for a period of time set by the  
20 court.

21 (c) Civil penaltiesPenalties collected under this subsection (8) must be deposited as provided in  
22 87-1-601(8).

23 (9) Unauthorized dumping of refuse on state lands and destruction of property, which includes land  
24 and improvements, are misdemeanor crimes punishable by a fine of not more than \$1,500."

25

26 **Section 8.** Section 77-1-815, MCA, is amended to read:

27 **"77-1-815. (Temporary) Recreational use agreement for hunting, fishing, and trapping**

28 **Agreement for general recreational use on legally accessible state trust land.** (1) The board is authorized

1 to enter into an agreement with the department of fish, wildlife, and parks to compensate state trust land  
2 beneficiaries for the use and impacts associated with ~~hunting, fishing, and trapping~~ general recreational uses as  
3 defined in 77-1-101 on legally accessible state trust land as defined in ~~department rule~~ 77-1-101. The  
4 department may impose restrictions it considers necessary to coordinate the uses of state trust land or to  
5 preserve the purposes of the various trust lands. ~~Hunting, fishing, and trapping~~ General recreational uses as  
6 defined in 77-1-101 on state trust land must be conducted in accordance with rules and provisions provided in  
7 this part.

8 (2) An agreement may be ~~issued to~~ entered into with the department of fish, wildlife, and parks for  
9 a term of up to 10 years. Through this agreement, the board shall recover for the beneficiaries of the trust the  
10 full market value for the use and impacts associated with ~~hunting, fishing, and trapping on legally accessible~~  
11 ~~state trust land~~ general recreational use on trust land, as defined in 77-1-101. The department may use funds  
12 appropriated from the trust land administration account provided for in 77-1-108 to implement and manage the  
13 agreement. Except as provided for in 17-7-304, any unexpended amount in the account that resulted from  
14 recreational use fees must be apportioned on a pro rata basis to the land trusts, in proportion to the respective  
15 trust's percentage of acreage in the total acreage of all state land trusts.

16 (3) Any agreement entered into is subject to the following conditions:

17 (a) The department maintains sole discretion, throughout the term of the agreement, with regard to  
18 identifying legally accessible parcels, coordinating uses on state trust land, and making any other necessary  
19 state trust land management decisions.

20 (b) An agreement between the department and the department of fish, wildlife, and parks may not  
21 convey any additional authority to the department of fish, wildlife, and parks.

22 ~~(4) During any period that the department of fish, wildlife, and parks and the department have~~  
23 ~~reached an agreement as provided in subsection (1), an individual recreational use license under 77-1-801 or~~  
24 ~~77-1-802 may not be required for a member of the public to hunt, fish, or trap upon legally accessible state trust~~  
25 ~~land. (Void on occurrence of contingency--sec. 8, Ch. 596, L. 2003.)"~~

26

27 **Section 9.** Section 81-7-123, MCA, is amended to read:

28 **"81-7-123. Voluntary wolf mitigation account.** (1) There is a voluntary wolf mitigation account in the

1 state special revenue fund established in 17-2-102. The account is statutorily appropriated, as provided in 17-7-  
2 502, and must be used pursuant to subsection (3) of this section.

3 (2) The voluntary wolf mitigation account is funded by private donations. State agencies shall, as  
4 appropriate, facilitate private donations to the account, including but not limited to the following methods:

7 (f) a Class A-5 elk tag;

8 (g) a Class AAA combination sports license that does not include a Class A-6 black bear tag. This

9 subsection (2)(g) does not prohibit a resident minor from purchasing any individual licenses for which the minor

10 may be eligible under this chapter if the minor does not purchase a Class AAA license under this subsection

11 (2)(g). A resident minor who lawfully purchases a Class AAA license pursuant to this subsection (2)(g) at 17

12 years of age, but who reaches 18 years of age during that license year, may legally use the license during that

13 license year.

14 (3) A nonresident minor who is 12 years of age or older and under 18 years of age may purchase

15 an upland game bird license and a migratory game bird license for one-half of the nonresident fee. Of the fee

5 (d) The department may limit the number of licenses issued pursuant to this subsection (4) to a  
6 total of 25 annually.

7 (5) Prior to reaching 12 years of age, a minor who will reach 12 years of age by January 16 of a  
8 license year may hunt any game species after August 15 of that license year as long as the minor obtains the  
9 necessary license pursuant to this chapter."

12 **"87-2-815. Donation of hunting licenses to disabled veterans or disabled members of the**  
13 **armed forces.** (1) The holder of any hunting license issued by the department may surrender that license and  
14 any related permit to the department for reissuance to a disabled veteran or a disabled member of the armed  
15 forces for use on an expedition arranged by a nonprofit organization that is exempt from taxation under 26  
16 U.S.C. 501(c)(3) and that uses hunting as part of the rehabilitation of disabled veterans and disabled members  
17 of the armed forces. The person surrendering the license:

18 (a) is not eligible for a refund for the cost of the surrendered license;

19 (b) may not designate to which organization, disabled veteran, or disabled member of the armed

19 (2) A resident, as defined in 87-2-102, awarded a purple heart for service in the armed forces of  
20 the United States is entitled to fish and hunt game birds, not including wild turkeys, with the purchase of a  
21 ~~wildlife~~-conservation license pursuant to 87-2-202 and a resident aquatic invasive species prevention pass  
22 pursuant to 87-2-130.

23 (3) A nonresident awarded a purple heart for service in the armed forces of the United States is  
24 entitled to fish and hunt game birds, not including wild turkeys, with the purchase of a ~~wildlife~~-conservation  
25 license pursuant to 87-2-202 and a nonresident aquatic invasive species prevention pass pursuant to 87-2-130  
26 during expeditions arranged for the nonresident by a nonprofit organization that uses fishing and hunting as  
27 part of the rehabilitation of disabled veterans.

28 (4) The department's general license account must be reimbursed by a quarterly transfer of funds

1 from the general fund to the general license account for license costs associated with the fishing and game bird  
2 hunting privileges granted pursuant to subsections (2) and (3) during the preceding calendar quarter.  
3 Reimbursement costs must be designated as license revenue."

5 **Section 24.** Section 87-2-817, MCA, is amended to read:

6 **"87-2-817. Licenses for service members.** (1) A veteran or a disabled member of the armed forces  
7 who meets the qualifications in 87-2-803(9) as a result of a combat-connected injury may apply at a fish,  
8 wildlife, and parks office for a regular Class A-3 deer A tag, a Class A-4 deer B tag, a Class B-7 deer A tag, a  
9 Class B-8 deer B tag, and a special antelope license made available under 87-2-506(3) for one-half of the  
10 license fee. Licenses issued to veterans or disabled members of the armed forces under this part do not count  
11 against the number of special antelope licenses reserved for people with permanent disabilities, as provided in

12 (3) A member of the armed forces who forfeited a license or permit issued through a drawing as a  
13 result of deployment outside of the continental United States in support of a contingency operation as provided  
14 in 10 U.S.C. 101(a)(13) is guaranteed the same license or permit, without additional fee, upon application in the  
15 year of the member's return from deployment or in the first year that the license or permit is made available  
16 after the member's return."

19 **"87-2-818. Law enforcement officers and firefighters critically injured in line of duty.** A law  
20 enforcement officer, as defined in 7-32-201, a firefighter, or a volunteer firefighter who was critically injured in  
21 the line of duty and is permanently unable to return to work because of the injury is entitled to fish with a wildlife  
22 conservation license issued by the department during expeditions arranged for the person by a nonprofit  
23 organization that uses fishing as part of the rehabilitation of injured or disabled persons."

26 **"87-6-302. Unlawful procurement of license, permit, or tag.** (1) A person may not:

18 court imposes a longer period. For each subsequent violation, the person shall forfeit any current hunting,  
19 fishing, or trapping license issued by this state and the privilege to hunt, fish, or trap in this state for the same  
20 period of time imposed by the court for the person's previous violation plus an additional 24 months."

22 **Section 27.** Section 87-6-303, MCA, is amended to read:

23 **"87-6-303. Nonresident license or permit offenses.** (1) A person who is not a resident may not:

24 (a) apply for or purchase for a nonresident's use the following resident licenses and permits:

25 (i) ~~wildlife~~ conservation license;

26 (ii) hunting license or permit; or

27 (iii) fishing license or permit;

28 (b) affirm to or make a false statement to obtain a resident license.

2     or twice the cost of the nonresident license that authorized the sought-after privilege or more than \$1,000 or be  
3     imprisoned in the county jail for not more than 6 months, or both. In addition, the person, upon conviction or  
4     forfeiture of bond or bail, shall forfeit any current hunting, fishing, or trapping license issued by this state and the  
5     privilege to hunt, fish, or trap in this state for not less than 18 months."

7           **NEW SECTION. Section 28. Appropriation.** (1) For the biennium beginning July 1, 2023, in each  
8     fiscal year there is appropriated \$670,000 from the state special revenue fund established in 87-1-601 to the  
9     department of fish, wildlife, and parks.

10          (2)     The legislature intends for the appropriation provided for in subsection (1) be considered part of  
11     the ongoing base for the next legislative sessions.
