15	shall submit a written report in accordance with 5-11-210 the information required by this section for the prior		
16	quarter to the legislative finance committee. The executive branch agencies subject to this section include		
17	THE AGENCIES HEADED BY OFFICERS LISTED IN ARTICLE VI, SECTION 1, OF THE MONTANA CONSTITUTION AND THE		
18	DEPARTMENTS CREATED PURSUANT TO ARTICLE VI, SECTION 7, OF THE MONTANA CONSTITUTION.

20	(a) the number of requests for information submitted to each entity in the preceding quarter;
