3	(8)(9) The department may adopt rules necessary for the administration of medicaid managed care
4	systems. Rules to be adopted may include but are not limited to rules concerning:
5	(a) participation in managed care;
6	(b) selection and qualifications for providers of managed care; and
7	(c) standards for the provision of managed care.
8	(9)(10) Subject to subsection (6), the department shall establish by rule income limits for eligibility for
9	extended medical assistance of persons receiving section 1931 medicaid benefits, as defined in 53-4-602, who
10	lose eligibility because of increased income to the assistance unit, as that term is defined in the rules of the
11	department, as provided in 53-6-134, and shall also establish by rule the length of time for which extended
12	medical assistance will be provided. The department, in exercising its discretion to set income limits and
13	duration of assistance, may consider the amount of funds appropriated by the legislature.
14	(10)(11) Unless required by federal law or regulation, the department may not adopt rules that exclude
15	a child from medicaid services or require prior authorization for a child to access medicaid services if the child
16	would be eligible for or able to access the services without prior authorization if the child was not in foster care."
