5 A BILL FOR AN ACT ENTITLED: "AN ACT GENERALLY REVISING THE REQUIREMENTS FOR CREATION
6 OF A NEW HIGH SCHOOL DISTRICT; AUTHORIZING MULTIPLE ADJACENT ELEMENTARY DISTRICTS
7 WITH AT LEAST 1,000 COMBINED ANB TO CONTRACT FOR THE FORMATION OF A NEW HIGH SCHOOL
8 DISTRICT ON APPROVAL OF THE ELECTORS OF EACH OF THE ELEMENTARY DISTRICTS; PROVIDING
9 FOR THE PASSAGE OF A BOND TO BUILD OR OUTFIT A HIGH SCHOOL BUILDING; PROVIDING
10 PROCEDURES TO ESTABLISH A BUDGET AND PROVIDE THE FUNDING OF THE NEW HIGH SCHOOL
11 DISTRICT; DELAYING THE CONSTRUCTION OF APPROVED HIGH SCHOOL FACILITIES UNTIL JULY 1,
12 2025; REQUIRING THE FORMER HIGH SCHOOL DISTRICT TO PROVIDE INSTRUCTION FOR A
13 TRANSITION PERIOD; CLARIFYING RESPONSIBILITIES AND REQUIREMENTS THROUGH THE
14 PROCESS OF ESTABLISHING A NEW HIGH SCHOOL DISTRICT; AMENDING SECTIONS 20-6-104, 20-9-
15 366, 20-9-439, AND 20-9-502, MCA; AND PROVIDING AN IMMEDIATE EFFECTIVE DATE."

17 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

19 NEW SECTION. **Section 1. Procedure for two or more elementary school districts to create new**
20 **high school district -- trustee resolution.** (1) Two or more existing elementary districts that are adjacent to
21 each other and that are not part of a unified school system or governed by a joint board with a high school
22 district may contract to create a new high school district under the procedures outlined in [section 2] and this
23 section only if the combined total of the ANB in the elementary districts, as calculated under the provisions of
24 20-9-311, is at least 1,000.

25 (2) The creation of a new high school district may be requested by the trustees of each existing
26 elementary district through passage of a resolution that includes the information outlined in 20-6-105(3) and
27 requests the county superintendent to order an election to allow the electors of each elementary district to

1 consider the proposition of creating a new high school district. The trustees of the existing elementary districts
2 proposing a contract under this section may not pass a resolution for expansion more than one time within a 5-
3 year period.

4 (3) (a) If the proposition for the expansion is approved by the electors of each of the elementary
5 districts and the trustees issue a certificate of election as provided in 20-20-416, for a period of 2 years from the
6 date of the certification of the election the elementary trustees have the authority to propose to the electors of
7 each of the elementary districts:

8 (i) a transition costs levy pursuant to 20-9-502; and

9 (ii) a general obligation bond pursuant to Title 20, chapter 9, part 4, for the purpose of building,
10 altering, repairing, buying, furnishing, equipping, purchasing lands for, or obtaining a water supply for a school
11 to accommodate high school students.

12 (b) The bond limitations pursuant to 20-9-406 imposed on a district proposing a bond under
13 subsection (3)(a) must be calculated on the limits for a high school district with the high school ANB calculated
14 by dividing the ANB of the elementary district by 9 and multiplying the result by 4.

15 (c) The electors of each elementary school district shall vote on the total amount of the general
16 obligation bond required for the purposes of subsection (3)(a). A bond approved under subsection (3)(a)
17 becomes a bond of, and may not be issued until the creation of, the new high school district formed pursuant to
18 subsection (4).

19 (d) A new high school district that issues a bond under this subsection (3) is eligible for facility
20 reimbursements and advances pursuant to 20-9-366 through 20-9-371 that, until the new high school has
21 enrolled students in all grades and has established an actual ANB for budgeting purposes, must be based on
22 an estimated high school ANB calculated by dividing the ANB of the elementary district by 9 and multiplying the
23 result by 4.

24 (4) If elementary electors in each of the elementary districts approve a bond pursuant to
25 subsection (3), on July 1 following the approval of the bond the county superintendent shall order the creation
26 of a new high school district with identical boundaries to the contracting elementary districts and the immediate
27 attachment of the contracting elementary districts to form a new high school district. The county superintendent

1 shall send a copy of the order to the board of county commissioners and to the trustees of the districts affected
2 by the creation of the new high school district. The trustees of the contracting elementary district in which the
3 new high school will be operated must be designated as the trustees of the new high school district pursuant to
4 20-3-351 and 20-3-352. The trustees shall appoint a district superintendent pursuant to 20-4-401.

5 (5) Prior to the first school fiscal year in which the new high school district will enroll students in a
6 particular high school grade, the high school trustees shall prepare operating budgets for the new high school
7 according to the school budgeting provisions of Title 20, except that:

8 (a) the ANB for any inaugural grades for the high school district must be estimated by the trustees
9 and may not exceed the number resulting from dividing the highest budgeted ANB of the combined elementary
10 districts in the preceding 3 fiscal years by 9 and multiplying the result by the number of grades in which the high
11 school will enroll students for the first time in the ensuing school year;

12 (b) the number of quality educators must be estimated by the trustees and may not exceed the
13 number resulting from dividing the ANB estimated under subsection (5)(a) by 10;

14 (c) the taxable value for budgeting purposes of the new high school district must be based on the
15 taxable value as most recently determined by the department of revenue;

16 (d) the general fund budget adopted by the trustees must be based on only the basic entitlement,
17 the quality educator payment, and the budget components derived from ANB counts; and

18 (e) the district's BASE aid for the upcoming year must be based on the general fund budget
19 adopted by the trustees for the upcoming school year.

20 (6) Until the first school year in which the new high school district enrolls students in all grades and
21 for a period of time not to exceed 6 years following the creation of the new high school district:

22 (a) the former high school district with which the contracting elementary districts were previously
23 associated shall provide high school instruction to high school students of the new high school district in any
24 grades in which the new high school district is not enrolling students;

25 (b) the new high school district shall be responsible for providing transportation for its students
26 enrolled in the former high school district pursuant to subsection (6)(a), may establish a transportation budget
27 for this purpose, and may receive state and county reimbursements under Title 20, chapter 10; and

1 (c) the new high school district shall pay the former high school district 20% of the per-ANB
2 maximum rate established in 20-9-306 for each of its students enrolled in the former high school district, with
3 one-half of the amount due by December 31 of the year following the year of attendance and the remainder due
4 no later than June 15 of the year following the year of attendance. The new high school district trustees shall
5 establish a tuition fund and levy to fund these payments.

6 (7) (a) Bonded indebtedness of the former high school district that is outstanding as of the date of
7 creation of the new high school district must remain secured by and be the indebtedness of the original territory
8 against which the bonds of the former high school district were issued and must be paid by tax levies against
9 the original territory.

10 (b) Bonded indebtedness of the former high school district that is issued by the former high school
11 district following the creation of the new high school district is secured by the territory of the former high school
12 district as of the date of issuance of the former high school district bonds and must be paid by tax levies against
13 the territory of the former high school district. However, if bonds of the former high school district were
14 approved at a bond election conducted before the creation of the new high school district, all bonds of the
15 former high school district issued by the former high school district under the bond election authority must
16 remain secured by and be the indebtedness of the territory of the former high school district as of the date the
17 bond authority was approved by voters and must be paid by tax levies against that territory.

18 (c) Bonded indebtedness of the new high school district is secured by the territory of the new high
19 school district as of the date of issuance of the new high school district bonds and must be paid by tax levies
20 against the territory of the new high school district.

21 (d) Bonded indebtedness of any of the contracting elementary districts that is outstanding as of the
22 date of creation of the new high school district must remain the bonded indebtedness of the issuing elementary
23 district and must remain secured by the territory of the issuing elementary district and paid by tax levies against
24 the territory of the appropriate elementary district. The debt service on the bonds must remain allocated to the
25 issuing elementary district.

26 (e) Bonded indebtedness of the former high school district or the new high school district that is
27 subsequently affected by a later reorganization of the former high school district or the new high school district

1 is governed by the provisions of Title 20, chapter 6, part 4.

2 (8) When two or more elementary districts contract to create a new high school district as provided
3 for in this section, a principal, teacher, or other certified employee of the former high school district who has a
4 right of tenure under Montana law must be given preference in hiring for a vacant position in the new high
5 school district for which the employee is qualified with the required certification endorsements.

7 **Section 2.** Section 20-6-104, MCA, is amended to read:

8 **"20-6-104. Moratorium on creation of new district -- exceptions.** (1) Except as provided in
9 subsections (2) ~~and (3)~~ through (4), a school district may not initiate the creation of a new elementary district or
10 a new high school district.

11 (2) Pursuant to the provisions of 20-6-326, the trustees or the electors of an existing elementary
12 district may initiate the creation of a new high school district solely for the purpose of expanding into a K-12
13 district.

14 (3) Pursuant to the provisions of [section 1], the trustees or electors of two or more existing
15 elementary districts may initiate the creation of a new high school district.

16 ~~(3)(4)~~ The moratorium in subsection (1) does not apply to a district that results from the procedure for
17 the dissolution of a K-12 school district pursuant to 20-6-704."

19 **Section 3.** Section 20-9-366, MCA, is amended to read:

20 **"20-9-366. Definitions.** As used in 20-9-366 through 20-9-371, the following definitions apply:

21 (1) "County retirement mill value per elementary ANB" or "county retirement mill value per high
22 school ANB" means the sum of the taxable valuation in the previous year of all property in the county divided by
23 1,000, with the quotient divided by the total county elementary ANB count or the total county high school ANB
24 count used to calculate the elementary school districts' and high school districts' prior year total per-ANB
25 entitlement amounts.

26 (2) (a) "District guaranteed tax base ratio" for guaranteed tax base funding for the BASE budget of
27 an eligible district means the taxable valuation in the previous year of all property in the district, except for

1 property value disregarded because of protested taxes under 15-1-409(2) or property subject to the creation of
2 a new school district under 20-6-326 or [section 1], divided by the district's prior year GTBA budget area.

3 (b) "District mill value per ANB", for school facility entitlement purposes, means the taxable
4 valuation in the previous year of all property in the district, except for property subject to the creation of a new
5 school district under 20-6-326 or [section 1], divided by 1,000, with the quotient divided by the ANB count of the
6 district used to calculate the district's prior year total per-ANB entitlement amount.

7 (3) "Facility guaranteed mill value per ANB", for school facility entitlement guaranteed tax base
8 purposes, means the sum of the taxable valuation in the previous year of all property in the state, multiplied by
9 140% and divided by 1,000, with the quotient divided by the total state elementary ANB count or the total state
10 high school ANB count used to calculate the elementary school districts' and high school districts' prior year
11 total per-ANB entitlement amounts.

12 (4) "Guaranteed tax base aid budget area" or "GTBA budget area" means the portion of a district's
13 BASE budget after the following payments are subtracted:

- 14 (a) direct state aid;
- 15 (b) the total data-for-achievement payment;
- 16 (c) the total quality educator payment;
- 17 (d) the total at-risk student payment;
- 18 (e) the total Indian education for all payment;
- 19 (f) the total American Indian achievement gap payment; and
- 20 (g) the state special education allowable cost payment.

21 (5) (a) Except as provided in subsection (6), "Statewide elementary guaranteed tax base ratio" or
22 "statewide high school guaranteed tax base ratio", for guaranteed tax base funding for the BASE budget of an
23 eligible district, means the sum of the taxable valuation in the previous year of all property in the state,
24 multiplied by 250% for fiscal year 2022 and 254% for fiscal year 2023 and each succeeding fiscal year and
25 divided by the prior year statewide GTBA budget area for the state elementary school districts or the state high
26 school districts. For fiscal year 2024 and subsequent fiscal years, the superintendent of public instruction shall
27 increase the multiplier in this subsection (5)(a) as follows:

1 (i) for fiscal years 2024 through 2031, if the revenue transferred to the state general fund pursuant
2 to 16-12-111 in the prior fiscal year is at least \$1 million more than the revenue transferred in the fiscal year 2
3 years prior, then:

4 (A) multiply the amount of increased revenue transferred to the state general fund pursuant to 16-
5 12-111 in the prior fiscal year above the amount of revenue transferred in the fiscal year 2 years prior by 0.25,
6 divide the resulting product by \$500,000, and round to the nearest whole number; and

7 (B) add the number derived in subsection (5)(a)(i)(A) as a percentage point increase to:

15 (A) if the prior year was not affected by a contingency under subsection (6), the multiplier used for
16 the prior fiscal year; or

17 (B) if the prior year was affected by a contingency under subsection (6), the multiplier for the prior
18 fiscal year had the prior fiscal year not been affected by a contingency under subsection (6); and

19 (iii) for fiscal years 2032 and subsequent fiscal years, the multiplier is equal to the multiplier used
20 for fiscal year 2031.

21 (b) "statewide mill value per elementary ANB" or "statewide mill value per high school ANB", for
22 school retirement guaranteed tax base purposes, means the sum of the taxable valuation in the previous year
23 of all property in the state, multiplied by 121% and divided by 1,000, with the quotient divided by the total state
24 elementary ANB count or the total state high school ANB amount used to calculate the elementary school
25 districts' and high school districts' prior year total per-ANB entitlement amounts.

26 (6) The guaranteed tax base multiplier under subsection (5)(a) must be reduced by 4 percentage
27 points following certification by the budget director of a contingency pursuant to Chapter 506, Laws of 2021:

7 **"20-9-439. Computation of net levy requirement for general obligation bonds -- procedure**

8 **when levy inadequate.** Subject to 20-6-326 and [section 1], the following provisions apply:

9 (1) The county superintendent shall compute the levy requirement for each school district's general
10 obligation debt service fund on the basis of the following procedure:

11 (a) Determine the total money available in the debt service fund for the reduction of the property
12 tax on the district by totaling:

13 (i) the end-of-the-year fund balance in the debt service fund, less any limited operating reserve as
14 provided in 20-9-438;

15 (ii) anticipated interest to be earned by the investment of debt service cash in accordance with the
16 provisions of 20-9-213(4) or by the investment of bond proceeds under the provisions of 20-9-435;

17 (iii) any state advance for school facilities distributed to a qualified district under the provisions of
18 20-9-346, 20-9-370, and 20-9-371;

19 (iv) funds transferred from the impact aid fund established pursuant to 20-9-514 that are authorized
20 by 20-9-437(2) to be used to repay the district's bonds; and

21 (v) any other money, including money from federal sources, anticipated by the trustees to be
22 available in the debt service fund during the ensuing school fiscal year from sources such as legally authorized
23 money transfers into the debt service fund or from rental income, excluding any guaranteed tax base aid.

24 (b) Subtract the total amount available to reduce the property tax, determined in subsection (1)(a),
25 from the final budget for the debt service fund as established in 20-9-438.

26 (2) The net debt service fund levy requirement determined in subsection (1)(b) must be reported to
27 the county commissioners by the later of the first Tuesday in September or within 30 calendar days after

2 the district, and a levy must be made by the county commissioners in accordance with 20-9-142.

3 (3) If the board of county commissioners fails in any school fiscal year to make a levy for any issue
4 or series of bonds of a school district sufficient to raise the money necessary for payment of interest and
5 principal becoming due during the next ensuing school fiscal year, in any amounts established under the
6 provisions of this section, the holder of any bond of the issue or series or any taxpayer of the district may apply

19 **Section 5.** Section 20-9-502, MCA, is amended to read:

20 **"20-9-502. Purpose and authorization of building reserve fund -- subfund structure.** (1) The
21 trustees of any district may establish a building reserve fund to budget for and expend funds for any of the
22 purposes set forth in this section. Appropriate subfunds must be created to ensure separate tracking of the
23 expenditure of funds from voted and nonvoted levies and transfers for school safety pursuant to 20-9-236.

24 (2) (a) A voted levy may be imposed and a subfund must be created with the approval of the
25 qualified electors of the district for the purpose of raising money for the future construction, equipping, or
26 enlarging of school buildings or for the purpose of purchasing land needed for school purposes in the district. In
27 order to submit to the qualified electors of the district a building reserve proposition for the establishment of or

1 addition to a building reserve, the trustees shall pass a resolution that specifies:

2 (i) the purpose or purposes for which the new or addition to the building reserve will be used;

3 (ii) the duration of time over which the new or addition to the building reserve will be raised in

4 annual, equal installments;

5 (iii) the total amount of money that will be raised during the duration of time specified for the levy;

6 and

7 (iv) any other requirements under 15-10-425 and 20-20-201 for the calling of an election.

8 (b) Except as provided in subsection (4)(b), a building reserve tax authorization may not be for

9 more than 20 years.

10 (c) The election must be conducted in accordance with the school election laws of this title, and
11 the electors qualified to vote in the election must be qualified under the provisions of 20-20-301. The ballot for a
12 building reserve proposition must be substantially in compliance with 15-10-425.

13 (d) The building reserve proposition is approved if a majority of those electors voting at the election
14 approve the establishment of or addition to the building reserve. The annual budgeting and taxation authority of
15 the trustees for a building reserve is computed by dividing the total authorized amount by the specified number
16 of years. The authority of the trustees to budget and impose the taxation for the annual amount to be raised for
17 the building reserve lapses when, at a later time, a bond issue is approved by the qualified electors of the
18 district for the same purpose or purposes for which the building reserve fund of the district was established.
19 Whenever a subsequent bond issue is made for the same purpose or purposes of a building reserve, the
20 money in the building reserve must be used for the purpose or purposes before any money realized by the
21 bond issue is used.

22 (3) (a) A subfund must be created to account for revenue and expenditures for school major
23 maintenance and repairs authorized under this subsection (3). The trustees of a district may authorize and
24 impose a levy of no more than 10 mills on the taxable value of all taxable property within the district for that
25 school fiscal year for the purposes of raising revenue for identified improvements or projects meeting the
26 requirements of 20-9-525(2). The 10-mill limit under this subsection (3) must be calculated using the district's
27 total taxable valuation most recently certified by the department of revenue under 15-10-202. The amount of

1 money raised by the levy, the deposits and transfers authorized under subsection (3)(f) of this section, and
2 anticipated state aid pursuant to 20-9-525(3) may not exceed the district's school major maintenance amount.
3 For the purposes of this section, the term "school major maintenance amount" means the sum of \$15,000 and
4 the product of \$110 multiplied by the district's budgeted ANB for the prior fiscal year. To authorize and impose a
5 levy under this subsection (3), the trustees shall:

6 (i) following public notice requirements pursuant to 20-9-116, adopt no later than March 31 of

14 the department of revenue under 15-10-202; and

15 (ii) include the amount of any final levy to be imposed as part of its final budget meeting noticed in
16 compliance with 20-9-131.

17 (b) Proceeds from the levy may be expended only for the purposes under 20-9-525(2), and the
18 expenditure of the money must be reported in the annual trustees' report as required by 20-9-213.

19 (c) Whenever the trustees of a district impose a levy pursuant to this subsection (3) during the
20 current school fiscal year, they shall budget for the proceeds of the levy, the deposits and transfers authorized
21 under subsection (3)(f) of this section, and anticipated state aid pursuant to 20-9-525(3) in the district's building
22 reserve fund budget. Any expenditures of the funds must be made in accordance with the financial
23 administration provisions of this title for a budgeted fund.

24 (d) When a tax levy pursuant to this subsection (3) is included as a revenue item on the final
25 building reserve fund budget, the county superintendent shall report the levy requirement to the county
26 commissioners by the later of the first Tuesday in September or within 30 calendar days after receiving certified
27 taxable values and a levy on the district must be made by the county commissioners in accordance with 20-9-

5 (f) If the imposition of 10 mills pursuant to subsection (3)(a) is estimated by the trustees to
6 generate an amount less than the maximum levy revenue specified in subsection (3)(a), the trustees may
7 deposit additional funds from any lawfully available revenue source and may transfer additional funds from any
8 lawfully available fund of the district to the subfund provided for in subsection (3)(a), up to the difference
9 between the revenue estimated to be raised by the imposition of 10 mills and the maximum levy revenue
10 specified in subsection (3)(a). The district's local effort for purposes of calculating its eligibility for state school
11 major maintenance aid pursuant to 20-9-525 consists of the combined total of funds raised from the imposition
12 of 10 mills and additional funds raised from deposits and transfers in compliance with this subsection (3)(f).

13 (4) (a) A voted levy may be imposed and a subfund must be created with the approval of the
14 qualified electors of the district to provide funding for transition costs incurred when the trustees:

- 15 (i) open a new school under the provisions of Title 20, chapter 6;
- 16 (ii) close a school;
- 17 (iii) replace a school building;
- 18 (iv) consolidate with or annex another district under the provisions of Title 20, chapter 6; or
- 19 (v) receive approval from voters to expand an elementary district into a K-12 district pursuant to

20 20-6-326; or

21 (vi) receive approval from voters to allow two or more elementary districts to contract to create a
22 new high school district pursuant to [section 1].

23 (b) Except as provided in subsection (4)(c), the total amount the trustees may submit to the
24 electorate for transition costs may not exceed the number of years specified in the proposition times the greater
25 of 5% of the district's maximum general fund budget for the current year or \$250 per ANB for the current year.
26 The duration of the levy for transition costs may not exceed 6 years.

27 (c) If the levy for transition costs is for consolidation or annexation:

1 (i) the limitation on the amount levied is calculated using the ANB and the maximum general fund
2 budget for the districts that are being combined; and

3 (ii) the proposition must be submitted to the qualified electors in the combined district.

4 (d) The levy for transition costs may not be considered as outstanding indebtedness for the
5 purpose of calculating the limitation in 20-9-406.

6 (5) (a) A subfund in the building reserve fund must be created for:

7 (i) the funds transferred to the building reserve fund for school safety and security pursuant to 20-
8 9-236; and

9 (ii) funds generated by a voter-approved levy for school and student safety and security pursuant
10 to subsection (5)(b) of this section.

11 (b) A voted levy may be imposed with the approval of the qualified electors of the district to provide
12 funding for improvements to school and student safety and security that meet any of the criteria set forth in 20-
13 9-236(1)(a) through (1)(e). A voted levy for school and student safety and security may not be considered as

19 **NEW SECTION. Section 6. Delay in facility construction or renovation.** If a new high school
20 district is created pursuant to [section 1], the district may not begin to undertake the activities for which the
21 general obligation bond was approved pursuant to [section 1(3)], including building, altering, repairing, buying,
22 furnishing, equipping, or obtaining a water supply for a school to accommodate high school students, before
23 July 1, 2025. The requirements of this section do not apply to the purchase or procurement of land.
