11 NEW SECTION. **Section 1. Committee procurement -- rulemaking.** (1) The wheat and barley
12 committee is not subject to procurement procedures under Title 18, chapter 4.

13 (2) The committee shall adopt rules for procurement of goods and services necessary to the duties
14 outlined in this part.
