12	NEW SECTION. Section 1. Coverage of glucose monitoring supplies. (1) Each individual		
13	disability policy, certificate of insurance, and membership contract that is delivered, issued for delivery,		
14	renewed, extended, or modified in this state must provide coverage of continuous glucose monitors and monitor		
15	supplies if a monitor is recommended by a health care provider person is treated with at least a single injectable		
16	that is at least once a day. A policy, certificate, or contract may not condition coverage on the stage of the		
17	insured's disease.		
18	(2) Coverage under this section may be subject to deductibles, coinsurance, and copayment		
19	provisions. Special deductible, coinsurance, copayment, or other limitations that are not generally applicable to		
20	other medical services covered under the plan may not be imposed on coverage of a continuous glucose		
21	monitor.		
22	(3) This section does not apply to disability income, hospital indemnity, medicare supplement,

16 (i) is a member of a plan with substantially the same or greater benefits at an equivalent cost;

(ii) is employed and, by virtue of that employment, is eligible to participate in another group plan
with substantially the same or greater benefits at an equivalent cost; or

19 (iii) becomes eligible for medicare under the federal Health Insurance for the Aged Act.

20 (c) A judge who remains a member of the group under the provisions of this subsection (4) and

16 (b) Coverage for well-child care under subsection (8)(a) must include:

17 (i) a history, physical examination, developmental assessment, anticipatory guidance, and

18 laboratory tests, according to the schedule of visits adopted under the early and periodic screening, diagnosis,

19 and treatment services program provided for in 53-6-101; and

20 (ii) routine immunizations according to the schedule for immunization recommended by the

21 advisory committee on immunization practices of the U.S. department of health and human services.

22 (c) Minimum benefits may be limited to one visit payable to one provider for all of the services

23 provided at each visit as provided for in this subsection (8).

24 (d) For purposes of this subsection (8):

25 (i) "developmental assessment" and "anticipatory guidance" mean the services described in the

26 Guidelines for Health Supervision II, published by the American academy of pediatrics; and

27 (ii) "well-child care" means the services described in subsection (8)(b) and delivered by a

28 physician or a health care professional supervised by a physician.

(12) (a) The state employee group benefit plans and the Montana university system group benefits
 plans must provide coverage for outpatient self-management training and education for the treatment of
 diabetes. Any education must be provided by a licensed health care professional with expertise in diabetes.

(b) Coverage must include a \$250 benefit for a person each year for medically necessary and
 prescribed outpatient self-management training and education for the treatment of diabetes.

(c) (i) The state employee group benefit plans and the Montana university system group benefits
 plans must provide coverage for diabetic equipment and supplies that at a minimum includes insulin, syringes,
 injection aids, devices for self-monitoring of glucose levels (including those for the visually impaired), test strips,
 visual reading and urine test strips, one insulin pump for each warranty period, accessories to insulin pumps,
 one prescriptive oral agent for controlling blood sugar levels for each class of drug approved by the United
 States food and drug administration, and glucagon emergency kits.

recommended by the insured's health care provider. Coverage may not be limited based on the stage of the
 insured's disease.

(d) Nothing in subsection (12)(a), (12)(b), or (12)(c) prohibits the state or the Montana university

8 (13) (a) The state employee group benefit plans and the Montana university system group benefits 9 plans that provide coverage to the spouse or dependents of a peace officer as defined in 45-2-101, a game 10 warden as defined in 19-8-101, a firefighter as defined in 19-13-104, or a volunteer firefighter as defined in 19-11 17-102 shall renew the coverage of the spouse or dependents if the peace officer, game warden, firefighter, or 12 volunteer firefighter dies within the course and scope of employment. Except as provided in subsection (13)(b), 13 the continuation of the coverage is at the option of the spouse or dependents. Renewals of coverage under this 14 section must provide for the same level of benefits as is available to other members of the group. Premiums 15 charged to a spouse or dependent under this section must be the same as premiums charged to other similarly 16 situated members of the group. Dependent special enrollment must be allowed under the terms of the 17 insurance contract or plan. The provisions of this subsection (13)(a) are applicable to a spouse or dependent 18 who is insured under a COBRA continuation provision.

(b) The state employee group benefit plans and the Montana university system group benefits
 plans subject to the provisions of subsection (13)(a) may discontinue or not renew the coverage of a spouse or
 dependent only if:

(i) the spouse or dependent has failed to pay premiums or contributions in accordance with the
 terms of the state employee group benefit plans and the Montana university system group benefits plans or if
 the plans have not received timely premium payments;

25 (ii) the spouse or dependent has performed an act or practice that constitutes fraud or has made 26 an intentional misrepresentation of a material fact under the terms of the coverage; or

(iii) the state employee group benefit plans and the Montana university system group benefits
plans are ceasing to offer coverage in accordance with applicable state law.
