21 is ordinarily not given away free but is purchased.

22 (4) "Application for voter registration" means a voter registration form prescribed by the secretary of
23 state that is completed and signed by an elector, is submitted to the election administrator, and contains voter
24 registration information subject to verification as provided by law.

25 (5) "Ballot" means a paper ballot counted manually or a paper ballot counted by a machine, such as
26 an optical scan system or other technology that automatically tabulates votes cast by processing the paper
