4 A JOINT RESOLUTION OF THE SENATE AND THE HOUSE OF REPRESENTATIVES OF THE STATE OF
5 MONTANA ACKNOWLEDGING AND THANKING MILITARY VETERANS WHO SERVED IN THE KOREAN
6 WAR AND RECOGNIZING THOSE FROM MONTANA WHO SACRIFICED THEIR LIVES.

8 WHEREAS, on June 25, 1950, Communist North Korea invaded South Korea, thereby initiating the
9 Korean War; and

10 WHEREAS, President Harry S. Truman ordered U.S. military intervention to help stop the attack on
11 June 27, 1950; and

12 WHEREAS, approximately 5,720,000 men and women of the U.S. Armed Forces served and fought
13 during the Korean War to defeat the spread of communism; and

14 WHEREAS, many Montanans have made the ultimate sacrifice in serving our country and securing the
15 freedoms we enjoy today; and

16 WHEREAS, these brave heroes answered the call of our national anthem, which states "then conquer
17 we must when our cause it is just"; and

18 WHEREAS, these heroes and their families deserve honor and remembrance for the tremendous
19 sacrifices they made in service to their country.

21 NOW, THEREFORE, BE IT RESOLVED BY THE SENATE AND THE HOUSE OF REPRESENTATIVES OF
22 THE STATE OF MONTANA:

23 That the 68th Legislature hereby recognizes and thanks veterans of the Korean War and their families
24 for their sacrifices in service to their country.
