BY REQUEST OF THE CRIMINAL JUSTICE OVERSIGHT COUNCIL

A BILL FOR AN ACT ENTITLED: "AN ACT REVISING SENTENCING LAWS FOR THEFT, FAILURE TO RETURN RENTED OR LEASED PERSONAL PROPERTY, ISSUING A BAD CHECK, DECEPTIVE PRACTICES, AND FORGERY; PROVIDING APPROPRIATIONS; PROVIDING FOR CONTINGENT VOIDNESS; AND AMENDING SECTIONS 45-2-101, 45-6-301, 45-6-309, 45-6-316, 45-6-317, AND 45-6-325, MCA; AND PROVIDING AN EFFECTIVE DATE."

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

Section 1. Section 45-2-101, MCA, is amended to read:

"45-2-101. General definitions. Unless otherwise specified in the statute, all words must be taken in the objective standard rather than in the subjective, and unless a different meaning plainly is required, the following definitions apply in this title:

- (1) "Acts" has its usual and ordinary meaning and includes any bodily movement, any form of communication, and when relevant, a failure or omission to take action.
- (2) "Administrative proceeding" means a proceeding the outcome of which is required to be based on a record or documentation prescribed by law or in which a law or a regulation is particularized in its application to an individual.
- (3) "Another" means a person or persons other than the offender.
- (4) (a) "Benefit" means gain or advantage or anything regarded by the beneficiary as gain or advantage, including benefit to another person or entity in whose welfare the beneficiary is interested.
(b) Benefit does not include an advantage promised generally to a group or class of voters as a consequence of public measures that a candidate engages to support or oppose.
- (5) "Bodily injury" means physical pain, illness, or an impairment of physical condition and includes

2 (6) "Child" or "children" means any individual or individuals under 18 years of age, unless a
3 different age is specified.

4 (7) "Cohabit" means to live together under the representation of being married.

5 (8) "Common scheme" means a series of acts or omissions ~~resulting in a pecuniary loss to the~~
6 ~~victim of at least \$1,500, or \$1,500 in value,~~ motivated by a purpose to accomplish a single criminal objective or
7 by a common purpose or plan that results in the repeated commission of the same offense or that affects the
8 same person or the same persons or the property of the same person or persons.

9 (9) "Computer" means an electronic device that performs logical, arithmetic, and memory functions
10 by the manipulation of electronic or magnetic impulses and includes all input, output, processing, storage,
11 software, or communication facilities that are connected or related to that device in a system or network.

12 (10) "Computer network" means the interconnection of communication systems between computers
13 or computers and remote terminals.

14 (11) "Computer program" means an instruction or statement or a series of instructions or
15 statements, in a form acceptable to a computer, that in actual or modified form permits the functioning of a
16 computer or computer system and causes it to perform specified functions.

17 (12) "Computer services" include but are not limited to computer time, data processing, and storage
18 functions.

19 (13) "Computer software" means a set of computer programs, procedures, and associated
20 documentation concerned with the operation of a computer system.

21 (14) "Computer system" means a set of related, connected, or unconnected devices, computer
22 software, or other related computer equipment.

23 (15) "Conduct" means an act or series of acts and the accompanying mental state.

24 (16) "Conviction" means a judgment of conviction and sentence entered upon a plea of guilty or
25 nolo contendere or upon a verdict or finding of guilty of an offense rendered by a legally constituted jury or by a
26 court of competent jurisdiction authorized to try the case without a jury.

27 (17) "Correctional institution" means a state prison, detention center, multijurisdictional detention

2 the incarceration of inmates under sentence for offenses or the custody of individuals awaiting trial or sentence
3 for offenses.

4 (18) "Deception" means knowingly to:

5 (a) create or confirm in another an impression that is false and that the offender does not believe
6 to be true;

7 (b) fail to correct a false impression that the offender previously has created or confirmed;

8 (c) prevent another from acquiring information pertinent to the disposition of the property involved;

9 (d) sell or otherwise transfer or encumber property without disclosing a lien, adverse claim, or

10 other legal impediment to the enjoyment of the property, whether the impediment is or is not of value or is or is
11 not a matter of official record; or

12 (e) promise performance that the offender does not intend to perform or knows will not be
13 performed. Failure to perform, standing alone, is not evidence that the offender did not intend to perform.

14 (19) "Defamatory matter" means anything that exposes a person or a group, class, or association to
15 hatred, contempt, ridicule, degradation, or disgrace in society or to injury to the person's or its business or
16 occupation.

17 (20) "Deprive" means:

18 (a) to withhold property of another:

19 (i) permanently;

20 (ii) for such a period as to appropriate a portion of its value; or

21 (iii) with the purpose to restore it only upon payment of reward or other compensation; or

22 (b) to dispose of the property of another and use or deal with the property so as to make it unlikely
23 that the owner will recover it.

24 (21) "Deviate sexual relations" means any form of sexual intercourse with an animal.

25 (22) "Document" means, with respect to offenses involving the medicaid program, any application,
26 claim, form, report, record, writing, or correspondence, whether in written, electronic, magnetic, microfilm, or
27 other form.

1 (23) "Felony" means an offense in which the sentence imposed upon conviction is death or
2 imprisonment in a state prison for a term exceeding 1 year.

3 (24) "Forcible felony" means a felony that involves the use or threat of physical force or violence
4 against any individual.

5 (25) A "frisk" is a search by an external patting of a person's clothing.

6 (26) "Government" includes a branch, subdivision, or agency of the government of the state or a
7 locality within it.

8 (27) "Harm" means loss, disadvantage, or injury or anything so regarded by the person affected,
9 including loss, disadvantage, or injury to a person or entity in whose welfare the affected person is interested.

10 (28) A "house of prostitution" means a place where prostitution or promotion of prostitution is
11 regularly carried on by one or more persons under the control, management, or supervision of another.

12 (29) "Human being" means a person who has been born and is alive.

13 (30) An "illegal article" is an article or thing that is prohibited by statute, rule, or order from being in
14 the possession of a person subject to official detention.

15 (31) "Inmate" means a person who is confined in a correctional institution.

16 (32) (a) "Intoxicating substance" means a controlled substance, as defined in Title 50, chapter 32,
17 and an alcoholic beverage, including but not limited to a beverage containing 1/2 of 1% or more of alcohol by
18 volume.

19 (b) Intoxicating substance does not include dealcoholized wine or a beverage or liquid produced
20 by the process by which beer, ale, port, or wine is produced if it contains less than 1/2 of 1% of alcohol by
21 volume.

22 (33) An "involuntary act" means an act that is:

23 (a) a reflex or convulsion;

24 (b) a bodily movement during unconsciousness or sleep;

25 (c) conduct during hypnosis or resulting from hypnotic suggestion; or

26 (d) a bodily movement that otherwise is not a product of the effort or determination of the actor,
27 either conscious or habitual.

1 (34) "Juror" means a person who is a member of a jury, including a grand jury, impaneled by a court
2 in this state in an action or proceeding or by an officer authorized by law to impanel a jury in an action or
3 proceeding. The term "juror" also includes a person who has been drawn or summoned to attend as a
4 prospective juror.

5 (35) "Knowingly"--a person acts knowingly with respect to conduct or to a circumstance described
6 by a statute defining an offense when the person is aware of the person's own conduct or that the circumstance
7 exists. A person acts knowingly with respect to the result of conduct described by a statute defining an offense
8 when the person is aware that it is highly probable that the result will be caused by the person's conduct. When
9 knowledge of the existence of a particular fact is an element of an offense, knowledge is established if a person
10 is aware of a high probability of its existence. Equivalent terms, such as "knowing" or "with knowledge", have
11 the same meaning.

12 (36) "Medicaid" means the Montana medical assistance program provided for in Title 53, chapter 6.

13 (37) "Medicaid agency" has the meaning in 53-6-155.

14 (38) "Medicaid benefit" means the provision of anything of pecuniary value to or on behalf of a
15 recipient under the medicaid program.

16 (39) (a) "Medicaid claim" means a communication, whether in oral, written, electronic, magnetic, or
17 other form:

18 (i) that is used to claim specific services or items as payable or reimbursable under the medicaid
19 program; or

20 (ii) that states income, expense, or other information that is or may be used to determine
21 entitlement to or the rate of payment under the medicaid program.

22 (b) The term includes related documents submitted as a part of or in support of the claim.

23 (40) "Mentally disordered" means that a person suffers from a mental disease or disorder that
24 renders the person incapable of appreciating the nature of the person's own conduct.

25 (41) "Mentally incapacitated" means that a person is rendered temporarily incapable of appreciating
26 or controlling the person's own conduct as a result of the influence of an intoxicating substance.

27 (42) "Misdemeanor" means an offense for which the sentence imposed upon conviction is

3 (43) "Negligently"--a person acts negligently with respect to a result or to a circumstance described
4 by a statute defining an offense when the person consciously disregards a risk that the result will occur or that
5 the circumstance exists or when the person disregards a risk of which the person should be aware that the
6 result will occur or that the circumstance exists. The risk must be of a nature and degree that to disregard it
7 involves a gross deviation from the standard of conduct that a reasonable person would observe in the actor's
8 situation. "Gross deviation" means a deviation that is considerably greater than lack of ordinary care. Relevant
9 terms, such as "negligent" and "with negligence", have the same meaning.

10 (44) "Nolo contendere" means a plea in which the defendant does not contest the charge or
11 charges against the defendant and neither admits nor denies the charge or charges.

12 (45) "Obtain" means:

13 (a) in relation to property, to bring about a transfer of interest or possession, whether to the
14 offender or to another; and

15 (b) in relation to labor or services, to secure the performance of the labor or service.

16 (46) "Obtains or exerts control" includes but is not limited to the taking, the carrying away, or the
17 sale, conveyance, or transfer of title to, interest in, or possession of property.

18 (47) "Occupied structure" means any building, vehicle, or other place suitable for human occupancy
19 or night lodging of persons or for carrying on business, whether or not a person is actually present, including
20 any outbuilding that is immediately adjacent to or in close proximity to an occupied structure and that is
21 habitually used for personal use or employment. Each unit of a building consisting of two or more units
22 separately secured or occupied is a separate occupied structure.

23 (48) "Offender" means a person who has been or is liable to be arrested, charged, convicted, or
24 punished for a public offense.

25 (49) "Offense" means a crime for which a sentence of death or of imprisonment or a fine is
26 authorized. Offenses are classified as felonies or misdemeanors.

27 (50) (a) "Official detention" means imprisonment resulting from a conviction for an offense,

4 (b) Official detention does not include supervision of probation or parole, constraint incidental to
5 release on bail, or an unlawful arrest unless the person arrested employed physical force, a threat of physical
6 force, or a weapon to escape.

7 (51) "Official proceeding" means a proceeding heard or that may be heard before a legislative, a
8 judicial, an administrative, or another governmental agency or official authorized to take evidence under oath,
9 including any referee, hearings examiner, commissioner, notary, or other person taking testimony or deposition
10 in connection with the proceeding.

11 (52) "Other state" means a state or territory of the United States, the District of Columbia, and the
12 Commonwealth of Puerto Rico.

13 (53) "Owner" means a person other than the offender who has possession of or other interest in the
14 property involved, even though the interest or possession is unlawful, and without whose consent the offender
15 has no authority to exert control over the property.

16 (54) "Party official" means a person who holds an elective or appointive post in a political party in
17 the United States by virtue of which the person directs or conducts or participates in directing or conducting
18 party affairs at any level of responsibility.

19 (55) "Peace officer" means a person who by virtue of the person's office or public employment is
20 vested by law with a duty to maintain public order or to make arrests for offenses while acting within the scope
21 of the person's authority.

22 (56) "Pecuniary benefit" is benefit in the form of money, property, commercial interests, or anything
23 else the primary significance of which is economic gain.

24 (57) "Person" includes an individual, business association, partnership, corporation, government, or
25 other legal entity and an individual acting or purporting to act for or on behalf of a government or subdivision of
26 government.

27 (58) "Physically helpless" means that a person is unconscious or is otherwise physically unable to

2 (59) "Possession" is the knowing control of anything for a sufficient time to be able to terminate
3 control.

4 (60) "Premises" includes any type of structure or building and real property.

5 (61) "Property" means a tangible or intangible thing of value. Property includes but is not limited to:

6 (a) real estate;

7 (b) money;

8 (c) commercial instruments;

9 (d) admission or transportation tickets;

10 (e) written instruments that represent or embody rights concerning anything of value, including
11 labor or services, or that are otherwise of value to the owner;

12 (f) things growing on, affixed to, or found on land and things that are part of or affixed to a
13 building;

14 (g) electricity, gas, and water;

15 (h) birds, animals, and fish that ordinarily are kept in a state of confinement;

16 (i) food and drink, samples, cultures, microorganisms, specimens, records, recordings,
17 documents, blueprints, drawings, maps, and whole or partial copies, descriptions, photographs, prototypes, or
18 models thereof;

19 (j) other articles, materials, devices, substances, and whole or partial copies, descriptions,
20 photographs, prototypes, or models thereof that constitute, represent, evidence, reflect, or record secret
21 scientific, technical, merchandising, production, or management information or a secret designed process,
22 procedure, formula, invention, or improvement; and

23 (k) electronic impulses, electronically processed or produced data or information, commercial
24 instruments, computer software or computer programs, in either machine- or human-readable form, computer
25 services, any other tangible or intangible item of value relating to a computer, computer system, or computer
26 network, and copies thereof.

27 (62) "Property of another" means real or personal property in which a person other than the offender

3 (63) "Public place" means a place to which the public or a substantial group has access.

4 (64) (a) "Public servant" means an officer or employee of government, including but not limited to
5 legislators, judges, and firefighters, and a person participating as a juror, adviser, consultant, administrator,
6 executor, guardian, or court-appointed fiduciary. The term "public servant" includes one who has been elected
7 or designated to become a public servant.

8 (b) The term does not include witnesses.

9 (65) "Purposely"--a person acts purposely with respect to a result or to conduct described by a
10 statute defining an offense if it is the person's conscious object to engage in that conduct or to cause that result.
11 When a particular purpose is an element of an offense, the element is established although the purpose is
12 conditional, unless the condition negatives the harm or evil sought to be prevented by the law defining the
13 offense. Equivalent terms, such as "purpose" and "with the purpose", have the same meaning.

14 (66) (a) "Serious bodily injury" means bodily injury that:

15 (i) creates a substantial risk of death;

16 (ii) causes serious permanent disfigurement or protracted loss or impairment of the function or
17 process of a bodily member or organ; or

18 (iii) at the time of injury, can reasonably be expected to result in serious permanent disfigurement
19 or protracted loss or impairment of the function or process of a bodily member or organ.

20 (b) The term includes serious mental illness or impairment.

21 (67) "Sexual contact" means touching of the sexual or other intimate parts of the person of another,
22 directly or through clothing, in order to knowingly or purposely:

23 (a) cause bodily injury to or humiliate, harass, or degrade another; or

24 (b) arouse or gratify the sexual response or desire of either party.

25 (68) (a) "Sexual intercourse" means penetration of the vulva, anus, or mouth of one person by the

15 (75) "Telephone" means any type of telephone, including but not limited to a corded, uncoded,
16 cellular, or satellite telephone.

17 (76) "Threat" means a menace, however communicated, to:

18 (a) inflict physical harm on the person threatened or any other person or on property;

19 (b) subject any person to physical confinement or restraint;

20 (c) commit a criminal offense;

21 (d) accuse a person of a criminal offense;

22 (e) expose a person to hatred, contempt, or ridicule;

23 (f) harm the credit or business repute of a person;

24 (g) reveal information sought to be concealed by the person threatened;

25 (h) take action as an official against anyone or anything, withhold official action, or cause the
26 action or withholding;

27 (i) bring about or continue a strike, boycott, or other similar collective action if the person making

5 (77) (a) "Value" means the market value of the property at the time and place of the crime or, if the
6 market value cannot be satisfactorily ascertained, the cost of the replacement of the property within a
7 reasonable time after the crime. If the offender appropriates a portion of the value of the property, the value
8 must be determined as follows:

9 (i) The value of an instrument constituting an evidence of debt, such as a check, draft, or
10 promissory note, is considered the amount due or collectible. The figure is ordinarily the face amount of the
11 indebtedness less any portion of the indebtedness that has been satisfied.

12 (ii) The value of any other instrument that creates, releases, discharges, or otherwise affects any
13 valuable legal right, privilege, or obligation is considered the amount of economic loss that the owner of the
14 instrument might reasonably suffer by virtue of the loss of the instrument.

15 (iii) The value of electronic impulses, electronically produced data or information, computer
16 software or programs, or any other tangible or intangible item relating to a computer, computer system, or
17 computer network is considered to be the amount of economic loss that the owner of the item might reasonably
18 suffer by virtue of the loss of the item. The determination of the amount of economic loss includes but is not
19 limited to consideration of the value of the owner's right to exclusive use or disposition of the item.

20 (b) When it cannot be determined if the value of the property is more or less than \$1,500 by the
21 standards set forth in subsection (77)(a), its value is considered to be an amount less than \$1,500.

22 (c) Amounts involved in thefts committed pursuant to a common scheme or the same transaction,
23 whether from the same person or several persons, may be aggregated in determining the value of the property.

24 (78) "Vehicle" means a device for transportation by land, water, or air or by mobile equipment, with
25 provision for transport of an operator.

26 (79) "Weapon" means an instrument, article, or substance that, regardless of its primary function, is
27 readily capable of being used to produce death or serious bodily injury.

6 obtains or exerts unauthorized control over property of the owner and:

8 (b) purposely or knowingly uses, conceals, or abandons the property in a manner that deprives the
9 owner of the property; or

10 (c) uses, conceals, or abandons the property knowing that the use, concealment, or abandonment

12 (2) A person commits the offense of theft when the person purposely or knowingly obtains by
13 threat or deception control over property of the owner and:
