16	(c)	the court has made an adjudication under 41-3-437 that the child is a youth in need of care.
17	(2)	Every treatment plan must contain the following information:
18	(a)	the identification of the problems or conditions that resulted in the abuse or neglect of a child;
19	(b)	the treatment goals and objectives for each condition or requirement established in the plan. If
20	the child has been removed from the home, the treatment plan must include but is not limited to the conditions	
21	or requirements that must be established for the safe return of the child to the family.
