9	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

11	Section 1. Section 45-5-702, MCA, is amended to read:
12	"45-5-702. Trafficking of persons. (1) A person commits the offense of trafficking of persons if the
13	person purposely or knowingly:
14	(a) recruits, transports, transfers, harbors, receives, provides, obtains, isolates, maintains, or
15	entices another person intending or knowing that the person will be subjected to involuntary servitude or sexual
16	servitude; or
17	(b) benefits, financially or by receiving anything of value, from facilitating any conduct described in
18	subsection (1)(a) or from participation in a venture that has subjected another person to involuntary servitude or
19	sexual servitude.
20	(2) (a) Except as provided in subsections (2)(b) and (2)(c), a person convicted of the offense of
21	trafficking of persons shall be imprisoned in the state prison for a term of not more than 15 years, fined an
22	amount not to exceed \$50,000 in the amount of \$400,000, or both.
23	(b) A person convicted of the offense of trafficking of persons shall be imprisoned in the state
24	prison for a term of not more than 50 years, fined an amount not to exceed in the amount of \$100,000
25	\$400,000, or both, if the victim was a child.
26	(c) A person convicted of the offense of trafficking of persons shall be imprisoned in the state
27	prison for a term of not more than 25 years, fined an amount not to exceed \$75,000 in the amount of \$400,000,

(b) A person convicted of the offense of trafficking of persons shall be imprisoned in the state prison for a term of not more than 50 years, fined an amount not to exceed \$100,000, or both, if the victim was a child.

(c) A person convicted of the offense of trafficking of persons shall be imprisoned in the state prison for a term of not more than 25 years, fined an amount not to exceed \$75,000, or both, if the violation involves

"NEW SECTION. Section 19. Child sex trafficking. (1) A person commits the offense of child sex trafficking by purposely or knowingly:

- (a) committing the offense of sex trafficking with a child; or
- (b) recruiting, transporting, transferring, harboring, receiving, providing, obtaining, isolating, maintaining, enticing, or using a child for the purposes of commercial sexual activity.
- (2) (a) A person convicted of the offense of child sex trafficking shall be imprisoned in the state prison for a term of 100 years. The court may not suspend execution or defer imposition of the first 25 years of a sentence of imprisonment imposed under this subsection (2)(a) except as provided in 46-18-222(1) through (4). During the first 25 years of imprisonment, the offender is not eligible for parole. The exceptions provided in 46-18-222(5) and (6) do not apply.
  - (b) In addition to the sentence of imprisonment imposed under subsection (2)(a), the offender:
  - (i) must be fined in the amount of \$400,000; and

17	amount not to exceed \$75,000 The court may not suspend execution or defer imposition of the first 25 years of
18	a sentence of imprisonment imposed under this subsection (3)(a)(i) except as provided in 46-18-222, and
19	during the first 25 years of imprisonment the offender is not eligible for parole.
20	(ii) shall be fined in the amount of \$400,000; and
21	(iii) must be ordered to enroll in and successfully complete the educational phase and the cognitive
22	and behavioral phase of a sexual offender treatment program provided or approved by the department of
23	corrections.
24	(b) If the offender is released after the mandatory minimum period of imprisonment, the offender is
25	subject to supervision by the department of corrections for the remainder of the offender's life and shall
26	participate in the program for continuous, satellite-based monitoring provided for in 46-23-1010.
27	(4) It is not a defense in a prosecution under this section:
28	(a) that a child consented to engage in commercial sexual activity; or

18	addition to the period of imprisonment prescribed for the offense. An additional sentence prescribed by this
19	section must run consecutively to the sentence provided for the underlying offense A person convicted of the
20	offense of aggravated sex trafficking shall be imprisoned in the state prison for a term of not less than 5 years
21	or more than 40 years, fined in the amount of \$400,000, or both. The exceptions provided in 46-18-222(5) and
22	(6) do not apply."

24	NEW SECTION. Section 10. Effective date. [This act] is effective on passage and approval.
