14	planning and service areas to evaluate the current designated planning and service areas and make		
15	recommendati	ons for revising the boundaries of the areas to better serve older Montanans.	
16	(2)	The task force consists of 12 15 members appointed as follows:	
17	(a)	two members of the Montana senate appointed by the committee on committees, one from the	
18	majority party and one from the minority party;		
19	(b)	two members of the Montana house of representatives appointed by the speaker of the house,	
20	one from the majority party and one from the minority party; and		
21	(c)	additional members appointed by the director of the department or the director's designee to	
22	represent:		
23	(i)	two FOUR area agencies on aging, one with a service area that includes PRIMARILY SERVES
