18	(a) make rules for the government of its political party in each county not inconsistent with any of
19	the provisions of the election laws of this state or the rules of its state political party;
20	(b) elect two county members of the state central committee, one of each gender, elect the
21	members of the congressional committee, and fill all vacancies and make rules in their jurisdiction.
22	(2) If there is no county central committee, the state central committee shall appoint a county
23	central committee.
24	(3) MEETINGS OF A CENTRAL COMMITTEE THAT IS FILLING AN ELECTION VACANCY PURSUANT TO 13-10-
25	326 OR 13-10-327 MUST BE OPEN TO THE PUBLIC. RECORDS OF A CENTRAL COMMITTEE REGARDING FILLING A VACANCY
26	PURSUANT TO 13-10-326 OR 13-10-327 MUST BE MADE AVAILABLE FOR PUBLIC INSPECTION ON REQUEST.

3	Section 2. Section 13-38-205, MCA, is amended to read:
4	"13-38-205. Organization and operation of county and city central committee committees. (1)
5	The county central committee shall meet prior to the state convention of its political party and organize by
6	electing a presiding officer and one or more vice presiding officers. The gender of the presiding officer and the
7	vice presiding officer may not be the same. The county central committee shall elect a secretary and other
8	officers as necessary. It is not necessary for the officers to be precinct committee representatives.
9	(2) The committee may select managing or executive committees and authorize subcommittees to
10	exercise all powers conferred upon the county, city, state, and congressional central committees by the election
11	laws of this state.
12	(3) The presiding officer of the county central committee shall call the central committee meeting
13	county convention and not less than 4 days before the date of the central committee meeting county convention
14	shall publish the call in a newspaper published at the county seat and mail a copy of the call to each precinct
15	committee representative. If party rules permit the use of a proxy, a proxy may not be recognized unless it is
16	held by an elector of the precinct of the committee representative executing it.
17	(4) The county presiding officer of the party shall preside at the county convention. No person
18	other than a duly elected or appointed committee representative or officer of the committee is entitled to
19	participate in the proceedings of the committee.
20	(5) If a committee representative is absent, the convention may fill the vacancy by appointing some
21	qualified elector of the party, resident in the precinct, to represent the precinct in the convention.
22	(6) The county convention shall elect delegates and alternate delegates to the state convention
23	under rules of the state party. The presiding officer and secretary of the county convention shall issue and sign
24	certificates of election of the delegates."
