15	(1) There is an account in the state special revenue fund established by 17-2-102 known as the bond payoff	
16	account.	
17	(2)	The purpose of the bond payoff account is to:
18	(a)	pay the principal, interest, premiums, and any costs or fees associated with redeeming
19	outstanding bonds, notes, or other obligations that have been authorized and issued pursuant to the laws of thi	
20	state and that are currently subject to optional redemption;	
21	(b)	pay the principal, interest, premiums, and any costs or fees associated with defeasing
22	outstanding bonds, notes, or other obligations that have been authorized and issued pursuant to the laws of thi	
23	state that are not currently subject to optional redemption;	
24	(c)	purchase any obligations in subsection (2)(b) if it results in a net cost savings to the state;
25	(d)	pay administrative costs incurred by the state and any state agency to pay off debt after
26	completion of the purposes in subsection (2)(a) through (2)(c); and	
27	(e)	reimburse the state general fund through a fund transfer as provided in subsection (7).
28	(3)	Funds in the bond payoff account are subject to legislative appropriation to the office of budget
