12 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

14 **Section 1.** Section 1-1-201, MCA, is amended to read:

15 **"1-1-201. Terms of wide applicability.** (1) Unless the context requires otherwise, the following
16 definitions apply in the Montana Code Annotated:

17 (a) "Female" means a member of the human species that, under normal development, produces a
18 relatively large, relatively immobile gamete, or egg, during her life cycle and has a reproductive and endocrine
19 system oriented around the production of that gamete. An individual who cannot produce an egg due to a
20 condition at birth, but who has male sex chromosomes and nonambiguous internal genitalia is a female
21 member of the human species.

22 (b) "Male" means a member of the human species that, under normal development, produces
23 small, mobile gametes, or sperm, during his life cycle and has a reproductive and endocrine system oriented
24 around the production of that gamete. An individual who cannot produce sperm due to a condition at birth, but
25 who has female sex chromosomes and nonambiguous external genitalia is a male member of the human
26 species.

27 (a)(c) "Oath" includes an affirmation or declaration.

28 (b)(d) "Person" includes a corporation or other entity as well as a natural person.

1 ~~(e)~~(e) "Several" means two or more.

2 (f) "Sex" means the organization of the body and gametes for reproduction in human beings and
3 other organisms. In human beings, there are exactly two sexes, male and female, with two corresponding
4 gametes. The sexes are determined by the biological indication of male or female, including sex chromosomes,
5 gonads, and nonambiguous internal and external genitalia present at birth, without regard to an individual's
6 psychological, chosen, or subjective experience of gender. **The sex of an individual with a chromosomal**
7 **intersex condition or individual who cannot produce egg or sperm gametes due to a condition at birth must be**
8 **determined based on the most predominant physical characteristics observed a the time of birth.**

9 ~~(d)~~(g) "State", when applied to the different parts of the United States, includes the District of
10 Columbia and the territories.

11 ~~(e)~~(h) "United States" includes the District of Columbia and the territories.

12 (2) Wherever the word "man" or "men" or a word that includes the syllable "man" or "men" in
13 combination with other syllables, such as "workman", appears in this code, the word or syllable includes
14 "woman" or "women" unless the context clearly indicates a contrary intent and unless the subject matter of the
15 statute relates clearly and necessarily to a specific sex only.

16 (3) Whenever the term "heretofore" occurs in any statute, it must be construed to mean any time
17 previous to the day the statute takes effect. Whenever the word "hereafter" occurs, it must be construed to
18 mean the time after the statute containing the term takes effect."

20 **Section 2.** Section 2-18-208, MCA, is amended to read:

21 **"2-18-208. Comparable worth.** The department of administration shall, in its continuous efforts to
22 enhance the current classification plan and pay schedules, work toward the goal of establishing a standard of
23 equal pay for comparable worth. This standard for the classification plan shall be reached by:

24 (1) eliminating, in the classification of positions, the use of judgments and factors that contain
25 inherent biases based on sex, as defined in 1-1-201; and

26 (2) comparing, in the classification of positions, the factors for determining job worth across
27 occupational groups whenever those groups are dominated by males or females."

28

1 **Section 3.** Section 7-15-4207, MCA, is amended to read:

2 **"7-15-4207. Prohibition against discrimination.** For all of the purposes of this part and part 43, a
3 person may not be subjected to discrimination because of sex, as defined in 1-1-201, race, creed, religion, age,
4 physical or mental disability, color, or national origin."

5

6 **Section 4.** Section 7-34-2123, MCA, is amended to read:

7 **"7-34-2123. Admission to district hospital facilities.** Such a hospital district must admit persons to
8 its facilities without regard to race, color, or sex, as defined in 1-1-201. Such obligation shall not prevent the
9 board of trustees of such hospital district from establishing reasonable minimum rates for hospital quarters,
10 services, and supplies. Indigents needing such services, for the rendition of which provision is made by the
11 laws of Montana, must be admitted to such public hospitals on terms and rates prescribed or authorized by
12 law."

13

14 **Section 5.** Section 13-27-408, MCA, is amended to read:

15 **"13-27-408. Rejection of improper arguments.** The secretary of state shall reject, with the approval
16 of the attorney general, an argument or other matter held to contain obscene, vulgar, profane, scandalous,
17 libelous, or defamatory matter; any language that in any way incites, counsels, promotes, or advocates hatred,
18 abuse, violence, or hostility toward, or that tends to cast ridicule or shame upon, a group of persons by reason
19 of race, color, religion, or sex, as defined in 1-1-201; or any matter not allowed to be sent through the mail.
20 Such arguments may not be filed or printed in the voter information pamphlet."

21

22 **Section 6.** Section 13-35-301, MCA, is amended to read:

23 **"13-35-301. Adoption of code of fair campaign practices.** The following code of fair campaign
24 practices is adopted by Montana:

25 "There are basic principles of decency, honesty, and fair play that every candidate for public office in
26 the United States has a moral obligation to observe and uphold, in order that, after vigorously contested but
27 fairly conducted campaigns, our citizens may exercise their constitutional right to a free and untrammelled
28 choice and the will of the people may be fully and clearly expressed on the issues before the country.

1 Therefore:

2 I will conduct my campaign in the best American tradition, discussing the issues as I see them,
3 presenting my record and policies with sincerity and frankness, and criticizing without fear or favor the record
4 and policies of my opponent and my opponent's party that merit such criticism.

5 I will defend and uphold the right of every qualified American voter to full and equal participation in the
6 electoral process.

7 I will conduct my campaign without the use of personal vilification, character defamation, whispering
8 campaigns, libel, slander, or scurrilous attacks on my opposition or my opposition's personal or family life.

9 I will not use campaign material of any sort that misrepresents, distorts, or otherwise falsifies the facts,
10 nor will I use malicious or unfounded accusations that aim at creating or exploiting doubts, without justification,
11 as to the loyalty and patriotism of my opposition.

12 I will not make any appeal to prejudice based on race, sex, as defined in 1-1-201, creed, or national
13 origin.

14 I will not undertake or condone any dishonest or unethical practice that tends to corrupt or undermine
15 our American system of free elections or that hampers or prevents the full and free expression of the will of the
16 voters.

17 Insofar as is possible, I will immediately and publicly repudiate support deriving from any individual or
18 group that resorts, on behalf of my candidacy or in opposition to that of my opponent, to the methods and
19 tactics that I have pledged not to use or condone. ""

20

21 **Section 7.** Section 13-38-201, MCA, is amended to read:

22 **"13-38-201. Election or appointment of committee representatives at primary -- vacancies -- tie**
23 **votes.** (1) Each political party shall appoint or elect at each primary election one person of each sex, as defined
24 in 1-1-201, to serve as committee representatives for each election precinct. The committee representatives
25 must be residents and registered voters of the precinct.

26 (2) If a political party chooses to appoint precinct committee representatives, the political party
27 shall make the appointments as provided in the party's rules.

28 (3) If a political party chooses to elect precinct committee representatives, the party may:

- 1 (a) administer the election itself as provided in the party's rules; or
- 2 (b) elect precinct committee representatives in a primary election, subject to 13-10-209 and
- 3 subsection (4) of this section.
- 4 (4) In a primary election for a precinct committee representative:
- 5 (a) if the number of candidates nominated for a party's precinct committee representatives is less
- 6 than or equal to the number of positions to be elected, the election administrator may give notice that a party's
- 7 precinct committee election will not be held in that precinct;
- 8 (b) if a party precinct committee election is not held pursuant to subsection (4)(a), the election
- 9 administrator shall declare elected by acclamation the candidate who filed for the position or who filed a
- 10 declaration of intent to be a write-in candidate. The election administrator shall issue a certificate of election to
- 11 the designated party.
- 12 (c) write-in votes for a precinct committee representative may be counted as specified in 13-15-
- 13 206(5) only if the individual whose name is written in has filed a declaration of intent as a write-in candidate by
- 14 the deadline prescribed in 13-10-211(1);
- 15 (d) in the case of a tie vote for a precinct committee representative position, the county central
- 16 committee shall determine a winner.
- 17 (5) Pursuant to 13-38-101, a vacancy in a precinct committee representative position must be filled
- 18 by the party governing body as provided in its rules."

19

20 **Section 8.** Section 20-7-1306, MCA, is amended to read:

21 **"20-7-1306. (Temporary) Designation of athletic teams.** (1) Interscholastic, intercollegiate,

22 intramural, or club athletic teams or sports that are sponsored by a public elementary or high school, a public

23 institution of higher education, or any school or institution whose students or teams compete against a public

24 school or institution of higher education must be expressly designated as one of the following based on

25 biological sex:

- 26 (a) males, men, or boys;
- 27 (b) females, women, or girls; or
- 28 (c) coed or mixed.

1 (2) Athletic teams or sports designated for females, women, or girls may not be open to students of
2 the male sex. (Void on occurrence of contingency--sec. 6, Ch. 405, L. 2021.)

3 (3) For the purposes of this section, "female", "male", and "sex" are defined in 1-1-201."
4

5 **Section 9.** Section 20-9-327, MCA, is amended to read:

6 **"20-9-327. Quality educator payment.** (1) (a) The state shall provide a quality educator payment to:

- 7 (i) public school districts, as defined in 20-6-101 and 20-6-701;
- 8 (ii) special education cooperatives, as described in 20-7-451;
- 9 (iii) the Montana school for the deaf and blind, as described in 20-8-101;
- 10 (iv) correctional facilities, as defined in 41-5-103; and
- 11 (v) the Montana youth challenge program.

12 (b) A special education cooperative that has not met the requirements of 20-7-454 may not be
13 funded under the provisions of this section except by approval of the superintendent of public instruction.

14 (2) (a) The quality educator payment for special education cooperatives must be distributed
15 directly to those entities by the superintendent of public instruction.

16 (b) The quality educator payment for the Montana school for the deaf and blind must be distributed
17 to the Montana school for the deaf and blind.

18 (c) The quality educator payment for Pine Hills correctional facility and the facility under contract
19 with the department of corrections for female, as defined in 1-1-201, youth must be distributed to those facilities
20 by the department of corrections.

21 (d) The quality educator payment for the Montana youth challenge program must be distributed to
22 that program by the department of military affairs.

23 (3) The quality educator payment is calculated as provided in 20-9-306, using the number of full-
24 time equivalent educators, as reported to the superintendent of public instruction for accreditation purposes in
25 the previous school year, each of whom:

26 (a) holds a valid certificate under the provisions of 20-4-106 and is employed by an entity listed in
27 subsection (1) of this section in a position that requires an educator license in accordance with the
28 administrative rules adopted by the board of public education;

- 1 (b) (i) is a licensed professional under 37-8-405, 37-8-415, 37-11-301, 37-15-301, 37-17-302, 37-
2 22-301, 37-23-201, 37-24-301, or 37-25-302; and
- 3 (ii) is employed by an entity listed in subsection (1) to provide services to students; or
- 4 (c) (i) holds an American Indian language and culture specialist license; and
- 5 (ii) is employed by an entity listed in subsection (1) to provide services to students in an Indian
6 language immersion program pursuant to Title 20, chapter 7, part 14."

7

8 **Section 10.** Section 20-25-501, MCA, is amended to read:

9 **"20-25-501. Definitions.** (1) Terms used in this part are defined as follows:

- 10 (a) "Domicile" means a person's true, fixed, and permanent home and place of habitation.
- 11 (b) "Minor" means a male or female, as defined in 1-1-201, person who has not obtained the age
12 of 18 years.
- 13 (c) "Qualified person" means a person legally qualified to determine the person's own domicile.
- 14 (d) "Resident student" means:
- 15 (i) a student who has been domiciled in Montana for 1 year immediately preceding registration at
16 any unit for any term or session for which resident classification is claimed. Attendance as a full-time student at
17 any college, university, or other institution of higher education is not alone sufficient to qualify for residence in
18 Montana.
- 19 (ii) any graduate of a Montana high school who is a citizen or resident alien of the United States
20 and whose parents, parent, or guardian has resided in Montana at least 1 full year of the 2 years immediately
21 preceding the student's graduation from high school. The classification continues for not more than 4 academic
22 years if the student remains in continuous attendance at a unit; or
- 23 (iii) a member of the armed forces of the United States assigned to and residing in Montana, the
24 member's spouse, or the member's dependent children.
- 25 (2) In the event that the definition of residency or any portion of the definition is declared
26 unconstitutional as it is applied to payment of nonresident fees and tuition, the regents of the Montana
27 university system may make rules on what constitutes adequate evidence of residency status not inconsistent
28 with those court decisions."

Section 11. Section 20-25-707, MCA, is amended to read:

"20-25-707. Antidiscrimination. An employer is not eligible to employ any person under this program if the employer practices discrimination in employment against any individual because of race, creed, religion, color, political ideas, sex, as defined in 1-1-201, age, marital status, physical or mental disability, ancestry, or national origin."

Section 12. Section 22-2-306, MCA, is amended to read:

"22-2-306. Grant conditions -- additional funds -- accounts and reports. (1) A grant may not be awarded unless the grantee accepts the Montana arts council's conditions of the grant and signs a contract stipulating those conditions.

(2) A grantee must agree in writing that:

(a) the grantee is the official and sole agency for the administration of the project described in the grant agreement; and

(b) no person will, on the grounds of race, color, national origin, sex, as defined in 1-1-201, or age, be excluded from participation in, be denied the benefits of, or be subjected to discrimination under any program or activity that results from the expenditure of grant funds.

(3) The grantee must agree that the funds granted will be expended solely for the purpose and activities described in the approved proposal. All funds granted to the grantee must be spent or encumbered during the grant period.

(4) Disbursements to grantees must be as follows, based upon the cash flow needs of the projects and the revenues available:

(a) Projects that are to receive more than \$10,000 may receive an amount not exceeding 25% of the grant award in the first 6 months of the biennium, 50% in the first year of the biennium, 75% in the first 18 months of the biennium, and the balance in the remainder of the biennium. Within the limitations contained in this subsection, the amount of each payment must be determined by the Montana arts council in its discretion. Each payment may be made only after an examination of the costs incurred in the project and the amount, if any, of the unencumbered or unexpended balance of prior grant payments for the project.

1 (b) Projects that are to receive \$10,000 or less may receive the total grant in any fiscal quarter if
2 the Montana arts council determines that the cultural and aesthetic project account has funds available and
3 that, after an examination of the costs incurred by the project, total payment is appropriate.

4 (c) A grant award budget may be modified in accordance with this subsection. A grantee may
5 modify line items in an approved budget in an amount not to exceed 10% of the total grant award. A grantee
6 may, with permission of the Montana arts council, modify line items in an approved budget in an amount not to
7 exceed 20% of the total grant award. A modification may not increase the grant award or change the scope or
8 purpose of the award.

9 (5) The grantee must maintain accounts, records, and other pertinent material pertaining to the
10 costs incurred and expenditures made under the grant. The system of accounting employed by the grantee
11 must be in accordance with generally accepted accounting principles and be applied in a consistent manner so
12 that project costs and expenditures can be clearly identified. Accounts, records, and other pertinent material
13 must be maintained for 3 years from the official termination date of the grant period or until an audit, approved
14 by the council, has been completed and any questions arising from the audit have been resolved to the
15 satisfaction of the council.

16 (6) Grantees must submit to the council semiannual reports of expenditures during the course of
17 the project and other financial and descriptive reports that the council may require. The grantee must submit,
18 within 30 days after completion of the project, a final financial report and a narrative report stating what was
19 accomplished with the grant. Five percent of the total grant award must be held pending receipt of final reports
20 by the council. With regard to grantees who in the past have submitted late reports, 30% of the grant award
21 may be held pending receipt of final reports by the council.

22 (7) The council may, at the principal place of business of the grantee and during regular business
23 hours, examine any directly pertinent records, accounts, and documents of the grantee involving transactions
24 related to the grant."

26 **Section 13.** Section 33-1-201, MCA, is amended to read:

27 **"33-1-201. Definitions -- insurance in general -- general terms.** For the purposes of this code, the
28 following definitions apply unless the context requires otherwise:

1 (1) "Alien insurer" is an insurer formed under the laws of any country other than the United States
2 or its states, districts, territories, and commonwealths.

3 (2) "Authorized insurer" is an insurer duly authorized by a certificate of authority issued by the
4 commissioner to transact insurance in this state.

5 (3) "Domestic insurer" is an insurer incorporated under the laws of this state.

6 (4) "Female" has the meaning provided in 1-1-201.

7 ~~(4)~~(5) "Foreign insurer" is an insurer formed under the laws of any jurisdiction other than this state.

8 Except when distinguished by context, the term includes an alien insurer.

9 ~~(5)~~(6) (a) "Insurance" is a contract through which one undertakes to indemnify another or pay or
10 provide a specified or determinable amount or benefit upon determinable contingencies.

11 (b) The term does not include:

12 (i) contracts for the installation, maintenance, and provision of inside telecommunications wiring to
13 residential or business premises;

14 (ii) direct patient care agreements established pursuant to 50-4-107; or

15 (iii) an arrangement with a health care sharing ministry that meets the requirements of 50-4-111.

16 ~~(6)~~(7) (a) "Insurer" includes every person engaged as indemnitor, surety, or contractor in the business
17 of entering into contracts of insurance. The term also includes a health service corporation in the provisions
18 listed in 33-30-102.

19 (b) The term does not include a health care sharing ministry that meets the requirements of 50-4-
20 111.

21 (8) "Male" has the meaning provided in 1-1-201.

22 ~~(7)~~(9) "Resident domestic insurer" is an insurer incorporated under the laws of this state and:

23 (a) if a mutual company, not less than one-half of the policyholders are individuals who are
24 residents of this state; or

25 (b) if a stock insurer, not less than one-half of the shares are owned by individuals who are
26 residents of this state and all of the directors and officers of the insurer are residents of this state.

27 (10) "Sex" has the meaning provided in 1-1-201.

28 ~~(8)~~(11) "State", when used in relation to jurisdiction, means a state, the District of Columbia, or a

1 territory, commonwealth, or possession of the United States.

2 ~~(9)~~(12) "Transact", with respect to insurance, means to:

3 (a) solicit;

4 (b) negotiate;

5 (c) sell or effectuate a contract of insurance; or

6 (d) transact matters subsequent to effectuation of the contract of insurance and arising out of it.

7 ~~(10)~~(13) "Unauthorized insurer" is an insurer not authorized by a certificate of authority issued by the
8 commissioner to transact insurance in this state."

9

10 **Section 14.** Section 35-20-209, MCA, is amended to read:

11 **"35-20-209. Duties of secretary -- record of interments.** The secretary shall perform all the duties
12 of a secretary of a corporation and shall, in addition, keep a record of interments in which the secretary shall
13 enter as correctly and carefully as may be the name, age, sex, as defined in 1-1-201, place of birth, and cause
14 of death with date of burial of every person interred in the cemetery. The secretary shall procure these facts
15 from friends or relatives of the deceased or the undertaker that gives the order for interment at that time or, if
16 the deceased is a pauper, a stranger, or criminal, from the coroner, physician, or other public officer directing
17 the burial of the deceased."

18

19 **Section 15.** Section 39-2-912, MCA, is amended to read:

20 **"39-2-912. Exemptions.** (1) This part does not apply to a discharge:

21 (a) that is subject to any other state or federal statute that provides a procedure or remedy for
22 contesting the dispute. The statutes include those that prohibit discharge for filing complaints, charges, or
23 claims with administrative bodies or that prohibit unlawful discrimination based on race, national origin, sex, as
24 defined in 1-1-201, age, disability, creed, religion, political belief, color, marital status, and other similar
25 grounds.

26 (b) of an employee covered by a written collective bargaining agreement or a written contract of
27 employment for a specific term.

28 (2) For the purposes of this section, a contract for a specific term may contain a probationary

1 period as provided for in 39-2-910 and may contain an automatic renewal clause that automatically renews the
2 contract of employment for one or more successive terms."

3

4 **Section 16.** Section 40-1-107, MCA, is amended to read:

5 **"40-1-107. Form of application, license, marriage certificate, and consent.** (1) The director of the
6 department of public health and human services shall prescribe the form for an application for a marriage
7 license, which must include the following information:

8 (a) name, sex, as defined in 1-1-201, address, [social security number,] and date and place of birth
9 of each party to the proposed marriage;

10 (b) if either party was previously married, the party's name and the date, place, and court in which
11 the marriage was dissolved or declared invalid or the date and place of death of the former spouse;

12 (c) name and address of the parents or guardian of each party; and

13 (d) whether the parties are related to each other and, if so, their relationship.

14 (2) The director of the department of public health and human services shall prescribe the forms
15 for the marriage license, the marriage certificate, and the consent to marriage.

16 [(3) The license, certificate, or consent may not contain the social security number, and the
17 department shall keep the number from this source confidential, except that the department may use the
18 number in administering Title IV-D of the Social Security Act.]

19 (4) The information contained in the marriage license application is subject to the disclosure
20 restrictions provided in 50-15-122(5). (Bracketed language terminates on occurrence of contingency--sec. 1,
21 Ch. 27, L. 1999.)"

22

23 **Section 17.** Section 40-1-401, MCA, is amended to read:

24 **"40-1-401. Prohibited marriages -- contracts.** (1) The following marriages are prohibited:

25 (a) a marriage entered into prior to the dissolution of an earlier marriage of one of the parties;

26 (b) a marriage between an ancestor and a descendant or between a brother and a sister, whether
27 the relationship is by the half or the whole blood, or between first cousins;

28 (c) a marriage between an uncle and a niece or between an aunt and a nephew, whether the

1 relationship is by the half or the whole blood;

2 (d) a marriage between persons of the same sex, as defined in 1-1-201.

3 (2) Parties to a marriage prohibited under this section who cohabit after removal of the impediment
4 are lawfully married as of the date of the removal of the impediment.

5 (3) Children born of a prohibited marriage are legitimate.

6 (4) A contractual relationship entered into for the purpose of achieving a civil relationship that is
7 prohibited under subsection (1) is void as against public policy."

8

9 **Section 18.** Section 40-5-907, MCA, is amended to read:

10 **"40-5-907. Case registry -- abstracts -- information required -- mandatory updating.** (1) There
11 must be registered in the case registry an abstract of:

12 (a) each case, including interstate cases, receiving IV-D services provided by the department;

13 (b) each support order entered and each modification of an existing support order made in this
14 state after October 1, 1998; and

15 (c) each subsequent order or action establishing, modifying, adjusting, granting relief from,
16 terminating, or otherwise affecting a support order in a registered case.

17 (2) Each abstract must include:

18 (a) the name, sex, as defined in 1-1-201, [social security number, other] identification numbers, if
19 any, date of birth, driver's license number, telephone number, and residential and mailing addresses of the
20 parents;

21 (b) the child's name, date of birth, sex, as defined in 1-1-201, [social security number, if any,] and
22 residential address if different from that of the child's custodian;

23 (c) the name and location of the obligee if the obligee is a person or agency other than the child's
24 parent;

25 (d) the name, address, and telephone number of the obligor's employer or of another payor of
26 income to the obligor; and

27 (e) (i) if the child is covered by a health or medical insurance plan and the information is available
28 in an electronic format, the name of the insurance carrier or health benefit plan, the policy identification number,

- 1 the name of the persons covered, and any other pertinent information regarding coverage; or
- 2 (ii) if the child is not covered, information as to the availability of coverage for the child through the
- 3 obligor's and obligee's employers.
- 4 (3) The abstract of a support order must include:

(6) (a) "Correctional facility" means a public secure residential facility or a private secure residential facility under contract with the department and operated to provide for the custody, treatment, training, and rehabilitation of:

(i) formally adjudicated delinquent youth;

(ii) convicted adult offenders or criminally convicted youth; or

(iii) a combination of the populations described in subsections (6)(a)(i) and (6)(a)(ii) under conditions set by the department in rule.

(b) The term does not include a state prison as defined in 53-30-101.

(7) "Cost containment pool" means an account from which funds are allocated by the office of court administrator under 41-5-132 to a judicial district that exceeds its annual allocation for juvenile out-of-home placements, programs, and services or to the department for costs incurred under 41-5-1504.

(8) "Cost containment review panel" means the panel established in 41-5-131.

(9) "Court", when used without further qualification, means the youth court of the district court.

(10) "Criminally convicted youth" means a youth who has been convicted in a district court pursuant to 41-5-206.

(11) (a) "Custodian" means a person, other than a parent or guardian, to whom legal custody of the

1 youth has been given.

2 (b) The term does not include a person who has only physical custody.

3 (12) "Delinquent youth" means a youth who is adjudicated under formal proceedings under the

6 (27) "Judge", when used without further qualification, means the judge of the youth court.

7 (28) "Juvenile home arrest officer" means a court-appointed officer administering or supervising
8 juveniles in a program for home arrest, as provided for in Title 46, chapter 18, part 10.

9 (29) "Law enforcement records" means information or data, either in written or electronic form,
10 maintained by a law enforcement agency, as defined in 7-32-201, pertaining to a youth covered by this chapter.

11 (30) (a) "Legal custody" means the legal status created by order of a court of competent jurisdiction
12 that gives a person the right and duty to:

13 (i) have physical custody of the youth;

14 (ii) determine with whom the youth shall live and for what period;

15 (iii) protect, train, and discipline the youth; and

16 (iv) provide the youth with food, shelter, education, and ordinary medical care.

17 (b) An individual granted legal custody of a youth shall personally exercise the individual's rights

20 WESTERN INTERSTATE CORRECTIONS COMPACT

21 Article I. Purpose and Policy

22 The party states, desiring by common action to improve their institutional facilities and provide
23 programs of sufficiently high quality for the confinement, treatment, and rehabilitation of various types of
24 offenders, declare that it is the policy of each of the party states to provide such facilities and programs on the
25 basis of cooperation with one another, thereby serving the best interests of such offenders and of society. The
26 purpose of this compact is to provide for the development and execution of such programs of cooperation for
27 the confinement, treatment, and rehabilitation of offenders.

28 Article II. Definitions

1 As used in this compact, unless the context clearly requires otherwise:

2 (1) "state" means a state of the United States or, subject to the limitation contained in Article VII,

3 Guam;

4 (2) "sending state" means a state party to this compact in which conviction was had;

5 (3) "receiving state" means a state party to this compact to which an inmate is sent for confinement
6 other than a state in which conviction was had;

7 (4) "inmate" means a male or female, as defined in 1-1-201, offender who is under sentence to or
8 confined in a prison or other correctional institution;

9 (5) "institution" means any prison, reformatory, or other correctional facility (including but not
10 limited to a facility for the mentally ill or mentally defective) in which inmates may lawfully be confined.

11 Article III. Contracts

12 (1) Each party state may make one or more contracts with any one or more of the other party
13 states for the confinement of inmates on behalf of a sending state in institutions situated within receiving states.

14 Any such contract shall provide for:

15 (a) its duration;

16 (b) payments to be made to the receiving state by the sending state for inmate maintenance,
17 extraordinary medical and dental expenses, and any participation in or receipt by inmates of rehabilitative or
18 correctional services, facilities, programs, or treatment not reasonably included as part of normal maintenance;

19 (c) participation in programs of inmate employment, if any; the disposition or crediting of any
20 payments received by inmates on account thereof; and the crediting of proceeds from or disposal of any
21 products resulting therefrom;

22 (d) delivery and retaking of inmates;

23 (e) such other matters as may be necessary and appropriate to fix the obligations, responsibilities,
24 and rights of the sending and receiving states.

25 (2) Prior to the construction or completion of construction of any institution or addition thereto by a
26 party state, any other party state or states may contract therewith for the enlargement of the planned capacity
27 of the institution or addition thereto, or for the inclusion therein of particular equipment or structures, and for the
28 reservation of a specific percent of the capacity of the institution to be kept available for use by inmates of the

1 sending state or states so contracting. Any sending state so contracting may, to the extent that moneys are
2 legally available therefor, pay to the receiving state a reasonable sum as consideration for such enlargement of
3 capacity or provision of equipment or structures and reservation of capacity. Such payment may be in a lump
4 sum or in installments as provided in the contract.

5 (3) The terms and provisions of this compact shall be a part of any contract entered into by the
6 authority of or pursuant thereto, and nothing in any such contract shall be inconsistent therewith.

7 Article IV. Procedures and Rights

8 (1) Whenever the duly constituted judicial or administrative authorities in a state party to this
9 compact, and which has entered into a contract pursuant to Article III, shall decide that confinement in or
10 transfer of an inmate to an institution within the territory of another party state is necessary in order to provide
11 adequate quarters and care or desirable in order to provide an appropriate program of rehabilitation or
12 treatment, said officials may direct that the confinement be within an institution within the territory of said other

7 (i) "HIV" means the human immunodeficiency virus identified as the causative agent of acquired
8 immunodeficiency syndrome (AIDS) and includes all HIV and HIV-related viruses that damage the cellular
9 branch of the human immune or neurological system and leave the infected person immunodeficient or
10 neurologically impaired.

11 (ii) "HIV-related condition" means any medical condition resulting from an HIV infection, including
12 but not limited to seropositivity for HIV.

13 (3) A person who operates a facility may not discriminate among the patients of licensed
14 physicians. The free and confidential professional relationship between a licensed physician and patient must
15 continue and remain unaffected.

16 (4) Except for a hospital that employs its medical staff, a hospital considering an application for
17 staff membership or granting privileges within the scope of the applicant's license may not deny the application
18 or privileges because the applicant is licensed under Title 37, chapter 6."

9 that exceeds 20% of the cost of the alterations to a primary function area.

10 (b) If the cost of altering a path of travel to an altered primary function area is disproportionate as
11 provided in subsection (2)(a), the path of travel must be made accessible to the extent possible without
12 incurring disproportionate costs. The alterations to the path of travel must be made by providing, in the following
13 order or priority:

14 (i) an accessible entrance and accessible exterior route to the accessible entrance from
15 accessible parking and passenger loading zones or from a public sidewalk if the public sidewalk is immediately

17 (ii) an accessible path of travel to the altered primary function area;

18 (iii) accessible restrooms for each sex, as defined in 1-1-201, or a single unisex restroom when
19 allowed by the applicable building code; and

20 (iv) accessible elements, including but not limited to storage spaces and alarms.

21 (3) A person or entity subject to the provisions of this section is also subject to the provisions of 50-
22 60-213(5)(a) and (5)(b)."

24 **Section 35.** Section 53-20-142, MCA, is amended to read:

25 **"53-20-142. Rights while in residential facility.** Persons admitted to a residential facility for a period
26 of habilitation have the following rights:

27 (1) Residents have a right to dignity, privacy, and humane care.

28 (2) Residents are entitled to send and receive sealed mail. Moreover, it is the duty of the facility to

1 foster the exercise of this right by furnishing the necessary materials and assistance.

2 (3) Residents must have the same rights and access to private telephone communication as
3 patients at any public hospital except to the extent that the individual treatment planning team or the qualified
4 intellectual disability professional responsible for formulation of a particular resident's habilitation plan writes an
5 order imposing special restrictions and explains the reasons for the restrictions. The written order must be
6 renewed monthly if any restrictions are to be continued.

7 (4) Residents have an unrestricted right to visitation except to the extent that the individual
8 treatment planning team or the qualified intellectual disability professional responsible for formulation of a
9 particular resident's habilitation plan writes an order imposing special restrictions and explains the reasons for
10 the restrictions. The written order must be renewed monthly if restrictions are to be continued.

11 (5) Residents have a right to receive suitable educational and habilitation services regardless of
12 chronological age, degree of intellectual disability, or accompanying disabilities.

13 (6) Each resident must have an adequate allowance of neat, clean, suitably fitting, and seasonable
14 clothing. Except when a particular kind of clothing is required because of a particular condition, residents must
15 have the opportunity to select from various types of neat, clean, and seasonable clothing. The clothing must be
16 considered the resident's throughout the resident's stay in the facility. Clothing, both in amount and type, must
17 make it possible for residents to go out of doors in inclement weather, to go for trips or visits appropriately
18 dressed, and to make a normal appearance in the community. The facility shall make provision for the
19 adequate and regular laundering of the residents' clothing.

20 (7) Each resident has the right to keep and use the resident's own personal possessions except
21 insofar as the clothes or personal possessions may be determined by the individual treatment planning team or
22 the qualified intellectual disability professional to be dangerous either to the resident or to others.

23 (8) Each resident has a right to a humane physical environment within the residential facility. The
24 facility must be designed to make a positive contribution to the efficient attainment of the habilitation goals of
25 the resident. To accomplish this purpose:

26 (a) regular housekeeping and maintenance procedures that will ensure that the facility is
27 maintained in a safe, clean, and attractive condition must be developed and implemented;

28 (b) pursuant to an established routine maintenance and repair program, the physical plant must be

1 kept in a continuous state of good repair and operation so as to ensure the health, comfort, safety, and well-
2 being of the residents and so as not to impede in any manner the habilitation programs of the residents;

3 (c) the physical facilities must meet all fire and safety standards established by the state and
4 locality. In addition, the facility must meet the provisions of the life safety code of the national fire protection
5 association that are applicable to it.

6 (d) there must be special facilities for nonambulatory residents to ensure their safety and comfort,
7 including special fittings on toilets and wheelchairs. Appropriate provision must be made to permit
8 nonambulatory residents to communicate their needs to staff.

9 (9) Residents have a right to receive prompt and adequate medical treatment for any physical or
10 mental ailments or injuries or physical disabilities and for the prevention of any illness or disability. The medical
11 treatment must meet standards of medical practice in the community. However, nothing in this subsection may
12 be interpreted to impair other rights of a resident in regard to involuntary commitment for mental illness, use of
13 psychotropic medication, use of hazardous, aversive, or experimental procedures, or the refusal of treatment.

14 (10) Corporal punishment is not permitted.

15 (11) The opportunity for religious worship must be accorded to each resident who desires worship.
16 Provisions for religious worship must be made available to all residents on a nondiscriminatory basis. An
17 individual may not be compelled to engage in any religious activities.

18 (12) Residents have a right to a nourishing, well-balanced diet. The diet for residents must provide
19 at a minimum the recommended daily dietary allowance as developed by the national academy of sciences.
20 Provisions must be made for special therapeutic diets and for substitutes at the request of the resident, the
21 resident's parents, guardian, or next of kin, or the responsible person appointed by the court in accordance with
22 the religious requirements of any resident's faith. Denial of a nutritionally adequate diet may not be used as
23 punishment.

24 (13) Residents have a right to regular physical exercise several times a week. It is the duty of the
25 facility to provide both indoor and outdoor facilities and equipment for exercise. Residents have a right to be
26 outdoors daily in the absence of contrary medical considerations.

27 (14) Residents have a right, under appropriate supervision, to suitable opportunities for the
28 interaction with members of the opposite sex, as defined in 1-1-201, except when the individual treatment

1 planning team or the qualified intellectual disability professional responsible for the formulation of a particular
2 resident's habilitation plan writes an order to the contrary and explains the reasons for the order. The order
3 must be renewed monthly if the restriction is to be continued."

5 **Section 36.** Section 53-21-121, MCA, is amended to read:

6 **"53-21-121. Petition for commitment -- contents of -- notice of.** (1) The county attorney, upon the
7 written request of any person having direct knowledge of the facts, may file a petition with the court alleging that
8 there is a person within the county who is suffering from a mental disorder and who requires commitment
9 pursuant to this chapter.

10 (2) The petition must contain:

11 (a) the name and address of the person requesting the petition and the person's interest in the
12 case;

13 (b) the name of the respondent and, if known, the address, age, sex, as defined in 1-1-201, marital
14 status, and occupation of the respondent;

15 (c) the purported facts supporting the allegation of mental disorder, including a report by a mental
16 health professional if any, a statement of the disposition sought pursuant to 53-21-127, and the need for
17 commitment;

18 (d) the name and address of every person known or believed to be legally responsible for the care,
19 support, and maintenance of the respondent for whom evaluation is sought;

20 (e) the name and address of the respondent's next of kin to the extent known to the county
21 attorney and the person requesting the petition;

22 (f) the name and address of any person whom the county attorney believes might be willing and
23 able to be appointed as friend of respondent;

24 (g) the name, address, and telephone number of the attorney, if any, who has most recently
25 represented the respondent for whom evaluation is sought; if there is no attorney, there must be a statement as
26 to whether to the best knowledge of the person requesting the petition the respondent for whom evaluation is
27 sought is indigent and unable to afford the services of an attorney;

28 (h) a statement of the rights of the respondent, which must be in conspicuous print and identified

1 by a suitable heading; and

2 (i) the name and address of the mental health facility to which it is proposed that the respondent
3 may be committed, if known.

4 (3) Notice of the petition must be hand-delivered to the respondent and to the respondent's
5 counsel on or before the initial appearance of the respondent before the judge or justice of the peace. The
6 respondent's counsel shall meet with the respondent, explain the substance of the petition, and explain the
7 probable course of the proceedings. Notice of the petition and the order setting the date and time of the hearing
8 and the names of the respondent's counsel, professional person, and friend of respondent must be hand-
9 delivered, mailed, or sent by a facsimile transmission to the person or persons legally responsible for care,
10 support, and maintenance of the respondent, the next of kin identified in the petition, any other person identified
11 by the county attorney as a possible friend of respondent other than the one named as the friend of respondent,
12 the director of the department or the director's designee, and the mental health facility to which the respondent
13 may be committed, if known. The notice may provide, other than as to the respondent and the respondent's
14 counsel, that no further notice will be given unless written request is filed with the clerk of court."

16 **Section 37.** Section 53-21-142, MCA, is amended to read:

17 **"53-21-142. Rights of persons admitted to facility.** Patients admitted to a mental health facility,
18 whether voluntarily or involuntarily, have the following rights:

19 (1) Patients have a right to privacy and dignity.

20 (2) Patients have a right to the least restrictive conditions necessary to achieve the purposes of
21 commitment. Patients must be accorded the right to appropriate treatment and related services in a setting and
22 under conditions that:

23 (a) are the most supportive of the patient's personal liberty; and

24 (b) restrict the patient's liberty only to the extent necessary and consistent with the patient's
25 treatment need, applicable requirements of law, and judicial orders.

26 (3) Patients have rights to visitation and reasonable access to telephone communications,
27 including the right to converse with others privately, except to the extent that the professional person
28 responsible for formulation of a particular patient's treatment plan writes an order imposing special restrictions.

1 The written order must be renewed after each periodic review of the treatment plan if any restrictions are to be
2 continued. Patients have an unrestricted right to visitation with attorneys, with spiritual counselors, and with
3 private physicians and other professional persons.

4 (4) Patients have an unrestricted right to send sealed mail. Patients have an unrestricted right to
5 receive sealed mail from their attorneys, private physicians and other professional persons, the mental
6 disabilities board of visitors, courts, and government officials. Patients have a right to receive sealed mail from
7 others except to the extent that a professional person responsible for formulation of a particular patient's
8 treatment plan writes an order imposing special restrictions on receipt of sealed mail. The written order must be
9 renewed after each periodic review of the treatment plan if any restrictions are to be continued.

10 (5) Patients have an unrestricted right to have access to letter-writing materials, including postage,
11 and have a right to have staff members of the facility assist persons who are unable to write, prepare, and mail
12 correspondence.

13 (6) Patients have a right to wear their own clothes and to keep and use their own personal
14 possessions, including toilet articles, except to the extent that clothes or personal possessions may be
15 determined by a professional person in charge of the patient's treatment plan to be dangerous or otherwise
16 inappropriate to the treatment regimen. The facility has an obligation to supply an adequate allowance of
17 clothing to any patients who do not have suitable clothing of their own. Patients must have the opportunity to
18 select from various types of neat, clean, and seasonable clothing. The clothing must be considered the patient's
19 throughout the patient's stay at the facility. The facility shall make provision for the laundering of patient
20 clothing.

21 (7) Patients have the right to keep and be allowed to spend a reasonable sum of their own money.

22 (8) Patients have the right to religious worship. Provisions for worship must be made available to
23 all patients on a nondiscriminatory basis. An individual may not be required to engage in any religious activities.

24 (9) Patients have a right to regular physical exercise several times a week. The facility shall
25 provide facilities and equipment for physical exercise. Patients have a right to be outdoors at regular and
26 frequent intervals in the absence of contrary medical considerations.

27 (10) Patients have the right to be provided, with adequate supervision, suitable opportunities for
28 interaction with members of the opposite sex, as defined in 1-1-201, except to the extent that a professional

1 person in charge of the patient's treatment plan writes an order stating that the interaction is inappropriate to the
2 treatment regimen.

3 (11) Patients have a right to receive prompt and adequate medical treatment for any physical
4 ailments. In providing medical care, the mental health facility shall take advantage of whatever community-
5 based facilities are appropriate and available and shall coordinate the patient's treatment for mental illness with
6 the patient's medical treatment.

7 (12) Patients have a right to a diet that will provide at a minimum the recommended daily dietary
8 allowances as developed by the national academy of sciences. Provisions must be made for special
9 therapeutic diets and for substitutes at the request of the patient or the friend of respondent in accordance with
10 the religious requirements of any patient's faith. Denial of a nutritionally adequate diet may not be used as
11 punishment.

12 (13) Patients have a right to a humane psychological and physical environment within the mental
13 health facilities. These facilities must be designed to afford patients with comfort and safety, promote dignity,
14 and ensure privacy. The facilities must be designed to make a positive contribution to the efficient attainment of
15 the treatment goals set for the patient. In order to ensure the accomplishment of this goal:

16 (a) regular housekeeping and maintenance procedures that will ensure that the facility is
17 maintained in a safe, clean, and attractive condition must be developed and implemented;

18 (b) there must be special provision made for geriatric and other nonambulatory patients to ensure
19 their safety and comfort, including special fittings on toilets and wheelchairs. Appropriate provision must be
20 made to permit nonambulatory patients to communicate their needs to the facility staff.

21 (c) pursuant to an established routine maintenance and repair program, the physical plant of each
22 facility must be kept in a continuous state of good repair and operation in accordance with the needs of the
23 health, comfort, safety, and well-being of the patients;

24 (d) each facility must meet all fire and safety standards established by the state and locality. In
25 addition, any hospital must meet the provisions of the life safety code of the national fire protection association
26 that are applicable to hospitals. A hospital must meet all standards established by the state for general
27 hospitals to the extent that they are relevant to psychiatric facilities.

28 (14) A patient at a facility has the right:

1 (a) to be informed of the rights described in this section at the time of admission and periodically
2 after admission in language and terms appropriate to the patient's condition and ability to understand;

3 (b) to assert grievances with respect to infringement of the rights described in this section,
4 including the right to have a grievance considered in a fair and timely manner according to an impartial
5 grievance procedure that must be provided for by the facility; and

6 (c) to exercise the rights described in this section without reprisal and may not be denied
7 admission to the facility as reprisal for the exercise of the rights described in this section.

8 (15) In order to assist a person admitted to a program or facility in the exercise or protection of the
9 patient's rights, the patient's attorney, advocate, or legal representatives must be given reasonable access to:

10 (a) the patient;

11 (b) the program or facility areas where the patient has received treatment or has resided or the
12 areas to which the patient has had access; and

13 (c) pursuant to the written authorization of the patient, records and information pertaining to the
14 patient's diagnosis, treatment, and related services.

15 (16) A person admitted to a facility must be given access to any available individual or service that
16 provides advocacy for the protection of the person's rights and that assists the person in understanding,
17 exercising, and protecting the person's rights as described in this section.

18 (17) This section may not:

19 (a) obligate a professional person to administer treatment contrary to the professional's clinical
20 judgment;

21 (b) prevent a facility from discharging a patient for whom appropriate treatment, consistent with the
22 clinical judgment of a professional person responsible for the patient's treatment, is or has become impossible
23 to administer because of the patient's refusal to consent to the treatment;

24 (c) require a facility to admit a person who has, on prior occasions, repeatedly withheld consent to
25 appropriate treatment; or

26 (d) obligate a facility to treat a person admitted to the facility solely for diagnostic evaluation."
27

28 **Section 38.** Section 60-5-514, MCA, is amended to read:

1 **"60-5-514. Business eligibility -- criteria -- restrictions.** (1) To be eligible for placement of a
2 business sign on a specific information sign panel, a business establishment shall meet standards for "GAS",
3 "FOOD", "LODGING", and "CAMPING" services in rules adopted by the department pursuant to guidelines in
4 the Manual on Uniform Traffic Control Devices, as amended.

5 (2) (a) Each business identified on a specific information sign shall provide assurance of its
6 conformity with all applicable laws concerning the provision of public accommodations without regard to race,
7 color, sex, as defined in 1-1-201, culture, social origin or condition, or political or religious ideas.

8 (b) If such a business violates any of these laws, it loses eligibility for business identification on a
9 specific information sign.

10 (3) No business that owns any outdoor advertising structure in violation of the provisions of Title
11 75, chapter 15, part 1, may be eligible for business identification on a specific information sign for 1 year after
12 the illegal outdoor advertising structure is removed unless the owner voluntarily removes it within 45 days of
13 receiving notification under 75-15-131."

15 **Section 39.** Section 60-5-522, MCA, is amended to read:

16 **"60-5-522. Business eligibility -- criteria -- restrictions.** (1) To be eligible for business identification
17 on a tourist-oriented directional sign, a business establishment shall meet the following standards for a
18 business, service, or activity:

19 (a) Gas, food, lodging, and camping services must:

20 (i) be licensed and approved by the state and local agencies regulating the particular type of
21 business;

22 (ii) provide an acceptable level of service to the public;

23 (iii) be in continuous operation at least 8 hours a day, 5 days a week, including Saturday or
24 Sunday; and

25 (iv) have a telephone and restroom facilities available for public use.

26 (b) Recreation services must:

27 (i) be licensed and approved by state and local agencies as required by law;

28 (ii) provide to families and the public activities of interest in which people participate for purposes

1 of physical exercise, collective amusement, or enjoyment of nature. Such activities may include hiking, golfing,
2 skiing, boating, swimming, picnicking, fishing, and horseback riding.

3 (c) Tourist services must:

4 (i) be licensed as required by law;

5 (ii) be open to the public at least 8 hours a day, 5 days a week, including Saturday or Sunday,
6 during the normal tourist season; and

7 (iii) provide a natural, recreational, historical, cultural, educational, or entertainment activity or a
8 unique or unusual commercial or nonprofit activity, from which the major portion of income or visitors is derived
9 during normal business seasons from motorists not residing in the immediate area of the activity.

10 (2) Priority under subsection (1)(a) must be given to businesses that are in continuous operation
11 for 12 months a year.

12 (3) (a) Each business identified on a tourist-oriented directional sign shall provide assurance of its
13 conformity with all applicable laws concerning the provision of public accommodations without regard to race,
14 color, sex, as defined in 1-1-201, culture, social origin or condition, or political or religious ideas.

15 (b) If a business violates any of these laws, it loses eligibility for business identification on a tourist-
16 oriented directional sign.

17 (4) A business that owns any outdoor advertising structure in violation of the provisions of Title 75,
18 chapter 15, part 1, may not be eligible for business identification on a tourist-oriented directional sign for 1 year
19 after the illegal outdoor advertising structure is removed unless the owner voluntarily removes it within 45 days
20 of receiving notification under 75-15-131."

21

22 **Section 40.** Section 61-5-107, MCA, is amended to read:

23 **"61-5-107. Application for license or motorcycle endorsement.** (1) Each application for a learner
24 license, driver's license, commercial driver's license, or motorcycle endorsement must be made on a form
25 furnished by the department. Each application must be accompanied by the proper fee, and payment of the fee
26 entitles the applicant to not more than three attempts to pass the examination within a period of 6 months from
27 the date of application. A voter registration form for mail registration as prescribed by the secretary of state
28 must be attached to each driver's license application. If the applicant wishes to register to vote, the department

1 shall accept the registration and forward the form to the election administrator.

2 (2) Each application must include the full legal name, date of birth, sex, as defined in 1-1-201,
3 residence address of the applicant [and the applicant's social security number], must include a brief description
4 of the applicant, and must provide the following additional information:

5 (a) the name of each jurisdiction in which the applicant has previously been licensed to drive any
6 type of motor vehicle during the 10-year period immediately preceding the date of the application;

7 (b) a certification from the applicant that the applicant is not currently subject to a suspension,
8 revocation, cancellation, disqualification, or withdrawal of a previously issued driver's license or any driving
9 privileges in another jurisdiction and that the applicant does not have a driver's license from another jurisdiction;

10 (c) a brief description of any physical or mental disability, limitation, or condition that impairs or
11 may impair the applicant's ability to exercise ordinary and reasonable control in the safe operation of a motor
12 vehicle on the highway;

13 (d) a brief description of any adaptive equipment or operational restrictions that the applicant relies
14 upon or intends to rely upon to attain the ability to exercise ordinary and reasonable control in the safe
15 operation of a motor vehicle on the highway, including the nature of the equipment or restrictions; and

16 (e) if the applicant is a foreign national whose presence in the United States is temporarily
17 authorized under federal law, the expiration date of the official document issued to the applicant by the bureau
18 of citizenship and immigration services of the department of homeland security authorizing the applicant's
19 presence in the United States.

20 [(3) The department shall keep the applicant's social security number from this source confidential,
21 except that the number may be used for purposes of subtitle VI of Title 49 of the U.S.C. or as otherwise
22 permitted by state law administered by the department and may be provided to the department of public health
23 and human services for use in administering Title IV-D of the Social Security Act.]

24 (4) (a) When an application is received from an applicant who is not ineligible for licensure under
25 61-5-105 and who was previously licensed by another jurisdiction, the department shall request a copy of the
26 applicant's driving record from each jurisdiction in which the applicant was licensed in the preceding 10-year
27 period. The driving record may be transmitted manually or by electronic medium.

28 (b) When received, the driving records must be appended to the driver's record created and

1 maintained in this state. The department may rely on information contained in driving records received under
2 this section to determine the appropriate action to be taken against the applicant upon subsequent receipt of a
3 report of a conviction or other conduct requiring suspension or revocation of a driver's license under state law.

4 (5) An individual who is under 26 years of age but at least 15 years of age and who is required to
5 register in compliance with the federal Military Selective Service Act, 50 App. U.S.C. 453, must be provided an
6 opportunity to fulfill those registration requirements in conjunction with an application for a learner license,
7 driver's license, commercial driver's license, or state identification card. If under 18 years of age but at least 15
8 years of age, an individual must be provided an opportunity to be registered by the selective service system
9 upon attaining 18 years of age. Any registration information supplied on the application must be transmitted by
10 the department to the selective service system. (Bracketed language terminates on occurrence of contingency--
11 sec. 1, Ch. 27, L. 1999.)"

13 **Section 41.** Section 72-1-103, MCA, is amended to read:

14 **"72-1-103. General definitions.** Subject to additional definitions contained in the subsequent
15 chapters that are applicable to specific chapters, parts, or sections and unless the context otherwise requires, in
16 chapters 1 through 6, the following definitions apply:

17 (1) "Agent" includes an attorney-in-fact under a durable or nondurable power of attorney, an
18 individual authorized to make decisions concerning another's health care, and an individual authorized to make
19 decisions for another under a natural death act.

20 (2) "Application" means a written request to the clerk for an order of informal probate or
21 appointment under chapter 3, part 2.

22 (3) "Beneficiary", as it relates to:

23 (a) a trust beneficiary, includes a person who has any present or future interest, vested or
24 contingent, and also includes the owner of an interest by assignment or other transfer;

25 (b) a charitable trust, includes any person entitled to enforce the trust;

26 (c) a beneficiary of a beneficiary designation, refers to a beneficiary of:

27 (i) an account with POD designation or a security registered in beneficiary form (TOD); or

28 (ii) any other nonprobate transfer at death; and

1 (d) a beneficiary designated in a governing instrument, includes a grantee of a deed, a devisee, a
2 trust beneficiary, a beneficiary of a beneficiary designation, a donee, and a person in whose favor a power of
3 attorney or a power held in any individual, fiduciary, or representative capacity is exercised.

4 (4) "Beneficiary designation" refers to a governing instrument naming a beneficiary of:

5 (a) an account with POD designation or a security registered in beneficiary form (TOD); or

6 (b) any other nonprobate transfer at death.

7 (5) "Child" includes an individual entitled to take as a child under chapters 1 through 5 by intestate
8 succession from the parent whose relationship is involved and excludes a person who is only a stepchild, a
9 foster child, a grandchild, or any more remote descendant.

10 (6) (a) "Claims", in respect to estates of decedents and protected persons, includes liabilities of the
11 decedent or protected person, whether arising in contract, in tort, or otherwise, and liabilities of the estate that
12 arise at or after the death of the decedent or after the appointment of a conservator, including funeral expenses
13 and expenses of administration.

14 (b) The term does not include estate taxes or demands or disputes regarding title of a decedent or
15 protected person to specific assets alleged to be included in the estate.

16 (7) "Clerk" or "clerk of court" means the clerk of the district court.

17 (8) "Conservator" means a person who is appointed by a court to manage the estate of a protected
18 person.

19 (9) "Court" means the district court in this state having jurisdiction in matters relating to the affairs
20 of decedents.

21 (10) "Descendant" of an individual means all of the individual's descendants of all generations, with
22 the relationship of parent and child at each generation being determined by the definition of child and parent
23 contained in this code.

24 (11) "Devise" when used as a noun means a testamentary disposition of real or personal property
25 and when used as a verb means to dispose of real or personal property by will.

26 (12) "Devisee" means a person designated in a will to receive a devise. For purposes of chapter 3,
27 in the case of a devise to an existing trust or trustee or to a trustee or trust described by will, the trust or trustee
28 is the devisee and the beneficiaries are not devisees.

1 (13) "Disability" means cause for a protective order as described by 72-5-409.

2 (14) "Distributee" means any person who has received property of a decedent from the decedent's
3 personal representative other than as a creditor or purchaser. A testamentary trustee is a distributee only to the
4 extent of distributed assets or increment to distributed assets remaining in the trustee's hands. A beneficiary of
5 a testamentary trust to whom the trustee has distributed property received from a personal representative is a
6 distributee of the personal representative. For purposes of this provision, "testamentary trustee" includes a
7 trustee to whom assets are transferred by will, to the extent of the devised assets.

8 (15) "Estate" includes the property of the decedent, trust, or other person whose affairs are subject
9 to chapters 1 through 5 as originally constituted and as it exists from time to time during administration.

10 (16) "Exempt property" means that property of a decedent's estate that is described in 72-2-413.

11 (17) "Fiduciary" includes a personal representative, guardian, conservator, and trustee.

12 (18) "Foreign personal representative" means a personal representative appointed by another
13 jurisdiction.

14 (19) "Formal proceedings" means proceedings conducted before a judge with notice to interested
15 persons.

16 (20) "Governing instrument" means a deed; will; trust; insurance or annuity policy; account with
17 POD designation; security registered in beneficiary form (TOD); pension, profit-sharing, retirement, or similar
18 benefit plan; instrument creating or exercising a power of appointment or a power of attorney; or dispositive,
19 appointive, or nominative instrument of any similar type.

20 (21) "Guardian" means a person who has qualified as a guardian of a minor or incapacitated person
21 pursuant to testamentary or court appointment but excludes one who is merely a guardian ad litem.

22 (22) "Heirs", except as controlled by 72-2-721, means persons, including the surviving spouse and
23 the state, who are entitled under the statutes of intestate succession to the property of a decedent.

24 (23) "Incapacitated person" has the meaning provided in 72-5-101.

25 (24) "Informal proceedings" means proceedings conducted without notice to interested persons by
26 the clerk of court for probate of a will or appointment of a personal representative.

27 (25) "Interested person" includes heirs, devisees, children, spouses, creditors, beneficiaries, and
28 any others having a property right in or claim against a trust estate or the estate of a decedent, ward, or

1 protected person. The term also includes persons having priority for appointment as personal representative
2 and other fiduciaries representing interested persons. The meaning as it relates to particular persons may vary
3 from time to time and must be determined according to the particular purposes of and matter involved in any
4 proceeding.

5 (26) "Issue" of a person means a descendant.

6 (27) "Joint tenants with the right of survivorship" includes co-owners of property held under
7 circumstances that entitle one or more to the whole of the property on the death of the other or others but
8 excludes forms of co-ownership registration in which the underlying ownership of each party is in proportion to
9 that party's contribution.

10 (28) "Lease" includes an oil, gas, coal, or other mineral lease.

11 (29) "Letters" includes letters testamentary, letters of guardianship, letters of administration, and
12 letters of conservatorship.

13 (30) "Minor" means a person who is under 18 years of age.

14 (31) "Mortgage" means any conveyance, agreement, or arrangement in which property is used as
15 security.

16 (32) "Nonresident decedent" means a decedent who was domiciled in another jurisdiction at the
17 time of death.

18 (33) "Organization" means a corporation, business trust, estate, trust, partnership, joint venture,
19 association, government or governmental subdivision or agency, or any other legal or commercial entity.

20 (34) "Parent" includes any person entitled to take, or who would be entitled to take if the child died
21 without a will, as a parent under chapters 1 through 5 by intestate succession from the child whose relationship
22 is in question and excludes any person who is only a stepparent, foster parent, or grandparent.

23 (35) "Payor" means a trustee, insurer, business entity, employer, government, governmental agency
24 or subdivision, or any other person authorized or obligated by law or a governing instrument to make payments.

25 (36) "Person" means an individual, a corporation, an organization, or other legal entity.

26 (37) "Personal representative" includes executor, administrator, successor personal representative,
27 special administrator, and persons who perform substantially the same function under the law governing their
28 status. "General personal representative" excludes special administrator.

1 (38) "Petition" means a written request to the court for an order after notice.

2 (39) "Proceeding" includes action at law and suit in equity.

3 (40) "Property" includes both real and personal property or any interest in that property and means
4 anything that may be the subject of ownership.

5 (41) "Protected person" has the meaning provided in 72-5-101.

6 (42) "Protective proceeding" has the meaning provided in 72-5-101.

7 (43) "Record" means information that is inscribed on a tangible medium or that is stored in an
8 electronic or other medium and is retrievable in perceivable form.

9 (44) "Security" includes any note; stock; treasury stock; bond; debenture; evidence of indebtedness;
10 certificate of interest or participation in an oil, gas, or mining title or lease or in payments out of production
11 under such a title or lease; collateral trust certificate; transferable share; voting trust certificate; in general, any
12 interest or instrument commonly known as a security; any certificate of interest or participation; or any
13 temporary or interim certificate, receipt, or certificate of deposit for or any warrant or right to subscribe to or
14 purchase any of the foregoing.

15 (45) "Settlement", in reference to a decedent's estate, includes the full process of administration,
16 distribution, and closing.

17 (46) "Sign" means, with present intent to authenticate or adopt a record other than a will:

18 (a) to execute or adopt a tangible symbol; or

19 (b) to attach to or logically associate with the record an electronic symbol, sound, or process.

20 (47) "Special administrator" means a personal representative as described by chapter 3, part 7.

21 (48) "State" means a state of the United States, the District of Columbia, the Commonwealth of
22 Puerto Rico, or any territory or insular possession subject to the jurisdiction of the United States.

23 (49) "Successor personal representative" means a personal representative, other than a special
24 administrator, who is appointed to succeed a previously appointed personal representative.

25 (50) "Successors" means persons, other than creditors, who are entitled to property of a decedent
26 under the decedent's will or chapters 1 through 5.

27 (51) "Supervised administration" refers to the proceedings described in chapter 3, part 4.

28 (52) "Survive" means that an individual has neither predeceased an event, including the death of

1 another individual, nor is considered to have predeceased an event under 72-2-114 or 72-2-712. The term
2 includes its derivatives, such as "survives", "survived", "survivor", and "surviving".

3 (53) "Testacy proceeding" means a proceeding to establish a will or determine intestacy.

4 (54) "Testator" includes an individual of either sex, as defined in 1-1-201.

5 (55) "Trust" includes an express trust, private or charitable, with additions to the trust, wherever and
6 however created. The term also includes a trust created or determined by judgment or decree under which the
7 trust is to be administered in the manner of an express trust. The term excludes other constructive trusts and
8 excludes resulting trusts; conservatorships; personal representatives; trust accounts as defined in 72-6-111 and
9 Title 72, chapter 6, parts 2 and 3; custodial arrangements pursuant to chapter 26; business trusts providing for
10 certificates to be issued to beneficiaries; common trust funds; voting trusts; security arrangements; liquidation
11 trusts; trusts for the primary purpose of paying debts, dividends, interest, salaries, wages, profits, pensions, or
12 employee benefits of any kind; and any arrangement under which a person is nominee or escrowee for another.

13 (56) "Trustee" includes an original, additional, or successor trustee, whether or not appointed or
14 confirmed by court.

15 (57) "Ward" means an individual described in 72-5-101.

16 (58) "Will" includes codicil and any testamentary instrument that merely appoints an executor,
17 revokes or revises another will, nominates a guardian, or expressly excludes or limits the right of an individual
18 or class to succeed to property of the decedent passing by intestate succession."

20 NEW SECTION. SECTION 42. SEVERABILITY. IF A PART OF [THIS ACT] IS INVALID, ALL VALID PARTS THAT
