11	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

13	Section 1. Section 13-1-301, MCA, is amended to read:
14	"13-1-301. Election administrator. (1) (a) The county clerk and recorder of each county is the
15	election administrator unless the <del>governing body of the county designates another official or appoints an</del>
16	election administrator county population is over 50,000.
17	(b) (i) If the county population exceeds 50,000 residents, the governing body of the county shall
18	hire an election administrator to administer all elections in the county except as provided for in 20-20-401.
19	(i)(ii) The hired election administrator may not hold any elected office during the hired election
20	administrator's tenure as the election administrator.
21	(ii)(iii) The hired election administrator may not hold any positions within a political party or central
22	committee during the hired election administrator's tenure as the election administrator.
23	(iii) Any election administrators hired on or after July 1, 2023, must have 3 or more years of
24	experience in administering elections.
25	(2) The election administrator is responsible for the administration of all procedures relating to
26	registration of electors and conduct of elections, shall keep all county records relating to elector registration and
27	elections, and is the primary point of contact for the county with respect to the statewide voter registration list
28	and implementation of other provisions of applicable federal law governing elections.
