4	A BILL FOR AN ACT ENTITLED: "AN ACT SUBMITTING TO THE QUALIFIED ELECTORS OF MONTANA AN
5	AMENDMENT TO ARTICLE V, SECTION 14, OF THE MONTANA CONSTITUTION TO REVISE THE
6	CRITERIA FOR LEGISLATIVE AND CONGRESSIONAL DISTRICTS; AND PROVIDING AN EFFECTIVE
7	DATE."

9	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:
10	
11	Section 1. Article V, section 14, of The Constitution of the State of Montana is amended to read:
12	"Section 14. Districting and apportionment. (1) The state shall be divided into as many districts
13	as there are members of the house, and each district shall elect one representative. Each senate district shall
14	be composed of two adjoining house districts, and shall elect one senator.
15	(2) Each district shall consist of compact and contiguous territory. All districts shall be as nearly
16	equal in population as is practicable. All districts shall comply with the United States constitution. The
17	geographical integrity of any city, town, county, or community of interest shall be respected preserved in a
18	manner that minimizes their division to the extent possible without violating any of the requirements of this
19	subsection. Communities of interest do not include relationships with political parties, incumbents, and political
20	candidates. In establishing districts, the commission may not consider any data pertaining to the political
21	affiliation of electors or prior election results.
22	(2)(3) In the legislative session following ratification of this constitution and thereafter in each session
23	preceding each federal population census, a commission of five citizens, none of whom may be public officials,
24	shall be selected to prepare a plan for redistricting and reapportioning the state into legislative districts and a
25	plan for redistricting the state into congressional districts. The majority and minority leaders of each house shall
26	each designate one commissioner. Within 20 days after their designation, the four commissioners shall select
27	the fifth member, who shall serve as chairman of the commission. If the four members fail to select the fifth
28	member within the time prescribed, a majority of the supreme court shall select him.

1	(3) (4) Within 90 days after the official final decennial census figures are available, the commission
2	shall file its final plan for congressional districts with the secretary of state and it shall become law.
3	(4)(5) The commission shall submit its plan for legislative districts to the legislature at the first regular
4	session after its appointment or after the census figures are available. Within 30 days after submission, the
5	legislature shall return the plan to the commission with its recommendations. Within 30 days thereafter, the
6	commission shall file its final plan for legislative districts with the secretary of state and it shall become law.
7	(5)(6) Upon filing both plans, the commission is then dissolved."
8	
9	NEW SECTION. Section 2. Two-thirds vote required. Because [section 1] is a legislative proposal
10	to amend the constitution, Article XIV, section 8, of the Montana constitution requires an affirmative roll call vote
11	of two-thirds of all the members of the legislature, whether one or more bodies, for passage.
12	
13	NEW SECTION. Section 3. Effective date. [This act] is effective on approval by the electorate.
14	
15	NEW SECTION. Section 4. Submission to electorate. [This act] shall be submitted to the qualified
16	electors of Montana at the general election to be held in November 2024 by printing on the ballot the full title of
17	[this act] and the following:
