FISCAL ANALYSIS

Assumptions:

- 1. It is assumed that a one-time system change will be necessary for functionality enhancements within the Secretary of State's Registry Information System to add a field for affirmation to track the information and add it to both the portal and back office. The estimated vendor cost is \$5,000 in FY 2024.
- 2. While there may be a minimal fiscal impact for personal services costs related to the implementation of the system changes and system testing, these costs are assumed to be de minimis.
