6	COMMITTEE; ESTABLISHING DUTIES AND FUNCTIONS OF THE COMMITTEE; PROVIDING FOR			
7	COMPENSATION FOR LEGISLATIVE AND PUBLIC COMMITTEE MEMBERS; PROVIDING FOR			
8	ADDRESSING VACANCIES ON THE COMMITTEE; PROVIDING THAT THE LEGISLATIVE FISCAL			
9	DIVISION AND THE LEGISLATIVE SERVICES DIVISION WILL STAFF THE COMMITTEE; RENAMING THE			
10	LEGISLATIVE FINANCE ACT TO THE LEGISLATIVE FINANCE AND DATA ANALYTICS ACT; AMENDING			
11	SECTIONS 5-5-211, 5-12-101, 5-12-301, AND 5-12-302, MCA; REPEALING SECTION 3, CHAPTER 508,			
12	LAWS OF 2021; AND PROVIDING AN IMMEDIATE EFFECTIVE DATE."

14	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:			
15				
16	NEW SECTION. Section 1. Modernization and risk analysis committee. (1) There is a			
17	modernization and risk analysis committee. The committee shall study the long-term future budget and revenue			
18	needs of the state with changing economics and demographics.			
19	(2) The modernization and risk analysis committee is a bipartisan committee consisting of the			
20	following:			
21	(a) six members of the legislative finance committee, with three members appointed by the			
22	presiding officer and three members appointed by the vice presiding officer of the legislative finance committee;			
23	and			
24	(b) four members who are not officials or employees in the executive or legislative branches with			
25	two appointed by the presiding officer and two appointed by the vice presiding officer of the modernization and			
26	risk analysis committee; AND			
27	(C) AN INTERIM COMMITTEE CHAIRPERSON AND VICE CHAIRPERSON OF OPPOSITE PARTIES AS TEMPORARY			
28	VOTING MEMBERS OF THE COMMITTEE. THE PRESIDING OFFICER OF THE MODERNIZATION AND RISK ANALYSIS			



1	COMMITTEE SHALL INVITE THE TWO MEMBERS BASED ON THE RELEVANCE AT LEAST ONE OF THE TOPICS OF THE			
2	UPCOMING MEE	TING TO THE SUBJECT MATTER UNDER THE JURISDICTION OF A SPECIFIC INTERIM COMMITTEE. IF THE		
3	CHAIRPERSON OR VICE CHAIRPERSON OF THE INTERIM COMMITTEE IS UNABLE TO ATTEND, THE CHAIRPERSON OR VICE			
4	CHAIRPERSON MAY DESIGNATE A MEMBER OF THE INTERIM COMMITTEE. THE INTERIM COMMITTEE CHAIRPERSON AND			
5	VICE CHAIRPERSON MUST BE INVITED AT LEAST 30 DAYS PRIOR TO THE MEETING DATE.			
6	(3)	The legislative fiscal division shall provide administrative staff support and analysis to the		
7	modernization and risk analysis committee. The legislative services division may provide research and legal			
8	support at the request of the committee.			
9	(4)	The modernization and risk analysis committee shall:		
10	(a)	use available data and analytical resources to study the past, present, and future costs and		
11	revenues of all	state and local government entities and other policy areas that affect the future well-being of the		
12	citizens of the state of Montana, including but not limited to:			
13	(i)	health care;		
14	(ii)	human services;		
15	(iii)	elementary and secondary education;		
16	(iv)	higher education;		
17	(v)	pensions;		
18	(vi)	public safety and corrections;		
19	(vii)	infrastructure and public works;		
20	(viii)	programs historically funded by revenue generated from natural resource taxes;		
21	(ix)	information technology systems of the state and local government.		
22	(b)	issue and, at the committee's discretion, accept invitations to work with interim committees on		
23	various data a	nd analytic research projects;		
24	(c)	provide direction to the legislative fiscal division on the direction and priorities of data work of		
25	the division;			
26	(d)	create data sets and models for future analysis by the legislature; and		
27	(e)	take affirmative measures to use and disseminate data generated by and for the committee for		
28	educating, train	ning, and increasing the competency of the public.

2	NEW SE	ECTION. Section 2. Modernization and risk analysis committee terms officers			
3	compensation. (1) Appointments EXCEPT FOR INTERIM COMMITTEE MEMBERS INVITED PURSUANT TO [SECTION				
4	1(2)(C)], APPOINTMENTS to the modernization and risk analysis committee are for 2 years, and a member of the				
5	committee shall serve until the member's term of office as a legislator ends or until a successor is appointed,				
6	whichever occurs first.				
7	(2)	The modernization and risk analysis committee shall elect one of its members as presiding			
8	officer and other	officers that it considers necessary.			
9	(3)	Members of the modernization and risk analysis committee AND INVITED INTERIM COMMITTEE			
10	MEMBERS are entitled to receive compensation and expenses as provided in 5-2-302. Public members are				
11	entitled to receive compensation and expenses as provided in 5-2-302 and 5-5-211.				
12	(4)	If a vacancy occurs on the modernization and risk analysis committee established in [section 1]			
13	when the legislat	ture is not in session, the new member must be appointed by the same method as the original			
14	appointment to c	complete the unexpired term.

16	Section	3. Section 5-5-211, MCA, is amended to read:			
17	"5-5-211	I. Appointment and composition of interim committees. (1) Senate interim committee			
18	members must b	be appointed by the committee on committees.			
19	(2)	House interim committee members must be appointed by the speaker of the house.			
20	(3)	Appointments to interim committees must be made by the time of adjournment of the legislative			
21	session.				
22	(4)	A legislator may not serve on more than two interim committees unless no other legislator is			
23	available or is wi	illing to serve.			
24	(5)	(a) Subject to 5-5-234 and subsection (5)(b) of this section, the composition of each interim			
25	committee must	be as follows:			
26	(i)	four members of the house, two from the majority party and two from the minority party; and			
27	(ii)	four members of the senate, two from the majority party and two from the minority party.			
28	(b)	If the committee workload requires, the legislative council may request the appointing authority

1 to appoint one or two additional interim committee members from the majority party and the minority party.

2 (6) The membership of the interim committees must be provided for by legislative rules. The rules 3 must identify the committees from which members are selected, and the appointing authority shall attempt to 4 select not less than 50% of the members from the standing committees that consider issues within the 5 jurisdiction of the interim committee and at least one member from the joint subcommittee that considers the 6 related agency budgets. In making the appointments, the appointing authority shall take into account term limits 7 of members so that committee members will be available to follow through on committee activities and 8 recommendations in the next legislative session.

9 (7) An interim committee, or the environmental quality council, or the modernization and risk 10 <u>analysis committee</u> may create subcommittees. Nonlegislative members may serve on a subcommittee. Unless 11 the person is a full-time salaried officer or employee of the state or a political subdivision of the state, a 12 nonlegislative member appointed to a subcommittee <u>or to the modernization and risk analysis committee</u> is 13 entitled to salary and expenses to the same extent as a legislative member. If the appointee is a full-time 14 salaried officer or employee of the state or of a political subdivision of the state, the appointee is entitled to 15 reimbursement for travel expenses as provided for in 2-18-501 through 2-18-503."

17 Section 4. Section 5-12-101, MCA, is amended to read:

18 "5-12-101. Title and purpose of chapter. (1) This chapter may be cited as "The Legislative Finance
19 and Data Analytics Act".

20 (2) Because the legislature is responsible for appropriating public funds, it <u>must-shall</u> provide for 21 fiscal analysis of state government to accumulate, compile, analyze, and furnish <u>such-information bearing upon</u> 22 <u>on</u> the financial matters of the state that is relevant to issues of policy and questions of statewide importance.

23 (3) Because the legislature is responsible for providing a comprehensive system of efficient
24 governance, policy, and appropriations for the state and its political subdivisions, including local governments

25 and schools, analysis of data across all aspects of government revenues, services, and funding is essential.

26 (4) Because the laws enacted by the legislature remain unless later changed by the legislature,

27 appropriations may impact future generations, and tax and other law changes may impact the state's economy,

28 the legislature needs a data tool to evaluate the impacts of legislation on future generations. The tool should be



1	derived from re	liable data sets and numeric in nature to allow the legislature to evaluate different assumptions		
2	and potential cl	hanges in law 20 years into the future."

5	"5-12-3	301. Legislative fiscal division. There is a legislative fiscal division. The legislative fiscal		
6	analyst shall manage the legislative fiscal division to support the legislative finance committee and the			
7	modernization and risk analysis committee and carry out the provisions of this chapter."

9	Sectio	n 6. Section 5-12-302, MCA, is amended to read:		
10	"5-12-3	302. Fiscal analyst's duties. The legislative fiscal analyst shall:		
11	(1)	provide for fiscal analysis of state government and accumulate, compile, analyze, and furnish		
12	information bea	aring upon the financial matters of the state that is relevant to issues of policy and questions of		
13	statewide impo	rtance, including but not limited to investigation and study of the possibilities of effecting		
14	economy and e	efficiency in state government;		
15	(2)	estimate revenue from existing and proposed taxes;		
16	(3)	analyze the executive budget and budget requests of selected state agencies and institutions,		
17	including proposals for the construction of capital improvements;			
18	(4)	make the reports, data tools, and recommendations that the legislative fiscal analyst considers		
19	desirable to the	e legislature in accordance with 5-11-210 and make reports, data tools, and recommendations as		
20	requested by th	ne legislative finance committee and the legislature;		
21	(5)	assist committees of the legislature and individual legislators in compiling and analyzing		
22	financial inform	ation data tools;		
23	(6)	assist the revenue interim committee in performing its revenue estimating duties;		
24	[(7)	assist and provide staff for the interim budget committees established in 5-12-501]; and		
25	<u>(8)</u>	assist and provide staff for the modernization and risk analysis committee; and		
26	(8) (9)	review all reports submitted to the legislative fiscal analyst and notify the legislative finance		
27	committee [or t	he appropriate interim budget committee, or both,] of any concerns the fiscal analyst identifies in

through 2].
