NEW SECTION. Section 1. Highway patrol officers' retirement system appropriation. There is
appropriated \$27.6 million from the general fund to the Montana public employees' retirement board for the
fiscal year beginning July 1, 2023, to amortize the highway patrol officers' retirement system in 25 years.
NEW SECTION. Section 2. Sheriffs' retirement system appropriation. There is appropriated \$26.8
million from the general fund to the Montana public employees' retirement board for the fiscal year beginning
July 1, 2023, to amortize the sheriffs' retirement system in 25 years.
NEW SECTION. Section 3. Game wardens' and peace officers' retirement system
appropriation. There is appropriated \$52.8 million from the general fund to the Montana public employees'
retirement board for the fiscal year beginning July 1, 2023, to amortize the game wardens' and peace officers'
retirement system in 25 years.
Section 4. Section 19-8-504, MCA, is amended to read:
"19-8-504. Employer's contribution. The employer shall pay as employer contributions 9% 10.56%

of the compensation paid to all of the employer's employees, except those properly excluded from membership.
