15	Section 1. Section 15-6-301, MCA, is amended to read:		
16	"15-6-301. Definitions. As used in this part, the following definitions apply:		
17	(1) "Annual verification" means the use of a process to:		
18	(a) verify an applicant's income;		
19	(b) approve, renew, or deny benefits for the current year based upon <u>on</u> the applicant's eligibility;

21	(c) terminate participation based upon on death or loss of status as a qualified veteran or veteran's		
22	spouse.		
23	(2) "PCE" means the implicit price deflator (price index) for personal consumption expenditures as

26	(3) "PCE inflation factor" for a tax year means the PCE price index value for the first quarter of the		
27	prior tax year before the tax year divided by the PCE price index value for the first quarter of 2015.		
28	(4) (a) "Primary residence" is, subject to the provisions of subsection (4)(b), a dwelling:

1 (i) in which a taxpayer can demonstrate the taxpayer lived for at least 7 months of the year for 2 which benefits are claimed; 3 (ii) that is the only residence for which property tax assistance is claimed; and 4 (iii) determined using the indicators provided for in the rules authorized by 15-6-302(2). 5 (b) A primary residence may include more than one dwelling when the taxpayer's combined 6 residence in the dwellings is at least 7 months of the tax year. 7 (5) "Qualified veteran" means a veteran: 8 (a) who was killed while on active duty or died as a result of a service-connected disability: or 9 if living: (b) 10 (i) was honorably discharged from active service in any branch of the armed services; and 11 (ii) is currently rated 100% 60% disabled or higher or is paid at the 100% 60% disabled rate or 12 higher by the U.S. department of veterans affairs for a service-connected disability, as verified by official 13 documentation from the U.S. department of veterans affairs. 14 (6) "Qualifying income" means: 15 (a) the federal adjusted gross income excluding capital and income losses of an applicant and the 16 applicant's spouse as calculated on the Montana income tax return for the prior year: 17 (b) for assistance under 15-6-311, the federal adjusted gross income excluding capital and income 18 losses of an applicant as calculated on the Montana income tax return for the prior tax year; or 19 (c) for an applicant who is not required to file a Montana income tax return, the income determined 20 using available income information. 21 "Qualifying property" means a primary residence that a qualified applicant owned and occupied (7)22 for at least 7 months during the tax year. 23 (8) "Residential real property" means the land and improvements of a taxpayer's primary 24 residence." 25 26 Section 2. 14	(5)	(a) An application must be filed by April 15 of the year for which assistance is first claimed.			
15	(b)	Once assistance is approved, the applicant remains eligible for property tax assistance in			
16	subsequent years through the annual verification process defined in 15-6-301 without the need to reapply.				
17	(c)	A taxpayer shall inform the department of any change in eligibility occurring from one year to			
18	the next.				
19	(6)	The department may verify an applicant's and an applicant's spouse's social security number			
20	and benefits with the social security administration and the U.S. department of veterans affairs.				
21	(7) The department must annually verify an applicant's eligibility, including the applicant's and				
22	spouse's income, and approve, renew, or deny benefits for the current year based upon on the findings.				
23	(8)	(a) When providing information for property tax assistance under 15-6-305 or 15-6-311,			
24	applicants are s	subject to the false swearing penalties established in 45-7-202.			
25	(b)	The department may investigate the information provided in an application and an applicant's			
26	continued eligibility.				
27	(c)	The department may request applicant verification of the primary residence.			
28	(9)	The department may address unusual circumstances of ownership and income that arise in



9 "15-6-311. Disabled veteran program. (1) The residential real property of a qualified veteran or a
10 qualified veteran's spouse is eligible to receive a tax rate reduction as provided in 15-6-302 and this section.

11 (2) Property qualifying under subsection (1) and owned by a qualified veteran is taxed at the rate 12 provided in 15-6-134 multiplied by a percentage figure based on the applicant's qualifying income and disability

13 <u>rating determined from the following table:</u>

(4) The property tax exemption under this section remains in effect as long as the qualifying

7 income requirements are met and the property is the primary residence owned and occupied by the veteran or,

8 if the veteran is deceased, by the veteran's spouse and the spouse:

9

(a) is the owner and occupant of the house;

10 (b) is unmarried; and

11 (c) has obtained from the U.S. department of veterans affairs a letter indicating that the veteran

12 was rated <u>100%-60%</u> disabled <u>or higher</u> or was paid at the <u>100%_60%</u> disabled rate <u>or higher</u> by the U.S.

13 department of veterans affairs for a service-connected disability at the time of death or that the veteran died

14 while on active duty or as a result of a service-connected disability.



1	(5) The qualifying income levels contained in subsections (2) and (3) must be adjusted annually by
2	using the PCE inflation factor defined in 15-6-301, rounded to the nearest whole dollar amount. If the
3	adjustment results in a decrease in qualifying income levels from the previous year, the qualifying income levels
4	must remain the same for that year."

9	meaning of 1-2-109, to property tax years beginning on January 1, 2023.
