4	A BILL FOR AN ACT ENTITLED: "AN ACT DIRECTING AN AMENDMENT TO ARM 27.95.623 TO REVISE		
5	THE CHILD-TO-STAFF RATIOS AND MAXIMUM GROUP SIZES FOR CHILD CARE CENTERS AND		
6	PROVIDE FOR A HIGHER CHILD-TO-STAFF RATIO DURING NAP TIMES PROVIDED CERTAIN		
7	CONDITIONS ARE MET."

9	WHEREAS, the proposed changes to the child-to-staff ratios and maximum group sizes for child care		
10	centers more closely align with the guidelines from the National Association for the Education of Young		
11	Children (NAEYC); and		
12	WHEREAS, the proposed changes would benefit the child care industry in Montana by opening up		
13	more child care spots in communities across the state while still aligning with the STARS to Quality level 5		
14	standards from the Department of Public Health and Human Services; and		
15	WHEREAS, child care centers would see increased revenue, which would allow the child care		
16	providers to increase their employees' wages without increasing tuition rates for families; and		
17	WHEREAS, at least 21 other states have adopted child care regulations that provide flexibilities during		
18	children's nap times, including Wyoming, Colorado, Mississippi, Texas, Alaska, and others; and		
19	WHEREAS, the additional flexibilities at nap time would benefit the child care industry in Montana by		
20	allowing lead staff to meet, plan, and collaborate during nap time and would reduce payroll costs by eliminating		
21	the need to schedule lead staff planning time each week while those staff are not included in the ratio, all while		
22	supporting a safe nap environment with sufficient supervision; and		
23	WHEREAS, the proposed changes would allow child care centers to increase access and affordability		
24	to child care for Montana families, help child care providers to attract and retain staff, and support quality		
25	improvement in child care programs, while still aligning with state and industry standards.

4	(1)	The child-to-staff ratio and maximum group size for a child care center are:	
5	(a)	4:1 for children newborn through 23 11 months with a maximum group size of 12 8;	
6	(b)	6:1 for children 12 months through 23 months with a maximum group size of 12;	
7	<u>(c)</u>	8:1 for children two years through three years with a maximum group size of 16;	
8	(c) (d)	10:1 for children four years three years through five years with a maximum group size of 24 20;	
9	and		
10	(d) (e)	14:1 for five years and over 15:1 for children six years and over with a maximum group size of	
11	32 <u>30</u> .		
12	(2)	When children of different ages are mixed, the ratio and group size for the youngest child in the	
13	group must be maintained.		
14	(3)	Only the director, early childhood lead teachers, assistant teachers, trainees, and substitute	
15	teachers may be counted as staff when determining the staff ratio.		
16	(4)	Group sizes must be maintained except for mealtimes, outdoor play, rest periods, or during	
17	large group activities, such as educational assemblies.		
18	<u>(5)</u>	At nap time, the child-to-staff ratio may be doubled for children two years and over when the	
19	following conditions are met:		
20	<u>(a)</u>	at least half the children are sleeping;	
21	<u>(b)</u>	another staff member is onsite in the center and is immediately available;	
22	<u>(c)</u>	the maximum group size and room capacity are not exceeded; and	
23	<u>(d)</u>	the staff member responsible for direct supervision of the napping children is not a trainee."
