9	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

11	Section 1. Section 50-20-104, MCA, is amended to read:				
12	"50-20	Definitions. As used in this chapter, the following definitions apply:			
13	(1)	"Abortion" means the use or prescription of any instrument, medicine, drug, or other substance			
14	or device to in	tentionally terminate the pregnancy of a woman known to be pregnant, with an intention other			
15	than to increase the probability of a live birth, to preserve the life or health of the child after live birth, or to				
16	remove a dead fetus.				
17	(2)	"Attempted abortion" or "attempted" means an act or an omission of a statutorily required act			
18	that, under the circumstances as the actor believes them to be, constitutes a substantial step in a course of				
19	conduct planned to culminate in the performance of an abortion in violation of this chapter.				
20	(3)	"Department" means the department of public health and human services provided for in 2-15-			
21	2201.				
22	(4)	"Facility" means a hospital, health care facility, physician's office, or other place in which an			
23	abortion is performed.				
24	(5)	"Informed consent" means voluntary consent to an abortion by the woman upon whom the			
25	abortion is to be performed only after full disclosure to the woman by:				
26	(a)	the physician who is to perform the abortion of the following information:			
27	(i)	the particular medical risks associated with the particular abortion procedure to be employed,			
28	including, whe	n medically accurate, the risks of infection, hemorrhage, breast cancer, danger to subsequent			



1	pregnanc	pregnancies, and infertility;		
2	(i	ii)	the probable gestational age of the unborn child at the time the abortion is to be performed;	
3	and			
4	(i	iii)	the medical risks of carrying the child to term;	
5	(I	b)	the physician or an agent of the physician:	
6	(i	i)	that medical assistance benefits may be available for prenatal care, childbirth, and neonatal	
7	care;			
8	(i	ii)	that the father is liable to assist in the support of the child, even in instances in which the father	
9	has offered to pay for the abortion; and			
10	(i	iii)	that the woman has the right to review the printed materials described in 50-20-304; and	
11	(0	c)	the physician or the agent that the printed materials described in 50-20-304 have been	
12	provided	by the	department and that the materials describe the unborn child and list agencies that offer	
13	alternativ	alternatives to abortion.		
14	(6	6)	(a) "Viability" means the ability of a fetus to live outside the mother's womb, albeit with artificial	
15	aid.			
16	<u>(l</u>	b)	A determination of viability must be:	
17	<u>(i</u>	i <u>)</u>	made in writing by the physician or physician assistant performing an abortion AND INCLUDE THE	
18	REVIEW A	ND REC	ORD OF AN ULTRASOUND; and	
19	<u>(i</u>	ii)	based on the best available science and survival data, with viability presumed at 24 weeks	
20	gestational age and any period of time after that. A calculation of gestational age must take into account a			
21	margin of	f error a	and, if uncertainty exists regarding viability, there is a presumption of viability."

24	",	50-20-1	109. Control of practice of abortion. (1) Except as provided in 50-20-401, an abortion may	
25	not be performed within the state of Montana:			
26	(;	a)	except by a licensed physician or physician assistant; and	
27	(I	b)	on an unborn child:	
28	<u>(i</u>	i)	who is capable of feeling pain, except as provided in 50-20-603; or	



1	<u>(ii)</u>	who is viable, unless necessary to preserve the life of the mother.
2	(2)	The supervision agreement of a physician assistant may provide for performing abortions.
3	(3)	Violation of subsection (1) is a felony."
