15	NEW SECTION. SECTION 2. PETROLEUM TANK RELEASE COMPENSATION BOARD REPORTING. (1) AT EACH		
16	QUARTERLY MEETING OF THE NATURAL RESOURCES AND TRANSPORTATION BUDGET COMMITTEE DURING THE 2023-		
17	2024 INTERIM, THE FOLLOWING MUST BE PRESENT TO REPORT TO THE COMMITTEE:		
18	(A) A MEMBER OF THE PETROLEUM TANK RELEASE COMPENSATION BOARD;		
19	(B) THE EXECUTIVE OFFICER OF THE PETROLEUM TANK RELEASE COMPENSATION BOARD;		
20	(C) A REPRESENTATIVE OF THE DEPARTMENT OF ENVIRONMENTAL QUALITY; AND		
21	(D) A MEMBER OR REPRESENTATIVE OF THE PETROLEUM MARKETERS AND CONVENIENCE STORE		
22	ASSOCIATION.		
23	(2) THE INDIVIDUALS LISTED IN SUBSECTION (1) SHALL REPORT ON THE FOLLOWING:		
24	(A) THE PROGRESS ON THE CLOSING OF SITES;		
25	(B) THE AMOUNT OF THE FUND BALANCE IN THE PETROLEUM TANK RELEASE CLEANUP FUND;		
26	(C) THE PORTION OF THE FUND BALANCE THAT IS ALLOCATED OR ENCUMBERED;		
27	(D) ANY SUGGESTIONS TO IMPROVE THE PROCESS OF CLOSING SITES; AND		
28	(E) THE TIMELINESS OF BOARD PAYMENTS FOR COMPLETED CORRECTIVE ACTION PLANS.

5	NEW SECTION. SECTION 3. REPORTING. (1) BY SEPTEMBER 1, 2023, THE DEPARTMENT OF FISH,
6	WILDLIFE, AND PARKS SHALL SUBMIT A REPORT TO THE NATURAL RESOURCES AND TRANSPORTATION BUDGET
7	COMMITTEE AND THE LEGISLATIVE FINANCE COMMITTEE DESCRIBING ALL PROJECTS INITIATED BUT NOT COMPLETED,
8	BEGINNING WITH PROJECTS FIRST APPROPRIATED IN 2015 AND CONTINUING THROUGH THE 2023 BIENNIUM IN EACH OF
9	THE PROGRAM AREAS LISTED IN SUBSECTION (4).
10	(2) THE REPORT MUST IDENTIFY FOR EACH PROJECT:
11	(A) THE NAME OF THE PROJECT;
12	(B) A BROAD DESCRIPTION OF THE PROJECT'S OBJECTIVES;
13	(C) THE PROJECT'S PHYSICAL LOCATION;
14	(D) A DESCRIPTION OF THE WORK COMPLETED;
15	(E) THE AMOUNT OF MONEY EXPENDED TO DATE;
16	(F) THE AMOUNT OBLIGATED BUT UNSPENT; AND
17	(G) A DESCRIPTION OF THE PROBLEMS OR OBSTACLES ENCOUNTERED THAT HAVE PROHIBITED
18	COMPLETION OF THE PROJECT.
19	(3) EVERY QUARTER AFTER THAT, THE DEPARTMENT SHALL SUBMIT A REPORT TO THE NATURAL
20	RESOURCES AND TRANSPORTATION BUDGET COMMITTEE AND THE LEGISLATIVE FINANCE COMMITTEE DESCRIBING THE
21	PROGRESS A PROGRAM MADE IN COMPLETING THE PROJECTS DESCRIBED IN SUBSECTION (1). THE REPORT MUST
22	INCLUDE:
23	(A) ACTIONS TAKEN TO COMPLETE THE PROJECT;
24	(B) FUNDS EXPENDED DURING THE QUARTER;
25	(C) THE BALANCE OF FUNDS OBLIGATED BUT NOT SPENT; AND
26	(D) PROBLEMS OR OBSTACLES INHIBITING PROJECT COMPLETION.
27	(4) THE FOLLOWING PROGRAMS OF THE DEPARTMENT OF FISH, WILDLIFE, AND PARKS SHALL PROVIDE
