10	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

12	Section 1. Section 13-37-130, MCA, is amended to read:			
13	"13-37-130. Limitation of action. An action may not be brought under 13-37-128 and 13-37-129			
14	more than 4 years 2 years after the occurrence of the facts that give rise to the action. No more than one			
15	judgment against a particular defendant may be had on a single state of facts. The civil action created in 13-37-			
16	128 and 13-37-129 is the exclusive remedy for violation of the contribution, expenditure, and reporting			
17	provisions of this chapter. These provisions are not subject to the misdemeanor penalties of 13-35-103 but may			
18	be a ground for contest of election or removal from office as provided in 13-35-106(3) and Title 13, chapter 36."

20	Section 2. Section 13-37-208, MCA, is amended to read:			
21	"13-37-208. Treasurer to keep records. (1) (a) Except as provided in subsection (1)(b), the			
22	campaign treasurer of each candidate, each political committee, and each joint fundraising committee shall			
23	keep detailed accounts of all contributions received and all expenditures made by or on behalf of the candidate,			
24	political committee, or joint fundraising committee that are required to be set forth in a report filed under this			
25	chapter. The accounts must be current within not more than 10 days after the date of receiving a contribution or			
26	making an expenditure.			
27	(b) The accounts described in subsection (1)(a) must be current as of the 5th day before the date			
28	of filing of a report as specified in 13-37-228.
