SPECIAL ORDERS OF THE DAY

Secretary of State Jacobsen introduced the Honorable Judge Ashley Harada, from the 13th Judicial District Court of Montana. Representative Schillinger and Representative Bishop escorted Judge Harada into the Chamber.

Judge Harada administered the following oath of office:

"I do solemnly swear that I will support, protect and defend the Constitution of the United States, the Constitution of the State of Montana, and I will discharge the duties of my office as a Montana State Representative with fidelity, so help me God."

Secretary of State Jacobsen thanked Judge Harada and asked the members of the House of Representatives to sign their copies of the oath of offices. The oaths will be presented to Judge Harada for her acknowledgement and then filed with the Secretary of State's office. Representative Schillinger and Representative Bishop escorted Judge Harada from the Chamber.

Secretary of State Jacobsen called for nominations for the office of Speaker of the House. Majority Leader-elect Vinton nominated Representative Matt Regier. Minority Leader-elect Abbott moved that the nominations be closed. Motion carried.

Secretary of State Jacobsen declared that Representative Matt Regier has been duly elected Speaker of the House of Representatives for the 68th Legislature. Representative Nave and Representative Caferro escorted Speaker Regier to the Rostrum.

Speaker Regier thanked Secretary Jacobsen on behalf of the House. Representative Windy Boy and Representative Welch escorted Secretary of State Jacobsen from the House Chamber.

Speaker Regier addressed the House:

"Distinguished guests, family, friends, legislative colleagues and most importantly the people of Montana, welcome to the 68th legislature of the Montana House of Representatives. Like so many great accomplishments in life, they are accompanied by the work and sacrifice of those around us. We have many families and friends who have toiled alongside of us dropping pamphlet after pamphlet, adding website content, and sharing the tears as we try and navigate that social media hoopla to get a boost post. They cheered us along; they held us up when we were down, and they continue to make sacrifices as our lives are disrupted over the next four months. To all those family and friends, you have our deepest gratitude. So first, let's give our family and friends a big round of applause.

And now congratulations to each of you. It is a great responsibility and honor to be here. I want to thank each of you for placing your trust in me to lead as Speaker of the House. I will never get tired of walking into this House Chamber, staring at the Charlie Russell painting here of Lewis and Clark meeting the Indians at Ross' Hole. Also, sitting at the historic desks in your new safe chairs, this truly is a privilege. There are only 100 Montanans that have been entrusted with this privilege to sit where you are and debate the ideas that will govern our great state. In front of you is a pin commemorating your membership to this committee. It is depicting the beautiful painting that is here in front of us. There are now and forever will be, only 100 of these pins. It is an awesome achievement, and at the same time carries a tremendous weight of responsibility.

Each legislative day, we resolve ourselves into a committee of the whole where we are a vast array of individuals. You are now one part of a committee that makes up the House of Representatives. This committee has over 134 years of tradition; tradition of debating the issues that are relevant to our great state. Like in the 11th session, 1909, this committee here debated Montana Code Annotated § 81-5-103 that states it is illegal to willfully abandon your sheep, unless of course you give the owner a five-day notice. That was, a hotly debated issue, I guess, back in that day and it ended up making it into the law books where it still resides today.

So, just as the mutton issues of the 11th session, I do not want us to shy away from debate. That is the one job we were sent here to do, to speak for your 10,000 plus constituents. But during our discussion on the question, I expect that each of you will make our debate civil and respectful. I ask two things of you as Representatives: to abstain from making the debate personal and to abstain from taking the debate personally. The bills that pass through this Chamber will inevitably affect some of us, as well as many Montanans across this great state. I

expect all of us to use the self-control and civility that has prevailed for the 67 prior legislative sessions.

But the courtesy and respect does not stop at second reading, both inside and outside these walls. Treat the House staff and Capitol employees with the respect and kindness they deserve. As the pace increases this session, please remember to enjoy this great process of the legislative branch. You will form friendships that will carry on decades past Sine Die. I affectionately refer to our Capitol here as the fishbowl where we are somewhat captive and surrounded by colleagues from all walks of life. Nowhere else in life do you have the unique opportunity to step outside of your comfort zone and meet such amazing people. Make the most of this opportunity you have been given. And whether walking in the halls of this Capitol, or sitting in committee rooms, or standing in line at the Grand for the seconds on the coconut shrimp, speak with class for the Montanans that you represent.

So, let's roll up our sleeves for the hard work that is ahead of us here for this session. It was Thomas Jefferson that stated, "I am a great believer in luck, and I find the harder I work the more of it I have." So, with that, I wish you all the best of luck in the 68th Montana Legislative Session."
