Dear President Ellsworth and Speaker Regier:

I support the Legislature's interest in broadening the scope of the post-election audits to include audits in counties that only hand count votes. Senate Bill 254 pursues this intention but fails to remove all references to the vote-tabulating machine limitation.

Therefore, in accordance with the power vested in me as Governor by the Constitution and the laws of the State of Montana, I hereby return with amendments Senate Bill 254: "AN ACT REMOVING AN EXEMPTION FROM A POSTELECTION AUDIT FOR COUNTIES THAT TABULATE THEIR VOTES BY HAND; PROVIDING RULEMAKING AUTHORITY; AMENDING SECTION 13-17-503, MCA; AND PROVIDING AN IMMEDIATE EFFECTIVE DATE."

The attached language further amends MCA 13-17-503-which is entitled "Random-sample audit of vote-counting machines required-rulemaking authority" and currently directs that "the county audit committee shall conduct a random-sample audit of vote-counting machines"-to remove both references to vote-counting machines and instead, more broadly direct that "the county audit committee shall conduct a random-sample audit."

I respectfully request your concurrence with this amendment.

Dear President Ellsworth and Speaker Regier:

Like you and members of the Legislature, I recognize the importance of providing parents, guardians, or other individuals who are the subject of a child abuse and neglect case with the information needed to protect their legal rights during a child protective services (CPS) investigation.

I appreciate the Legislature's work to promote transparency and parental rights during child abuse and neglect cases. However, Senate Bill 181 can be improved to ensure the protection of vulnerable children and the ability of Montana Department of Public Health and Human Services (DPHHS) Child and Family Services Division (CFSD) staff, who are required under state and federal law to investigate reports of child abuse and neglect, to conduct timely and thorough investigations, while promoting transparency and parental rights.

Therefore, in accordance with the power vested in me as Governor by the Constitution and the laws of the State of Montana, I hereby return with amendments Senate Bill 181: "AN ACT PROVIDING FOR THE PROVISION OF CERTAIN INFORMATION TO A PARENT, GUARDIAN, OR OTHER PERSON HAVING PHYSICAL OR LEGAL CUSTODY OF A CHILD WHO IS THE SUBJECT OF A CHILD ABUSE OR NEGLECT INVESTIGATION."

As approved by the Legislature, Senate Bill 181 shifts the focus of CPS investigations away from children's best interests in favor of the rights of parents who are the subject of an abuse or neglect investigation. Under Senate Bill 181, the prioritization of parental interests over a child's could delay and hinders CFSD's ability to fulfill its mandate to protect abused or neglected children when dangerous circumstances exist.

Specifically, Senate Bill 181 prevents DPHHS staff from properly investigating and providing for the safety of children in their home following an allegation of abuse and neglect. The legislation hinders DPHHS investigators as they engage with a parent, who is the subject of a child abuse and neglect case to protect and ensure the safety of the child. Further, Senate Bill 181 fails to prohibit actions that could be used to abuse, terrify, intimidate, threaten, harass, injure, or endanger DPHHS employees when a child is removed from the parental home.

While I share the Legislature's goal of promoting transparency and parental rights during CPS investigations, it is critical that the best interests of vulnerable children in Montana are not

undermined and CFSD staff are not obstructed while protecting children who have been or are at substantial risk of abuse, neglect, or abandonment.

Therefore, I offer an amendment that strengthens the bill by ensuring the safety and well-being of Montana's children and safeguarding the ability of DPHHS staff to properly fulfill their duties, while also promoting parental engagement and full notice of their legal rights during a CPS investigation.

Senate Bill 181 can be improved with vulnerable Montana children in mind, and I respectfully ask for your support of this amendment.

Like you and members of the Legislature, I understand the need to provide stable and predictable procedures in dependent and neglect ("DN") cases that do not result in unnecessary or inordinate delays in the placement of children or reunification of families.

While I appreciate the intent of Senate Bill 184 to expedite DN cases by limiting a court's ability to transfer venue and grant continuances, these provisions unduly limit a court's ability to appropriately manage DN cases in the best interests of the children and parents involved.

Therefore, in accordance with the power vested in me as Governor by the Constitution and the laws of the State of Montana, I hereby return with amendments Senate Bill 184: "AN ACT REVISING PROCEDURAL REQUIREMENTS IN CHILD ABUSE AND NEGLECT PROCEEDINGS; PROHIBITING TRANSFER OF VENUE OUTSIDE OF THE COUNTY IN WHICH AN ABUSE AND NEGLECT PETITION WAS FILED; PROVIDING EXCEPTIONS TO THE PROHIBITION ON TRANSFERS OF VENUE; PROHIBITING CONTINUANCES OF HEARINGS UNLESS EXIGENT CIRCUMSTANCES EXIST: DEFINING 'EXIGENT

CIRCUMSTANCES'; AND AMENDING SECTIONS 41-3-103 AND 41-3-434, MCA."

First, Senate Bill 184 prohibits a court from transferring venue outside of the county in which the petition is filed unless venue is being transferred to a tribal court or treatment court. It is not uncommon for a party involved in a **DN** case to move to another county for any number of legitimate reasons, including employment, housing, or treatment opportunities. Prohibiting venue transfer in these circumstances could not only limit the ability of a parent, child, or other necessary party to meaningfully participate in the proceedings, but it may also hinder reunification efforts or a child's permanent placement. The better course is to allow the original court to weigh and consider all of the circumstances - including the stage of the proceedings, the location of witnesses, the child's needs, a parent's treatment progress, and the ability of parties to participate - to determine if a change in venue will best serve the interests of the child and the implementation of any reunification or permanent placement plans.

Therefore, I offer an amendment that authorizes a court to deny a motion to change venue if good cause exists or if transferring venue will result in delaying a child's permanency.

Second, Senate Bill 184 prohibits a court from continuing a hearing unless a narrow set of exigent circumstances exists. **DN** cases are complex and involve many people. If a parent cannot be located, constitutional due process rights may require a continuance outside of the narrow exigent circumstances prescribed by the bill. Critical witnesses may not be available at the time of an originally-scheduled hearing. A parent may need additional time to complete a treatment component due to circumstances beyond their control. Senate Bill 184 even takes away the right of the parties themselves to agree to a continuance.

Recognizing the unique complexity of **DN** cases and the importance of parental rights, the amendment I offer appropriately allows a court to grant a continuance if good cause exists, as defined in the amendment, including consideration of a parent's constitutional rights.

To ensure courts in DN cases can take into account relevant facts when presented with a request for transfer of venue or a continuance, and to ensure courts can make a reasoned decision that protects the constitutional rights of parents while promoting the best interests of the child, I respectfully ask for your support of these amendments.

Dear President Ellsworth and Speaker Regier:

Like you and members of the Legislature, I understand the vital role our ambulance service providers play in providing Montana's patients with life-saving medical care. Ambulance service organizations face unprecedented challenges with increased operating costs that have been compounded by a shortage of paramedics and emergency medical technicians, and I share your commitment to ensuring such organizations are equipped to continue serving as lifelines to care in communities across Montana.

I share the goal of maintaining and improving Montanans' access to critical life-saving services and applaud the Legislature's work to improve the financial security of ambulance providers across the state. However, House Bill 828 can be improved to ensure the intent of the legislation is achieved.

Therefore, in accordance with the power vested in me as Governor by the Constitution and the laws of the State of Montana, I hereby return with amendments House Bill 828: "AN ACT ESTABLISHING AN AMBULANCE PROVIDER ASSESSMENT FEE; ESTABLISHING PROCEDURES FOR COLLECTING AND DISTRIBUTING THE FEE; ALLOWING AUDITING OF AMBULANCE PROVIDER REPORTS AND PAYMENTS; ALLOWING FOR PENALTIES AND INTEREST; REQUIRING REVENUES GENERATED BY THE FEE TO BE USED FOR SUPPLEMENTING AMBULANCE PROVIDER MEDICAID PAYMENTS; PROVIDING RULEMAKING AUTHORITY; PROVIDING DEFINITIONS; PROVIDING A STATUTORY APPROPRIATION; AMENDING SECTION 17-7-502, MCA; AND PROVIDING AN EFFECTIVE DATE AND A CONTINGENT TERMINATION DATE."

As approved by the Legislature, House Bill 828 establishes a Medicaid supplemental payment program for ambulance providers, which requires the Montana Department of Public Health and Human Services (DPHHS) to obtain approval of a state plan amendment (SPA) from the Centers for Medicare & Medicaid Services (CMS) with sufficient time to implement the program by July 1, 2024. While I am also committed to improving access to ambulance services, the bill, as approved by the Legislature, does not provide enough time for DPHHS to gather the data and to conduct a proper analysis to determine the impact of the supplemental payment program, including the impact on ambulance service providers, and whether the program will have the impact intended by the Legislature. Such data and analyses are also needed to support the submission to, and approval by, CMS of the necessary SPA

Therefore, I offer an amendment that will strike the implementation date in Section 16(2) of House Bill 828, which will allow DPHHS to work with relevant stakeholders to ensure their broad support, as well as obtain the necessary data to analyze the impact, of the supplemental payment program prior to seeking federal approval.

House Bill 828 can be improved to ensure the bill's intent is achieved, and I respectfully ask for your support of this amendment.

Dear President Ellsworth and Speaker Regier:

When any Montanan is convicted and incarcerated for a crime he or she didn't commit, that individual deserves redress and compensation. We owe it to wrongfully convicted individuals to help them make their lives whole.

I appreciate the 67th Legislature for establishing an optional path for compensation and am grateful for the 68th Legislature's work to continue the wrongful conviction compensation program and clarify several of its procedural aspects through House Bill 423. However, this bill can be improved.

Therefore, in accordance with the power vested in me as Governor by the Constitution and the laws of the State of Montana, I hereby return with amendments House Bill 423: "AN ACT GENERALLY REVISING EXONEREE COMPENSATION LAWS; MAKING THE COMPENSATION PROCESS PERMANENT; REVISING WHAT INFORMATION MUST ACCOMPANY A CLAIM FOR COMPENSATION; REVISING WHEN A CLAIMANT CONVICTED PRIOR TO JULY 2021 MAY FILE A CLAIM; LIMITING WHEN A PROFFER OF ACTUAL INNOCENCE MAY BE REQUIRED; REMOVING A PARDON AS AN ACT THAT CAN BE USED TO ESTABLISH A CLAIM FOR COMPENSATION; REVISING WHEN A TRANSITION ASSISTANCE GRANT MUST BE PAID; ELIMINATING COUNTY OF CONVICTION AS A PARTY TO A CLAIM; PROVIDING FOR A TRANSFER OF FUNDS TO THE EXONEREE COMPENSATION FUND; MAKING THE STATUTORY APPROPRIATION OF THE EXONEREE COMPENSATION FUND PERMANENT; AMENDING SECTIONS 46-32-101, 46-32-102, 46-32-103, 46-32-104, AND 46-32-108, MCA; REPEALING SECTION 15, CHAPTER 574, LAWS OF 2021; AND PROVIDING EFFECTIVE DATES."

Historically, counties have been liable for approximately 77% of the damages paid to persons

wrongfully convicted, and the state has been liable for approximately 23%. That is why, in 2021, I worked with the legislature through House Bill 92 to allocate responsibility for 75% of the costs associated with the wrongful conviction compensation program to counties and 25% to the state. House Bill 423 eliminates the counties' responsibility for wrongful convictions, placing 100% of the responsibility on state taxpayers.

To ensure financial and legal responsibility for harm rests with the party best able to keep it from happening again, and to protect Montana taxpayers, the amendatory language I offer restores the 75% to 25% compensation equation established through House **Bill** 92 in 2021.

Additionally, with enactment of the Montana Marijuana Regulation and Taxation Act (MMRTA) in 2021, certain acts relating to the possession of marijuana were decriminalized and persons convicted of those acts may petition for expungement of the conviction or for re-sentencing as a misdemeanor or civil infraction. Another amendment I offer clarifies that an individual seeking expungement of a felony conviction for a crime that is now legal under MMRTA is not eligible to seek compensation for a wrongful conviction.

Again, I appreciate your efforts to ensure we compensate Montanans who are wrongfully convicted and imprisoned for crimes they didn't commit. As a society, it is the right thing to do, and I respectfully ask for your support of this amendment.
