Later that year he ran for State Representative for House District 35, and he became the first Republican elected from Butte since 1950. He also was a guest lecturer and instructor at Montana Tech, construction chairman for the U.S. High Altitude Sports Center, a member of the Governor's Energy Task Force, the Montana Coal Council, and the Environmental Quality Council.

Haley loved his work but is most remembered by family and friends as an avid hunter, fisherman and outdoorsman. He could often be found floating the river or having early morning coffee with the "breakfast club," reminiscing about his travel adventures. He was a gentle giant, as strong as an ox, stubborn as a mule. Telling a good story and making all around him laugh was a specialty of Haley's. His own chuckle was contagious.

Bob Marks was born in Helena, the second son of Merle and Evelyn Marks on January 11, 1932. He was raised on the family ranch in Clancy, attending grade school there and then going on to high school at Jefferson County High School in Boulder. He learned his work ethic from his father while taking care of draft horses, threshing grain, milking cows, putting up hay, and other duties. Bob attended the University of Montana and Montana State until he decided higher education was not for him, and he pursued a career of ranching full time.

He married Barbara Myles in 1951, and they started their family of six children. While he loved ranch life, it did not support his family. He continued to use the old sawmill his father had put together for cutting mine timbers and construction work in the early 1900s and began harvesting logs and cutting lumber for his own property while selling lumber as a side business, which turned into Marks Lumber. "Art" Noonan on March 6, 2022 on Saturday, September 17, 2022 in Butte. He was 70 years old. It is fitting and proper that the record and accomplishments of the late Art Noonan be filed on the official records of this Assembly, and the following facts relative to his career are hereby noted:*

Art Noonan was born on November 24, 1951, one of six children of Edward J. and Sara L. Noonan. He grew up on Whitman Avenue, attended St. John's School and graduated from Butte Central High School in 1970.

In 1971 Art received statewide publicity for being the first young person to vote in Silver Bow County after the 1969 law lowering the voting age from 21 to 19. In his early twenties, he was invited to address several legislative sessions where he paced up and down the center aisles in period costume as Thomas Jefferson, extolling the virtues of the Declaration of Independence and the U.S. Constitution.

Art worked on the staff of former U.S. Representative Pat Williams, focusing on natural resources and wilderness issues. He also worked for Senator John Melcher. He ended his congressional career in Congressman Williams' Butte field office.

Art served three terms, the 2005, 2007 and 2009 sessions as a Democrat in the Montana House of Representatives from House District 73 in Butte. In 2007 he was the Democratic Floor Leader tasked with helping support the agenda of Governor Brian Schweitzer, who later named Art Deputy Director of Montana Fish, Wildlife and Parks from 2009 to 2011. Art was also the Executive Director of the Montana Democratic Party from 2007-2009. People have said about Art that he had "the knack to disagree vehemently without being disagreeable." At the time of his death, Art was once again running for House District 73.

Art served on the Butte-Silver Bow Planning Board and the Montana Supreme Court Commission on Practices. He was executive director of the AWARE Foundation and worked for Northwestern Energy advising the company on governmental affairs from 2012 until his retirement in 2017.

Art was preceded in death by his parents and brothers Ed and Larry. He is survived by his sisters Winifred Noonan, Sara Paul, brother Mark, nephews Pat Noonan, Dan Paul, Bryan Noonan and nieces Andrea Bottorff, Kate Williamsen and Kelley Paul. Art loved several cats throughout his life, and his most recent buddy, Skinny Cat, will miss him dearly.

## HAROLD LEE PAULSEN

Harold joined the Army in 1941. He was accepted to Officer Candidate School and received his commission as an air Force Statistical Officer from Harvard School of Business Administration. He served with the 8th Air Force in England for 28 months and was discharged in December 1945 with the rank of Captain.

After the service Harold began a long career in life insurance in Helena. In 2001 he was honored at the home office of The Hartford Company on the occasion of his 65th anniversary with the company, a longer tenure than any other individual. He belonged to the Jaycees and was inducted as a Charter Member of the National Jaycees Hall of Leadership at Tulsa, Oklahoma in 1983. He was devoted to his church, leading the effort to build a new church.

Harold served as a member was a member of the state legislature, and his children remember hanging campaign signs with their dad. He served in the House of Representatives during the 1957 and 1959 sessions.

Harold will be remembered for his great tenor voice. He sang for most of the Montana governors during his lifetime, and once shared the stage with the late Norman Vincent Peale. He sang in groups, choirs, recordings, and solo performances across the U.S. and in England, Norway, and Denmark. He was a featured singer at the Governor's Prayer breakfast from its start in the 1960s.

Harold was preceded in death by his parents, wife Betty and brothers Paul, Bud, Kenneth, Bill, and his sister Lillian "Sis" Duncan. He is survived by his four children and spouses, Peggy and Bill Honeck, Dick and Carol, Lee and Kristi, Jim and Jan, grandchildren, and great grandchildren. Within a week they had driven to Montana, made an offer on a house and some land to be used to build a manufacturing plant, and changed their license plate to Montana. They bought the house his wife still lives in.

Having been interested in politics since he was a young boy, Gary decided it was time to give back. He won a seat in the Montana State Senate in 2003 and served in the Senate through 2009. Senator Perry was famous for his 41-minute opening on a bill. He was a member of the Judiciary and Natural Resources committee. He also was chairman of the Gallatin County Republican Central Committee, the Chamber of Commerce, the Rotary, and the NRA.

Gary is survived by his wife Lisa and their son Travis.

## ARTHUR L. PETERSON

Shortly before going to Korea, he had married Connie Lucille Harr.

During a career which combined a continuing interest in higher education and politics, he served for 20 years as a college professor in the field of political science at the University of Wisconsin (Eau Claire) and Ohio Wesleyan, and as a college dean and president for 16 years at the American Graduate School of International Management, Lebanon Valley College, and Eckerd College. In the late 1990s Art served as the Scott Professor of Leadership at Rocky Mountain College in Billings. He was elected as a member of the 2001 State House of Representatives and served on the Appropriations Committee.

Art was preceded in death by his parents, brothers and sisters, his wife Connie of 50 years and a son. He is succeeded by his wife Mary as well as by her children and family, his children, grandchildren, and many friends.

## THOMAS PAUL "TOM" RICHMOND

## MARK ALLEN SWEENEY

*WHEREAS, it is with deep and sincere sorrow that the members of the Sixty-Eighth Legislative Assembly of the State of Montana record the passing of Mark Allen Sweeney on May 6th, 2022 at age 62. It is fitting and proper that the record and accomplishments of the late Mark Sweeney be filed on the official records of this Assembly, and the following facts relative to his career are hereby noted:*

Mark Sweeney was born in Butte on May 27, 1959, the youngest son of Jean and Bill Sweeney. Raised in Miles City, he hunted and fished on the eastern prairies. He went to Western Montana College in Dillon, where he wrestled and explored the mountain west.

After college he returned to Eastern Montana and worked at the Lower Yellowstone River Intake near Glendive for Montana Fish, Wildlife and Parks. He was responsible for establishing the river's walleye population, gathering walleye eggs downstream from the intake on the Yellowstone. Those eggs spawned the walleye program at Miles City fish hatchery.

That success led to Sweeney working to improve Montana fish populations as far west as Lake Koocanusa in Libby. He eventually became manager of the Washoe Park Trout Hatchery in Anaconda, where biologists developed the population of genetically pure west slope cutthroat used to re-populate the fish to their historic Montana territories.

Mark grew up on the Yellowstone River, hunting and navigating in a small kayak. "He was like a Huckleberry Finn," said his friend Chris Marchion of Anaconda. "He knew all the islands. He really knew that river. He would float all the time in that little kayak."

Mark's deeply seated values compelled him to serve the public. He began as a county commissioner, then a member of the Montana House of Representatives in the 2019 session and the State Senate in the 2021 session. He represented an area that stretches from Drummond to Walkerville in the northern reaches of Butte. He was engaged in a campaign for a seat in the U.S. House of Representatives at the time of his death.

Mark is survived by his wife Sue; his daughters Shannon and Jordan; his stepdaughters Brandi Johnson and Carly Johnson; his grandsons Weston and Brooks; his father-in-law Vic Standa; his siblings Judy and Perry Wolfe, Bill and Lana Sweeney, Joan and Dale Hubber; in-laws Frank and Becky Standa, Jack and Nia Standa, Leigh and Scott McOmber; numerous nieces and nephews and their children.

## **WILLIAM G. (BILL) THOMAS**

His entrepreneurial spirit led him to become a successful small business owner of Granny's Pie House, It'll Do Bar, Iron Kettle restaurant and oil drilling endeavors. He served as a member of the Montana House of Representatives in the 1975 session and in the State Senate during the 1977, 1979, 1981 and 1982 sessions.

He was an educator for 30 years and served as President of the State Board of Education where he championed the Montana School for the Deaf and Blind. He was particularly fond of helping countless friends and family in navigating intricate ways to afford higher education. He had a strong Catholic faith, having spent time in the seminary in his youth and as a lifelong parishioner of Holy Spirit Church.

Bill enjoyed a variety of activities including politics, investing, both water and snow skiing, yearly boating outings with his family at Seeley Lake. He had a passion for football, the Green Bay Packers and the Notre Dame Fighting Irish. He enjoyed and always made time to mentor his political friends and colleagues. He also spent time volunteering at St. Thomas Orphanage, Great Falls Rotary, and many roles in organizing the Montana East/West Shrine Football Game.

Bill was best known for his big heart, deep belly laugh, and infectious smile. He was preceded in death by his loving parents and his brother-in-law, Hollis Broderick. He is survived by his beloved wife of 53 years, Patsie Bartoletti-Thomas, his sister Colleen Broderick, his children Patti Monts, William G. (Jen) Thomas II, Mary Pat (Tim) Penley, Marty (Rebecca), Brad, and Stephanie (Justin); his grandchildren Kim, Katie, Kyle, Bryce, Amanda, Thomas, Edward, Terra, Joseph, Taylor, Gabe, Kate, William J. It is fitting and proper that the record and accomplishments of the late Gene Vuckovich filed on the official records of this Assembly, and the following facts relative to his career are hereby noted:*

Gene Vuckovich was born in Anaconda on March 9, 1936, to Daniel and Donnie (Elakovich) Vuckovich. He joined his older siblings Jack and Nada to create a loving family unit with a fierce devotion to one another. He was only 7 years old when his father suddenly passed away, but he believed these hard times helped develop his strong work ethic, sense of service to others and dedication to his community.

He met the beautiful and charming Noreen Opie at high school, and she became the love of his life. They were married on August 31, 1957. He received a scholarship from Western Montana College, earning a Bachelor of Arts degree in education, majoring in English and social studies. He completed graduate work at the University of Montana and University of Utah, earning a Master of Science degree in mathematics and physics. He taught and coached in the Anaconda school system and also worked as a journeyman ironworker in the summer and school breaks to help support his family. He felt privileged to be part of the crew of "men on the mountain," a group of ironworkers from Local 81 that helped assemble Our Lady of the Rockies.

Gene changed career paths and served as the Director of the Montana Concentrated Employment Program, and for over 16 years served as the Director/Coordinator for the Montana Ironworkers' Apprenticeship Program. He was City/County Manager of Anaconda/Deer Lodge County and was instrumental in seeing the Old Works Golf Course built on a superfund cleanup site. His last job was Executive Director for Montana Rural Development Partners.

After retirement Gene ran for an open seat in the Montana State Senate. He served in the Senate during the 2011 through 2019 sessions working on the Business, Energy and Local Government committees.

Gene was preceded in death by his parents; wife Noreen; stepfather George Schimmings; in-laws William and Kathryn Opie-Mertzig and Kathryn's second husband Louie Mertzig, brother-in-law Ray Sherrill, sister-in-law Vi Vuckovich, infant son William Eugene Vuckovich Jr. and grandson Jeremy Funston.
