5 A BILL FOR AN ACT ENTITLED: "AN ACT REVISING THE POWERS, DUTIES, TERMS, DESIGNATIONS,  
6 APPOINTMENTS, OPERATIONS, AND JURISDICTION OF THE WATER COURT; PROVIDING FOR THE  
7 GOVERNOR'S APPOINTMENT OF WATER JUDGES; PROVIDING FOR WATER COURT JURISDICTION  
8 OVER WATER DISTRIBUTION; REVISING THE APPOINTMENT OF WATER COMMISSIONERS;  
9 DESIGNATING WATER JUDGES TO WATER DIVISIONS; PROVIDING THAT WATER JUDGES ENFORCE  
10 FINAL DECREES; PROVIDING FOR A WATER COURT ADMINISTRATOR; REVISING THE POWERS AND  
11 DUTIES OF WATER MASTERS; REVISING THE PROCESS TO PETITION FOR DEPARTMENT ACTION ON  
12 UNPERFECTED WATER RIGHTS; REVISING JUDICIAL REVIEW OF CERTAIN CONTESTED CASES;  
13 PROVIDING DEFINITIONS; PROVIDING RULEMAKING AUTHORITY; AMENDING SECTIONS 2-4-702, 3-1-  
14 101, 3-1-901, 3-1-905, 3-7-101, 3-7-102, 3-7-103, 3-7-201, 3-7-202, 3-7-203, 3-7-204, 3-7-211, 3-7-212, 3-7-

21 WHEREAS, Article VII, section 1, of the Montana Constitution provides that the "judicial power of the  
22 state is vested in one supreme court, district courts, justice courts, and such other courts as may be provided  
23 by law"; and

24 WHEREAS, the Montana Legislature possesses the authority to constitute a water court and similarly  
25 set forth mechanisms for the appointment and election of judges for the court; and

26 WHEREAS, neither the Water Court nor its judgeships are mandated or created by the Montana  
27 Constitution but rather are judgeships maintained by the Montana Legislature.

1 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

3 **Section 1.** Section 2-4-702, MCA, is amended to read:

4 **"2-4-702. (Temporary) Initiating judicial review of contested cases.** (1) (a) Except as provided in  
5 75-2-213 and 75-20-223, a person who has exhausted all administrative remedies available within the agency  
6 and who is aggrieved by a final written decision in a contested case is entitled to judicial review under this  
7 chapter. This section does not limit use of or the scope of judicial review available under other means of review,  
8 redress, relief, or trial de novo provided by statute.

9 (b) A party who proceeds before an agency under the terms of a particular statute may not be  
10 precluded from questioning the validity of that statute on judicial review, but the party may not raise any other  
11 question not raised before the agency unless it is shown to the satisfaction of the court that there was good  
12 cause for failure to raise the question before the agency.

13 (2) (a) Except as provided in 75-2-211, 75-2-213, and subsections (2)(c) and (2)(e) of this section,  
14 proceedings for review must be instituted by filing a petition in district court within 30 days after service of the  
15 final written decision of the agency or, if a rehearing is requested, within 30 days after the written decision is  
16 rendered. Except as otherwise provided by statute, subsection (2)(d), or subsection (2)(e), the petition must be  
17 filed in the district court for the county where the petitioner resides or has the petitioner's principal place of  
18 business or where the agency maintains its principal office. Copies of the petition must be promptly served  
19 upon the agency and all parties of record.

20 (b) The petition must include a concise statement of the facts upon which jurisdiction and venue  
21 are based, a statement of the manner in which the petitioner is aggrieved, and the ground or grounds specified  
22 in 2-4-704(2) upon which the petitioner contends to be entitled to relief. The petition must demand the relief to  
23 which the petitioner believes the petitioner is entitled, and the demand for relief may be in the alternative.

24 (c) If a petition for review is filed pursuant to 33-16-1012(2)(c), the workers' compensation court,  
25 rather than the district court, has jurisdiction and the provisions of this part apply to the workers' compensation  
26 court in the same manner as the provisions of this part apply to the district court.

27 (d) If a petition for review is filed challenging a licensing or permitting decision made pursuant to  
28 Title 75 or Title 82, the petition for review must be filed in the county where the facility is located or proposed to

1 be located or where the action is proposed to occur.

2 (e) (i)–A party who is aggrieved by a final decision on an application for a permit or change in  
3 appropriation right filed under Title 85, chapter 2, part 3, may petition ~~the district court or the water court for~~  
4 judicial review of the decision. The water court has jurisdiction over the petitions and the provisions of this part  
5 apply. If a petition for judicial review is filed in the water court, the water court rather than the district court has  
6 jurisdiction and the provisions of this part apply to the water court in the same manner as they apply to the  
7 district court. The time for filing a petition is the same as provided in subsection (2)(a).

8 (ii) ~~If more than one party is aggrieved by a final decision on an application for a permit or change in~~  
9 ~~appropriation right filed under Title 85, chapter 2, part 3, the district court where the appropriation right is~~  
10 ~~located has jurisdiction. If more than one aggrieved party files a petition but no aggrieved party files a petition in~~  
11 ~~the district court where the appropriation right is located, the first judicial district, Lewis and Clark County, has~~  
12 ~~jurisdiction.~~

13 (iii) ~~If a petition for judicial review is filed in the district court, the petition for review must be filed in the~~  
14 ~~district court in the county where the appropriation right is located.~~

15 (3) Unless otherwise provided by statute, the filing of the petition may not stay enforcement of the  
16 agency's decision. The agency may grant or the reviewing court may order a stay upon terms that it considers  
17 proper, following notice to the affected parties and an opportunity for hearing. A stay may be issued without  
18 notice only if the provisions of 27-19-315 through 27-19-317 are met.

19 (4) Within 30 days after the service of the petition or within further time allowed by the court, the  
20 agency shall transmit to the reviewing court the original or a certified copy of the entire record of the proceeding  
21 under review. By stipulation of all parties to the review proceedings, the record may be shortened. A party  
22 unreasonably refusing to stipulate to limit the record may be required by the court to pay the additional costs.  
23 The court may require or permit subsequent corrections or additions to the record. ~~(Terminates September 30,~~

25 **2-4-702. (Effective October 1, 2025) Initiating judicial review of contested cases.** (1) (a) Except

5 **Section 2.** Section 3-1-101, MCA, is amended to read:

6 **"3-1-101. The several courts of this state.** The following are courts of justice of this state:

7 (1) the court of impeachment, which is the senate;

8 (2) the supreme court;

9 (3) the district courts;

10 (4) the municipal courts;

11 (5) the justices' courts;

12 (6) the water court; and

13 ~~(6)(7)~~ the city courts and such other courts of limited jurisdiction as the legislature may establish in  
14 any incorporated city or town."  
15

16 **Section 3.** Section 3-1-901, MCA, is amended to read:

17 **"3-1-901. Judicial vacancy -- notice.** (1) (a) ~~Upon~~On receiving notice from the chief justice of the  
18 supreme court, the governor shall appoint a candidate, as provided in this part, to fill any vacancy on the  
19 supreme court or the district court.

20 (b) ~~The chief justice of the supreme court~~governor shall appoint a candidate to fill any water judge  
21 term or vacancy ~~for the chief water judge or associate water judge~~ pursuant to 3-7-221.

22 (2) Within 10 days of the date of receipt by the governor of the notice from the chief justice of the  
23 supreme court that a vacancy has occurred or the effective date of a judicial resignation has been announced,  
24 the governor shall notify the public, including media outlets with general statewide circulation and other  
25 appropriate sources, that a vacancy has been announced, including the deadline within which applications must  
26 be received."  
27

28 **Section 4.** Section 3-1-905, MCA, is amended to read:

1           **"3-1-905. Appointments.** (1) The governor, ~~or the chief justice of the supreme court for the office~~  
2 ~~described in 3-7-224,~~ shall make an appointment within 30 days of the close of the public comment period from  
3 the list of applicants.

4           (2) For the purposes of Article VII, section 8, of the Montana constitution, the governor must be  
5 construed to receive the names of the nominees at the close of the public comment period provided for in 3-1-  
6 904.

7           (3) If the governor fails to appoint within 30 days of the close of the public comment period  
8 provided for in subsection (1), the chief justice shall make the appointment from the same list of applicants  
9 within 30 days of the governor's failure to appoint."

10  
11           NEW SECTION. Section 5. Definitions. As used in this chapter, the following definitions apply:

12           (1) "Water court" means a court comprised of four water division courts that preside over water  
13 disputes and controversies that arise within the boundaries of the water division as described in 3-7-102.

14           (2) "Water judge" means a judge presiding over any matter under 3-7-101 in a water division.

15  
16           **Section 6.** Section 3-7-101, MCA, is amended to read:

17           **"3-7-101. ~~Water divisions~~ Powers and duties of water court.** ~~To adjudicate existing water rights~~  
18 ~~and to conduct hearings in cases certified under 85-2-309, water divisions are established as defined in 3-7-~~  
19 ~~402.~~ A water division shall be presided over by a water judge one or more water judges. A water judge WATER  
20 JUDGES of the water court shall:

21           (1) \_\_\_\_\_ prior to and including the issuance of a final decree in a basin pursuant to 85-2-234 and 85-2-  
22 235, administer the adjudication of existing water rights in the basin by:

23           (a) \_\_\_\_\_ coordinating with the department of natural resources and conservation to:

24           (i) \_\_\_\_\_ compile information submitted on water claim forms under Title 85, chapter 2, part 2; and

25           (ii) \_\_\_\_\_ expeditiously and properly transfer that information to the water judge in each division; and

26           (b) \_\_\_\_\_ ensuring any contested or conflicting claims are expeditiously tried and adjudicated.

27           (2) \_\_\_\_\_ conduct proceedings for petitions for judicial review filed with the water court under 2-4-

28 702(2)(e);

- 1           (3) review decisions made by a compact board or other administrative entity as provided in Title  
2 85, chapter 20;
- 3           (4) review motions brought pursuant to Rule 59 or 60, M.R.Civ.P., concerning the adjudication of  
4 an existing water right and orders pursuant to 85-2-234(8);
- 5           (5) hear and resolve disputes arising under the interpretation of a final decree issued under 85-2-  
6 234;
- 7           (6) hear and resolve issues related to judicial enforcement actions for waste, unlawful use,  
8 interference, or other violations pursuant to 85-2-114 and 85-2-122;
- 9           (7) hear and resolve issues related to enforcement actions brought pursuant to common law  
10 remedies, including but not limited to the waste of water, unlawful use of water, abandonment, or interference  
11 with the use of water, including the right to injunctive relief under Title 27, chapter 19;
- 12           (8) conduct abandonment proceedings under 85-2-404 and 85-2-405;
- 13           (9) hear and determine matters related to ~~objections to permits or changes in appropriation rights~~  
14 FACTUAL AND LEGAL ISSUES INVOLVING THE ADJUDICATION OR DETERMINATION OF WATER RIGHTS certified to the water  
15 court under 85-2-309;
- 16           (10) hear and determine matters related to a dispute over ownership of a water right certified to the  
17 water court under 85-2-424(9);
- 18           (11) hear and determine rights and issues related to water distribution controversies under 85-2-  
19 406;
- 20           (12) appoint and supervise water commissioners or water mediators under Title 85, chapter 5;
- 21           (13) hear and resolve ditch easement matters ancillary to a water right dispute or controversy, as a  
22 water right is defined in 85-2-102;
- 23           (14) promulgate rules for use across all water divisions for practice and procedure pursuant to Title  
24 3, chapter 7;
- 25           (15) prescribe forms for use pursuant to Title 3, chapter 7; and
- 26           (16) determine and interpret existing water rights, including without limitation the adjudication of total  
27 or partial abandonment of existing water rights occurring at any time."

1           **Section 7.** Section 3-7-102, MCA, is amended to read:

2           **"3-7-102. Water ~~divisions~~ court division boundaries.** There are four water court divisions whose  
3 boundaries are formed by the natural divides between drainages and the borders of the state of Montana and  
4 which are described as follows:

5           (1)     The Yellowstone River basin water division consists of those areas drained by the Yellowstone  
6 and Little Missouri Rivers and any remaining areas in Carter County.

7           (2)     The lower Missouri River basin water division consists of those areas drained by the Missouri  
8 River from below the mouth of the Marias River and any remaining areas in Glacier and Sheridan Counties.

9           (3)     The upper Missouri River basin water division consists of those areas drained by the Missouri  
10 River to below the mouth of the Marias River.

11          (4)     The Clark Fork River basin water division consists of the areas drained by the Clark Fork River,  
12 the Kootenai River, and any remaining areas in Lincoln County."

13

14          **Section 8.** Section 3-7-103, MCA, is amended to read:

15          **"3-7-103. Promulgation of rules and prescription of forms -- advisory committee.** (1) As soon as  
16 practicable the Montana supreme court may promulgate special rules of practice and procedure and shall  
17 prescribe forms for use ~~in connection with this chapter~~ with 3-7-101(1) and Title 85, chapter 2, parts 2 and 7, in  
18 consultation with the chief water judge and the department of natural resources and conservation.

19          (2)     (a) The chief water judge shall appoint a water adjudication advisory committee to provide  
20 recommendations to the water court, the Montana supreme court, the department of natural resources and  
21 conservation, and the legislature on methods to improve and expedite the water adjudication process.

22          (b)     The committee consists of three nongovernmental attorneys who practice before the water  
23 court, one district court judge, and three water users who have filed statements of claim with the department of  
24 natural resources and conservation under this chapter.

25          (c)     The chief water judge or the judge's designee shall serve as an ex officio member of the  
26 committee. The Montana supreme court may appoint the attorney general or the attorney general's designee, a  
27 representative from the department of natural resources and conservation, and a representative of the United  
28 States government as ex officio members of the committee.



1 (d) The committee members shall serve at the pleasure of the water court and shall serve without  
2 compensation.

3 (e) The committee shall file a report with the Montana supreme court ~~by October 1, 1996, and as~~  
4 often as determined by the Montana supreme court."  
5

6 NEW SECTION. Section 9. Venue for water rights determinations. All matters under 3-7-101(2)  
7 through (16) must be brought before or immediately transferred to the water judge in the appropriate water  
8 division. Any proceedings for matters arising under 3-7-101(2) through (16) must be conducted within the water  
9 division or county in which the controversy arises unless otherwise determined by mutual agreement of the  
10 parties.  
11

12 **Section 10.** Section 3-7-201, MCA, is amended to read:

13 **"3-7-201. Designation of water judge.** (1) A water judge must be designated for each water division  
14 ~~by a majority vote of a committee composed of the district court judge from each single judge judicial district~~  
15 ~~and the chief district judge from each multijudge judicial district, wholly or partly within the division. Except as~~  
16 ~~provided in subsection (2), a water judge must be a district court judge or retired district court judge of a judicial~~  
17 ~~district wholly or partly within the water division~~ subject to the terms of office in 3-7-221.

18 (2) A district court judge, ~~or retired district court judge,~~ retired water judge, or water judge  
19 appointed to another water division may sit as a substitute water judge ~~in more than one division~~ if requested by  
20 the chief justice of the supreme court or the water judge of the division in which the judge is requested to sit. A  
21 substitute water judge has the same powers as a water judge appointed pursuant to 3-7-221.

22 (3) A water judge, when presiding over a water division, ~~presides~~ has as the duties and powers of a  
23 district court judge in and for each judicial district wholly or partly within the water division, including the ability  
24 to appoint a judge pro tempore and standing masters pursuant to Title 3, chapter 5, part 1."  
25

26 **Section 11.** Section 3-7-202, MCA, is amended to read:

27 **"3-7-202. Term of office.** ~~The~~ On a retention election pursuant to 13-14-212 PURSUANT TO 3-5-203,  
28 the term of office for water judges is from the date of initial appointment as provided in 3-7-201 to June 30,

1 1985. After June 30, 1985, the term of office of a water judge is 4 years, subject to continuation of the water  
2 divisions by the legislature a water judge is 6 years."

3

4 **Section 12.** Section 3-7-203, MCA, is amended to read:

5 **"3-7-203. Vacancies.** (1) If a vacancy in the office of water judge occurs, it must be filled in the  
6 manner provided in ~~3-7-204~~ for the initial designation of a water judge ~~3-1-904~~ TITLE 3, CHAPTER 1, PART 9.

7 (2) ~~(A) The senate shall confirm each appointment made pursuant to 3-1-901 and 3-1-905~~ AN  
8 APPOINTMENT OF A WATER JUDGE IS SUBJECT TO SENATE CONFIRMATION AT THE NEXT REGULAR LEGISLATIVE SESSION,  
9 EXCEPT FOR AN APPOINTMENT MADE WHILE THE LEGISLATURE IS NOT IN REGULAR SESSION, FOR WHICH THE  
10 APPOINTMENT EXPIRES PRIOR TO THE NEXT REGULAR LEGISLATIVE SESSION.

11 (B) An appointment made while the senate is not in session is effective until the end of the next  
12 legislative session.

13 (3) ~~Except in basins that contain existing water rights pursuant to Title 85, chapter 20, part 10,~~  
14 ~~prior to the issuance of final decrees in all basins pursuant to 85-2-234 and 85-2-235, and after the appointment~~  
15 ~~and confirmation of a water judge, that water judge is subject to a statewide retention election pursuant to 13-~~  
16 ~~14- 212 to be held on the next general election day in an even-numbered year.~~ PRIOR TO THE ISSUANCE OF FINAL  
17 DECREES IN ALL BASINS PURSUANT TO 85-2-234 AND 85-2-235, EXCEPT IN BASINS THAT CONTAIN EXISTING WATER  
18 RIGHTS PURSUANT TO TITLE 85, CHAPTER 20, PART 10, AND AFTER APPOINTMENT BY THE GOVERNOR AND  
19 CONFIRMATION BY THE SENATE OF A WATER JUDGE, AT THE END OF THE WATER JUDGE'S TERM THE JUDGE MUST BE AN  
20 UNOPPOSED INCUMBENT CANDIDATE IN A STATEWIDE RETENTION ELECTION. THE BALLOT MUST FOLLOW THE FORM  
21 PROVIDED IN 13-14-212. THE ELECTION MUST BE HELD ON THE NEXT GENERAL ELECTION DAY IN AN EVEN-NUMBERED  
22 YEAR.

23 (4) ~~Except in basins that contain existing water rights pursuant to Title 85, chapter 20, part 10,~~  
24 ~~prior to the issuance of final decrees in all basins pursuant to 85-2-234 and 85-2-235, and after the appointment~~  
25 ~~and confirmation of a water judge, that water judge is subject to a retention election pursuant to 13-14-212 to be~~  
26 ~~held on the next general election day in an even-numbered year within the assigned water division.~~ AFTER THE  
27 ISSUANCE OF FINAL DECREES IN BASINS PURSUANT TO 85-2-234 AND 85-2-235, EXCEPT IN BASINS THAT CONTAIN  
28 EXISTING WATER RIGHTS PURSUANT TO TITLE 85, CHAPTER 20, PART 10, AND AFTER APPOINTMENT BY THE GOVERNOR

1 AND CONFIRMATION BY THE SENATE OF A WATER JUDGE, AT THE END OF THE WATER JUDGE'S TERM THE JUDGE MUST BE  
2 AN UNOPPOSED INCUMBENT CANDIDATE IN A RETENTION ELECTION TO BE HELD ON THE NEXT GENERAL ELECTION DAY IN  
3 AN EVEN-NUMBERED YEAR WITHIN THE ASSIGNED WATER DIVISION. THE BALLOT MUST FOLLOW THE FORM PROVIDED IN  
4 13-14-212.

5 (5) A vacancy is created when a water judge dies, resigns, retires, is not ~~elected to a subsequent~~  
6 ~~term~~ RETAINED IN A RETENTION ELECTION, forfeits the judicial position, is removed, or is otherwise unable to  
7 complete the term as a water judge."

8

9 **Section 13.** Section 3-7-204, MCA, is amended to read:

10 **"3-7-204. Supervision and administration by supreme court.** (1) The Montana supreme court shall  
11 supervise the activities of the water judges, ~~water masters~~, and associated water court personnel in  
12 implementing this chapter and Title 85, chapter 2, part 2.

13 (2) The supreme court shall pay the salaries and expenses of the water judges and ~~the salaries~~  
14 ~~and expenses of the water judges' staffs and the salaries and expenses of the water masters and the water~~  
15 ~~masters' staffs, from appropriations made for that purpose~~ associated water court personnel. "Salaries and  
16 expenses" as used in this section include but are not limited to the salaries and expenses of personnel, the cost  
17 of office equipment and office space, and other necessary expenses that may be incurred in the administration  
18 of this chapter and Title 85, chapter 2, part 2.

19 (3) A water judge must receive the same salary and expense allowance as provided for a district  
20 court judge pursuant to 3-5-211.

21 (4) The office of the water court, as described in 3-7-223, must be at a location designated by the  
22 chief justice of the Montana supreme court. "

24 **Section 14.** Section 3-7-211, MCA, is amended to read:
