8 A BILL FOR AN ACT ENTITLED: "AN ACT ESTABLISHING THE MONTANA END OF WATCH TRUST AND
9 PROVIDING RELATED SUPPORTS; CREATING A STATE SPECIAL REVENUE ACCOUNT; CREATING AN
10 OVERSIGHT BOARD THAT IS ATTACHED TO THE DEPARTMENT OF JUSTICE FOR ADMINISTRATIVE
11 PURPOSES; PROVIDING FOR LOCAL GOVERNMENT AND STATE GOVERNMENT PAYMENTS FOR
12 HEALTH INSURANCE BENEFITS WHEN AN OFFICER IS CATASTROPHICALLY INJURED OR DIES;
13 PROVIDING THAT A BENEFIT RECEIVED FROM THE TRUST IS NOT TAXABLE INCOME; PROVIDING
14 FOR RETROACTIVE PAYMENTS FROM THE TRUST; PROVIDING DEFINITIONS; SUPERSEDING THE
15 UNFUNDED MANDATE LAWS; AMENDING SECTIONS 2-18-704, 15-30-2110, ~~AND 15-30-2120~~, AND 25-13-
16 608, MCA; PROVIDING A FUND TRANSFER; PROVIDING AN APPROPRIATION; AND PROVIDING
17 EFFECTIVE DATES AND A RETROACTIVE APPLICABILITY DATE."

19 WHEREAS, Montana law enforcement officers are charged with the enforcement of the laws of the
20 State of Montana as determined by the Montana State Legislature; and

21 WHEREAS, law enforcement officers put their lives on the line each day to protect the people of
22 Montana; and

23 WHEREAS, line of duty deaths and catastrophic injuries often leave behind dependent family members
24 who are struggling to cope mentally, emotionally, and financially with the trauma of a line of duty death or to
25 provide care to a catastrophically injured spouse; and

26 WHEREAS, the State of Montana does not currently provide a line of duty death or catastrophic injury
27 benefit to officers or their families when one of these tragedies occurs.

1 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

2

3 NEW SECTION. Section 1. Definitions. For the purposes of [sections 1 through 4 ~~5~~ 6], the following
4 definitions apply:

5 (1) "Board" means the Montana end of watch trust board established in [section ~~3~~ 4 ~~5~~].

6 (2) "Catastrophic injury" means an injury directly related to an individual's required employment
7 duties with direct or proximate consequences that renders the individual in need of 24-hour care, permanently
8 incapacitates the individual, and permanently prevents the individual from performing any gainful work.

9 (3) "Department" means the department of justice.

10 (4) "Immediate family" means a law enforcement officer's spouse and dependent children under
11 age 18, including children to whom the law enforcement officer is a legal guardian.

12 (5) "In the line of duty" means an action taken by a law enforcement officer or an activity in which a
13 law enforcement officer participated:

14 (a) as required or authorized by law, rule, regulation, condition of employment, or professional
15 ethics; and

16 (b) for which compensation is provided by the officer's employer or would have been provided by
17 the officer's employer if the officer had been on duty at the time the action in question was taken.

18 (6) "Law enforcement officer" ~~has the same meaning as provided in 7-32-201~~ MEANS:

19 (A) A POLICE OFFICER, DEPUTY SHERIFF, UNDERSHERIFF, HIGHWAY PATROL OFFICER, INVESTIGATOR
20 APPOINTED BY THE DEPARTMENT OF JUSTICE, FISH AND GAME WARDEN, PARK RANGER, OR OTHER PUBLIC SAFETY
21 OFFICER CERTIFIED BY THE PUBLIC SAFETY OFFICER STANDARDS AND TRAINING COUNCIL; OR

22 (B) AN ELECTED A SHERIFF.

23

24 NEW SECTION. Section 2. Montana end of watch trust benefits -- responsibilities of board of
25 investments -- responsibilities of department of justice. (1) (a) There is a Montana end of watch trust within
26 the permanent fund type for the purpose of supporting eligible law enforcement officers and their surviving
27 immediate family in the event of an officer's death or catastrophic injury in the line of duty.

28 (b)(2) The department may accept contributions and gifts for the trust in money or other forms. When

1 accepted, the contributions and gifts must be deposited in the trust.

2 ~~(e)(3)~~ The legislature may transfer money to the trust.

3 ~~(d)(4)~~ ~~Interest and income earned on money in the trust must be retained within the trust. THE STATE~~
4 ~~TREASURER SHALL EACH MONTH TRANSFER FROM THE TRUST TO THE ACCOUNT ESTABLISHED IN [SECTION 3] THE~~
5 ~~AMOUNT OF EARNINGS, EXCLUDING UNREALIZED GAINS AND LOSSES, REQUIRED TO MEET THE OBLIGATIONS OF THE~~
6 ~~STATE THAT ARE PAYABLE FROM THE ACCOUNT. EARNINGS NOT TRANSFERRED TO THE ACCOUNT ESTABLISHED IN~~
7 ~~[SECTION 3] MUST BE RETAINED IN THE TRUST ACCOUNT. ANY UNEXPENDED INTEREST THAT TRANSFERS BACK INTO THE~~
8 ~~TRUST CAN BE APPROPRIATED IF MONTHLY OBLIGATIONS EXCEED THE CURRENT AVAILABLE INTEREST IN THE ACCOUNT.~~
9 ~~IF THIS PORTION OF THE TRUST IS APPROPRIATED IN ANY FISCAL YEAR, THE STATE TREASURER SHALL TRANSFER THAT~~
10 ~~SAME AMOUNT FROM THE GENERAL FUND TO THE TRUST IN THE FOLLOWING FISCAL YEAR.~~

11 ~~(e)(5)~~ ~~The trust is overseen by the board as provided in [section 3]. MONEY THE BOARD OF~~
12 ~~INVESTMENTS SHALL INVEST MONEY DEPOSITED IN THE FUND ESTABLISHED UNDER THIS SECTION MUST BE INVESTED BY~~
13 ~~THE BOARD OF INVESTMENTS AS PROVIDED BY LAW.~~

14 (2) — The board of investments shall:

15 (a) — manage the trust;

16 (b) — report the annual available balance, changes in the trust's earnings, and any other pertinent
17 financial information to the end of watch trust board established in [section 3] and the department by June 30 of
18 each year;

19 (c) — reinvest into the trust all interest generated by the trust when there are no eligible recipients
20 during a fiscal year; and

21 (d) — allow the department to administer benefits from the interest generated by the trust when there
22 are eligible recipients during a fiscal year.

23 (3) — The department shall disburse payments to an officer's designated beneficiary, as indicated by
24 the officer on a form provided by the department.

25 (4) — (a) Loss payments for a catastrophic injury or death in the line of duty must be made monthly
26 for 5 calendar years from the date of the injury or death.

27 (b) — The minimum monthly payment is \$8,000 and must be increased in accordance with the
28 consumer price index.

1 ~~(5) — The money in the account is subject to legislative appropriation.~~

3 NEW SECTION. SECTION 3. MONTANA END OF WATCH ACCOUNT -- PAYMENT AND CESSATION OF

4 PAYMENT. (1) THERE IS A MONTANA END OF WATCH STATE SPECIAL REVENUE ACCOUNT WITHIN THE STATE SPECIAL
5 REVENUE FUND ESTABLISHED IN 17-2-102 ADMINISTERED BY THE DEPARTMENT OF JUSTICE. PURSUANT TO [SECTION 2],
6 ALL INTEREST AND EARNINGS FROM THE TRUST FUND ESTABLISHED IN [SECTION 2] MUST BE DEPOSITED INTO THIS FUND.

7 ~~(2) — THE DEPARTMENT OF JUSTICE SHALL DISBURSE PAYMENTS TO AN OFFICER'S DESIGNATED~~
8 ~~BENEFICIARY, AS INDICATED BY THE OFFICER ON A FORM PROVIDED BY THE DEPARTMENT.~~

9 ~~(3) — (A) LOSS PAYMENTS FOR A CATASTROPHIC INJURY OR DEATH IN THE LINE OF DUTY MUST BE MADE~~
10 ~~MONTHLY FOR 5 CALENDAR YEARS FROM THE DATE OF THE INJURY OR DEATH.~~

11 ~~(B) — THE MINIMUM MONTHLY PAYMENT IS \$8,000 AND MUST BE INCREASED IN ACCORDANCE WITH THE~~
12 ~~CONSUMER PRICE INDEX ON AN ANNUAL BASIS.~~

13 ~~(2) — THE DEPARTMENT OF JUSTICE SHALL DISBURSE PAYMENTS TO A QUALIFYING LAW ENFORCEMENT~~
14 ~~OFFICER OR THE LAW ENFORCEMENT OFFICER'S IMMEDIATE FAMILY AS PROVIDED IN THIS SECTION.~~

15 ~~(3) — (A) PAYMENTS FOR A CATASTROPHIC INJURY IN THE LINE OF DUTY MUST BE MADE TO A~~
16 ~~CATASTROPHICALLY INJURED LAW ENFORCEMENT OFFICER ON A MONTHLY BASIS FOR 60 MONTHS FROM THE DATE OF~~
17 ~~THE INJURY.~~

18 ~~(B) — IN THE EVENT THE CATASTROPHICALLY INJURED LAW ENFORCEMENT OFFICER DIES PRIOR TO~~
19 ~~RECEIVING ALL 60 MONTHLY PAYMENTS, THE DEPARTMENT SHALL PAY ON A MONTHLY BASIS THE REMAINDER OF THE 60~~
20 ~~MONTHLY PAYMENTS TO THE LAW ENFORCEMENT OFFICER'S IMMEDIATE FAMILY AS FOLLOWS:~~

21 ~~(i) — TO THE LAW ENFORCEMENT OFFICER'S SURVIVING SPOUSE UNTIL THE SURVIVING SPOUSE REMARRIES~~
22 ~~OR DIES; OR~~

23 ~~(ii) — IF THERE IS NO SURVIVING SPOUSE OR IF THE SURVIVING SPOUSE REMARRIES OR DIES PRIOR TO THE~~
24 ~~DISBURSEMENT OF ALL 60 MONTHLY PAYMENTS, THEN THE REMAINDER OF THE 60 MONTHLY PAYMENTS MUST BE MADE~~

27 ~~(C) — IN THE EVENT THERE IS NO SURVIVING SPOUSE THAT HAS NOT REMARRIED OR SURVIVING DEPENDENT~~
28 ~~CHILDREN UNDER 18 YEARS OF AGE, THE PAYMENTS MUST CEASE.~~

1 (4) (A) PAYMENTS FOR A LAW ENFORCEMENT OFFICER KILLED IN THE LINE OF DUTY MUST BE MADE TO THE
2 LAW ENFORCEMENT OFFICER'S SURVIVING IMMEDIATE FAMILY ON A MONTHLY BASIS FOR 60 MONTHS FROM THE DATE OF
3 THE LAW ENFORCEMENT OFFICER'S DEATH. THE DEPARTMENT SHALL MAKE THE PAYMENTS AS FOLLOWS:

4 (i) TO THE LAW ENFORCEMENT OFFICER'S SURVIVING SPOUSE UNTIL THE SURVIVING SPOUSE REMARRIES
5 OR DIES;

6 (ii) IF THERE IS NO SURVIVING SPOUSE OR IF THE SURVIVING SPOUSE REMARRIES OR DIES PRIOR TO
7 DISBURSEMENT OF ALL 60 MONTHLY PAYMENTS, THEN THE REMAINDER OF THE 60 MONTHLY PAYMENTS MUST BE MADE
8 TO THE LAW ENFORCEMENT OFFICER'S SURVIVING DEPENDENT CHILDREN UNDER 18 YEARS OF AGE, IN EQUAL SHARES,
9 AND SUBJECT TO THE UNIFORM TRANSFERS TO MINORS ACT PROVIDED FOR IN TITLE, 72, CHAPTER 26.

10 (B) IN THE EVENT THERE IS NO SURVIVING SPOUSE THAT HAS NOT REMARRIED OR SURVIVING DEPENDENT
11 CHILDREN UNDER 18 YEARS OF AGE, THE PAYMENTS MUST CEASE.

12 (5) (A) FOR THE FIRST 12 MONTHS FOLLOWING THE DATE OF THE CATASTROPHIC EVENT OR DEATH, THE
13 MONTHLY PAYMENT DUE TO A QUALIFYING LAW ENFORCEMENT OFFICER OR THE LAW ENFORCEMENT OFFICER'S
14 IMMEDIATE FAMILY UNDER THIS SECTION IS \$7,000 A MONTH.

15 (B) FOR MONTHS 13 THROUGH 60 FOLLOWING THE DATE OF THE CATASTROPHIC EVENT OR DEATH, THE
16 MONTHLY PAYMENT DUE TO A QUALIFYING LAW ENFORCEMENT OFFICER OR THE LAW ENFORCEMENT OFFICER'S
17 IMMEDIATE FAMILY UNDER THIS SECTION IS:

18 (i) \$7,000, SUBJECT TO AN ANNUAL INCREASE ACCORDING TO THE CONSUMER PRICE INDEX OR 3%,
19 WHICHEVER IS LESS;

20 (ii) MINUS THE SUM OF:

21 (A) ONE-HALF OF THE WORKERS' COMPENSATION MONTHLY BENEFIT BASED ON THE EMPLOYMENT OF THE
22 QUALIFYING LAW ENFORCEMENT OFFICER PAID TO THE LAW ENFORCEMENT OFFICER OR THE LAW ENFORCEMENT
23 OFFICER'S IMMEDIATE FAMILY; AND

24 (B) ONE-HALF OF THE STATE RETIREMENT MONTHLY BENEFIT PAID BASED ON THE EMPLOYMENT OF THE
25 QUALIFYING LAW ENFORCEMENT OFFICER TO THE LAW ENFORCEMENT OFFICER OR THE LAW ENFORCEMENT OFFICER'S
26 IMMEDIATE FAMILY.

27 (4)(6) THE MONEY IN THE ACCOUNT IS SUBJECT TO LEGISLATIVE APPROPRIATION.

28 (7) ALL PAYMENTS UNDER THIS SECTION ARE EXEMPT FROM EXECUTION WITHOUT LIMIT AS PROVIDED IN

3 NEW SECTION. SECTION 4. CERTIFICATION OF CONTINUED ELIGIBILITY -- NOTIFICATION OF CHANGE IN

4 MARITAL STATUS -- NOTIFICATION OF DATE OF BIRTH. (1) EACH YEAR ON THE ANNIVERSARY OF THE FIRST PAYMENT

5 MADE UNDER [SECTION 3(3)], THE CATASTROPHICALLY INJURED LAW ENFORCEMENT OFFICER, SURVIVING SPOUSE,

6 OTHER IMMEDIATE FAMILY MEMBER, OR AGENT OF THE CATASTROPHICALLY INJURED LAW ENFORCEMENT OFFICER,

7 SURVIVING SPOUSE, OR OTHER IMMEDIATE FAMILY MEMBER, SHALL ATTEST TO THE BOARD ON A FORM PROVIDED BY THE

8 DEPARTMENT THAT THE LAW ENFORCEMENT OFFICER IS STILL ELIGIBLE UNDER THE DEFINITION OF CATASTROPHIC

9 INJURY IN [SECTION 1]. IF THE LAW ENFORCEMENT OFFICER IS NO LONGER ELIGIBLE UNDER THE DEFINITION OF

10 CATASTROPHIC INJURY IN [SECTION 1] OR IF THE ANNUAL ATTESTATION IS NOT SUBMITTED WITHIN 120 DAYS AFTER THE

11 ANNIVERSARY DATE OF THE FIRST PAYMENT UNDER [SECTION 3(3)], THE PAYMENT MUST CEASE.

12 (2) IF PAYMENTS ARE BEING MADE TO A SURVIVING SPOUSE AND THE SURVIVING SPOUSE'S MARITAL

13 STATUS CHANGES, THE SURVIVING SPOUSE SHALL NOTIFY THE BOARD OF THE CHANGE IN MARITAL STATUS WITHIN 120

14 DAYS. ON RECEIPT OF NOTIFICATION, THE PAYMENT MUST BE DISPERSED AS DIRECTED IN [SECTIONS 3(3)AND 3(4)].

15 (3) ON A FORM PROVIDED BY THE DEPARTMENT AND WITHIN 180 DAYS OF RECEIPT OF THE FIRST

16 PAYMENT, THE CATASTROPHICALLY INJURED LAW ENFORCEMENT OFFICER, SURVIVING SPOUSE, OTHER IMMEDIATE

17 FAMILY MEMBER, OR AGENT OF THE CATASTROPHICALLY INJURED LAW ENFORCEMENT OFFICER, SURVIVING SPOUSE, OR

18 OTHER IMMEDIATE FAMILY MEMBER, SHALL PROVIDE THE BOARD WITH THE IDENTITY AND DATES OF BIRTH OF ALL

19 DEPENDENT CHILDREN OF THE LAW ENFORCEMENT OFFICER WHO WERE UNDER 18 YEARS OF AGE AT THE TIME OF THE

20 LAW ENFORCEMENT OFFICER'S CATASTROPHIC INJURY OR DATE OF DEATH.

22 NEW SECTION. Section 5. Montana end of watch trust board. (1) There is a volunteer board to

23 oversee the administration of the Montana end of watch trust provided for in [section 2]. The board is attached

24 to the department of justice for administrative purposes only, as provided in 2-15-121.

25 (2) The board consists of five members appointed by the attorney general, including:

26 (a) a representative of the Montana sheriffs and peace officers association;

27 (b) a representative of the Montana police protective association;

28 (c) a representative of the association of Montana troopers;

1 (d) a representative of the Montana association of chiefs of police; and

2 (e) a representative from the department of justice.

3 (3) The board shall:

4 (a) meet at least once each fiscal year;

5 (b) act as an advocate for officers catastrophically injured in the line of duty and the surviving
6 immediate family members of officers who died in the line of duty; AND

7 (c) settle disputes and concerns regarding trust benefits; ~~and~~

8 ~~(d) communicate with the board of investments regarding the money in the trust, including~~
9 ~~reporting needs.~~

10 (4) The representatives in subsection (2) must be sworn ~~officers~~ ACTORS of a participating agency.

11

12 NEW SECTION. Section 6. End of watch health insurance support. (1) (a) Local governments that
13 employ a law enforcement officer as defined in ~~7-32-204~~ [SECTION 1] and provide health insurance benefits to
14 an officer, an officer's spouse, or an officer's dependents shall:

15 (i) ~~renew the coverage of~~ ENROLL the officer and the officer's spouse ~~or~~ AND dependents IN
16 COBRA CONTINUATION COVERAGE if the officer is catastrophically injured, AS THAT TERM IS DEFINED IN [SECTION 1];
17 AND

18 (ii) ENROLL THE OFFICER'S SPOUSE AND DEPENDENTS IN COBRA COVERAGE ~~or IF THE OFFICER~~ dies in
19 the line of duty as ~~these terms are~~ THAT TERM IS defined in [section 1].

20 (b) ~~Renewals of~~ CONTINUATION coverage under this section must provide for the same level of
21 CONTINUATION COVERAGE benefits as is available to other members of the group. Premiums charged to an
22 officer, spouse, or dependent under this section must be the same as premiums charged to other similarly
23 situated members of the group.

24 (c) Dependent special enrollment must be allowed under the terms of the insurance contract or
25 plan.

26 (d) The provisions of this section are applicable to an officer, spouse, or dependent who is
27 ALREADY insured under a COBRA continuation provision.

28 (2) The law enforcement officer's employing agency shall pay the premium for ~~4 month~~ 4 MONTHS

1 after the catastrophic injury or death in the line of duty, after which the officer, spouse, or dependent shall pay
2 the premium.

3 (3) The benefit plans may discontinue or not renew the coverage of an officer, spouse, or
4 dependent only if:

5 (a) the officer, spouse, or dependent has failed to pay premiums or contributions for which the
6 individual is responsible;

7 (b) the officer, spouse, or dependent has performed an act or practice that constitutes fraud or has
8 made an intentional misrepresentation of a material fact under the terms of the coverage; or

9 (c) the state employee group benefit plans cease to offer coverage in accordance with applicable
10 state law.

11

12 **Section 7.** Section 2-18-704, MCA, is amended to read:

13 **"2-18-704. Mandatory provisions.** (1) An insurance contract or plan issued under this part must
14 contain provisions that permit:

15 (a) the member of a group who retires from active service under the appropriate retirement
16 provisions of a defined benefit plan provided by law or, in the case of the defined contribution plan provided in
17 Title 19, chapter 3, part 21, a member with at least 5 years of service and who is at least age 50 while in
18 covered employment to remain a member of the group until the member becomes eligible for medicare under
19 the federal Health Insurance for the Aged Act, 42 U.S.C. 1395, unless the member is a participant in another
20 group plan with substantially the same or greater benefits at an equivalent cost or unless the member is
21 employed and, by virtue of that employment, is eligible to participate in another group plan with substantially the
22 same or greater benefits at an equivalent cost;

23 (b) the surviving spouse of a member to remain a member of the group as long as the spouse is
24 eligible for retirement benefits accrued by the deceased member as provided by law unless the spouse is
25 eligible for medicare under the federal Health Insurance for the Aged Act or unless the spouse has or is eligible
26 for equivalent insurance coverage as provided in subsection (1)(a);

27 (c) the surviving children of a member to remain members of the group as long as they are eligible
28 for retirement benefits accrued by the deceased member as provided by law unless they have equivalent

1 coverage as provided in subsection (1)(a) or are eligible for insurance coverage by virtue of the employment of
2 a surviving parent or legal guardian.

3 (2) An insurance contract or plan issued under this part must contain the provisions of subsection
4 (1) for remaining a member of the group and also must permit:

5 (a) the spouse of a retired member the same rights as a surviving spouse under subsection (1)(b);

6 (b) the spouse of a retiring member to convert a group policy as provided in 33-22-508; and

7 (c) continued membership in the group by anyone eligible under the provisions of this section,
8 notwithstanding the person's eligibility for medicare under the federal Health Insurance for the Aged Act.

9 (3) (a) A state insurance contract or plan must contain provisions that permit a legislator to remain
10 a member of the state's group plan until the legislator becomes eligible for medicare under the federal Health
11 Insurance for the Aged Act if the legislator:

12 (i) terminates service in the legislature and is a vested member of a state retirement system
13 provided by law; and

14 (ii) notifies the department of administration in writing within 90 days of the end of the legislator's
15 legislative term.

16 (b) A former legislator may not remain a member of the group plan under the provisions of
17 subsection (3)(a) if the person:

18 (i) is a member of a plan with substantially the same or greater benefits at an equivalent cost; or

19 (ii) is employed and, by virtue of that employment, is eligible to participate in another group plan
20 with substantially the same or greater benefits at an equivalent cost.

21 (c) A legislator who remains a member of the group under the provisions of subsection (3)(a) and
22 subsequently terminates membership may not rejoin the group plan unless the person again serves as a
23 legislator.

24 (4) (a) A state insurance contract or plan must contain provisions that permit continued
25 membership in the state's group plan by a member of the judges' retirement system who leaves judicial office
26 but continues to be an inactive vested member of the judges' retirement system as provided by 19-5-301. The
27 judge shall notify the department of administration in writing within 90 days of the end of the judge's judicial
28 service of the judge's choice to continue membership in the group plan.

1 (b) A former judge may not remain a member of the group plan under the provisions of this
2 subsection (4) if the person:

3 (i) is a member of a plan with substantially the same or greater benefits at an equivalent cost;

4 (ii) is employed and, by virtue of that employment, is eligible to participate in another group plan

2 (iii) has had a student loan incurred as a result of health-related education; and

3 (iv) has received a loan payment during the tax year made on the taxpayer's behalf by a loan
4 repayment program described in subsection (13)(b) as an incentive to practice in Montana.

5 (b) For the purposes of subsection (13)(a), a loan repayment program includes a federal, state, or
6 qualified private program. A qualified private loan repayment program includes a licensed health care facility, as
7 defined in 50-5-101, that makes student loan payments on behalf of the person who is employed by the facility
8 as a licensed health care professional.

9 (14) A taxpayer may exclude the amount of loan repayment assistance received during the tax year
10 pursuant to Title 20, chapter 4, part 5, not to exceed \$5,000, from the taxpayer's adjusted gross income.

11 (15) Notwithstanding the provisions of subsection (1), adjusted gross income does not include 40%
12 of capital gains on the sale or exchange of capital assets before December 31, 1986, as capital gains are
13 determined under subchapter P. of Chapter 1 of the Internal Revenue Code as it read on December 31, 1986.

14 (16) A refund received of federal income tax referred to in subsection (1)(b) must be allocated in the
15 following order as applicable:

16 (a) to federal income tax in a prior tax year that was not deducted on the state tax return in that
17 prior tax year;

18 (b) to federal income tax in a prior tax year that was deducted on the state tax return in that prior
19 tax year but did not result in a reduction in state income tax liability in that prior tax year; and

20 (c) to federal income tax in a prior tax year that was deducted on the state tax return in that prior
21 tax year and that reduced the taxpayer's state income tax liability in that prior tax year.

22 (17) By November 1 of each year, the department shall multiply the amount of pension and annuity
23 income contained in subsection (2)(c)(i) and the federal adjusted gross income amounts in subsection (2)(c)(ii)
24 by the inflation factor for the following tax year, rounded to the nearest \$10. The resulting amounts are effective
25 for that following tax year and must be used as the basis for the exemption determined under subsection (2)(c).

3 **Section 9.** Section 15-30-2120, MCA, is amended to read:

4 **"15-30-2120. (Effective January 1, 2024) Adjustments to federal taxable income to determine**
5 **Montana taxable income.** (1) The items in subsection (2) are added to and the items in subsection (3) are
6 subtracted from federal taxable income to determine Montana taxable income.

7 (2) The following are added to federal taxable income:

8 (a) to the extent that it is not exempt from taxation by Montana under federal law, interest from
9 obligations of a territory or another state or any political subdivision of a territory or another state and exempt-
10 interest dividends attributable to that interest except to the extent already included in federal taxable income;

11 (b) that portion of a shareholder's income under subchapter S. of Chapter 1 of the Internal
12 Revenue Code that has been reduced by any federal taxes paid by the subchapter S. corporation on the
13 income;

14 (c) depreciation or amortization taken on a title plant as defined in 33-25-105;

15 (d) the recovery during the tax year of an amount deducted in any prior tax year to the extent that
16 the amount recovered reduced the taxpayer's Montana income tax in the year deducted;

17 (e) an item of income, deduction, or expense to the extent that it was used to calculate federal
18 taxable income if the item was also used to calculate a credit against a Montana income tax liability;

19 (f) a deduction for an income distribution from an estate or trust to a beneficiary that was included
20 in the federal taxable income of an estate or trust in accordance with sections 651 and 661 of the Internal
21 Revenue Code, 26 U.S.C. 651 and 661;

22 (g) a withdrawal from a medical care savings account provided for in Title 15, chapter 61, used for
23 a purpose other than an eligible medical expense or long-term care of the employee or account holder or a
24 dependent of the employee or account holder;

25 (h) a withdrawal from a first-time home buyer savings account provided for in Title 15, chapter 63,
26 used for a purpose other than for eligible costs for the purchase of a single-family residence;

27 (i) for a taxpayer that deducts the qualified business income deduction pursuant to section 199A
28 of the Internal Revenue Code, 26 U.S.C. 199A, an amount equal to the qualified business income deduction

1 claimed; and

2 (j) for a taxpayer that deducts state income taxes pursuant to section 164(a)(3) of the Internal
3 Revenue Code, 26 U.S.C. 164(a)(3), an additional amount equal to the state income tax deduction claimed, not
4 to exceed the amount required to reduce the federal itemized amount computed under section 161 of the
5 Internal Revenue Code, 26 U.S.C. 161, to the amount of the federal standard deduction allowable under
6 section 63(c) of the Internal Revenue Code, 26 U.S.C. 63(c).

7 (3) To the extent they are included as income or gain or not already excluded as a deduction or
8 expense in determining federal taxable income, the following are subtracted from federal taxable income:

9 (a) a deduction for an income distribution from an estate or trust to a beneficiary in accordance
10 with sections 651 and 661 of the Internal Revenue Code, 26 U.S.C. 651 and 661, recalculated according to the
11 additions and subtractions in subsections (2) and (3)(b) through (3)(m);

12 (b) if exempt from taxation by Montana under federal law:

13 (i) interest from obligations of the United States government and exempt-interest dividends
14 attributable to that interest; and

15 (ii) railroad retirement benefits;

16 (c) (i) salary received from the armed forces by residents of Montana who are serving on active
17 duty in the regular armed forces and who entered into active duty from Montana;

18 (ii) the salary received by residents of Montana for active duty in the national guard. For the
19 purposes of this subsection (3)(c)(ii), "active duty" means duty performed under an order issued to a national
20 guard member pursuant to:

21 (A) Title 10, U.S.C.; or

22 (B) Title 32, U.S.C., for a homeland defense activity, as defined in 32 U.S.C. 901, or a contingency
23 operation, as defined in 10 U.S.C. 101, and the person was a member of a unit engaged in a homeland
24 defense activity or contingency operation.

25 (iii) the amount received pursuant to 10-1-1114 or from the federal government by a service
26 member, as defined in 10-1-1112, as reimbursement for group life insurance premiums paid;

27 (iv) the amount received by a beneficiary pursuant to 10-1-1201; and

28 (v) all payments made under the World War I bonus law, the Korean bonus law, and the veterans'

1 bonus law. Any income tax that has been or may be paid on income received from the World War I bonus law,
2 Korean bonus law, and the veterans' bonus law is considered an overpayment and must be refunded upon the
3 filing of an amended return and a verified claim for refund on forms prescribed by the department in the same
4 manner as other income tax refund claims are paid.

5 (d) interest and other income related to contributions that were made prior to January 1, 2024, that
6 are retained in a medical care savings account provided for in Title 15, chapter 61, and any withdrawal for
7 payment of eligible medical expenses or for the long-term care of the employee or account holder or a
8 dependent of the employee or account holder;

9 (e) contributions or earnings withdrawn from a family education savings account provided for in
10 Title 15, chapter 62, or from a qualified tuition program established and maintained by another state as
11 provided in section 529(b)(1)(A)(ii) of the Internal Revenue Code, 26 U.S.C. 529(b)(1)(A)(ii), for qualified
12 education expenses, as defined in 15-62-103, of a designated beneficiary;

13 (f) interest and other income related to contributions that were made prior to January 1, 2024, that
14 are retained in a first-time home buyer savings account provided for in Title 15, chapter 63, and any withdrawal
15 for payment of eligible costs for the first-time purchase of a single-family residence;

16 (g) for each taxpayer that has attained the age of 65, an additional subtraction of \$5,500;

17 (h) the amount of a scholarship to an eligible student by a student scholarship organization
18 pursuant to 15-30-3104;

19 (i) a payment received by a private landowner for providing public access to public land pursuant
20 to Title 76, chapter 17, part 1;

21 (j) the amount of any refund or credit for overpayment of income taxes imposed by this state or
22 any other taxing jurisdiction to the extent included in gross income for federal income tax purposes but not
23 previously allowed as a deduction for Montana income tax purposes;

24 (k) the recovery during the tax year of any amount deducted in any prior tax year to the extent that
25 the recovered amount did not reduce the taxpayer's Montana income tax in the year deducted;

26 (l) an amount equal to 30% of net-long term capital gains, as defined in section 1222 of the
27 Internal Revenue Code, 26 U.S.C. 1222, if and to the extent such gain is taken into account in computing
28 federal taxable income; and

1 (m) the amount of the gain recognized from the sale or exchange of a mobile home park as
2 provided in 15-31-163; and

3 (n) less payments from the Montana end of watch trust as provided in [section 2].

4 (4) (a) A taxpayer who, in determining federal taxable income, has reduced the taxpayer's
5 business deductions:

6 (i) by an amount for wages and salaries for which a federal tax credit was elected under sections
7 38 and 51(a) of the Internal Revenue Code, 26 U.S.C. 38 and 51(a), is allowed to deduct the amount of the
8 wages and salaries paid regardless of the credit taken; or

9 (ii) for which a federal tax credit was elected under the Internal Revenue Code is allowed to
10 deduct the amount of the business expense paid when there is no corresponding state income tax credit or
11 deduction, regardless of the credit taken.

12 (b) The deductions in subsection (4)(a) must be made in the year that the wages, salaries, or
13 business expenses were used to compute the credit. In the case of a partnership or small business corporation,
14 the deductions in subsection (4)(a) must be made to determine the amount of income or loss of the partnership
15 or small business corporation.

16 (5) (a) An individual who contributes to one or more accounts established under the Montana
17 family education savings program or to a qualified tuition program established and maintained by another state
18 as provided in section 529(b)(1)(A)(ii) of the Internal Revenue Code, 26 U.S.C. 529(b)(1)(A)(ii), may reduce
19 taxable income by the lesser of \$3,000 or the amount of the contribution. In the case of married taxpayers, each
20 spouse is entitled to a reduction, not in excess of \$3,000, for the spouses' contributions to the accounts.
21 Spouses may jointly elect to treat half of the total contributions made by the spouses as being made by each
22 spouse. The reduction in taxable income under this subsection (5)(a) applies only with respect to contributions
23 to an account of which the account owner is the taxpayer, the taxpayer's spouse, or the taxpayer's child or
24 stepchild if the taxpayer's child or stepchild is a Montana resident. The provisions of subsection (2)(d) do not
25 apply with respect to withdrawals of contributions that reduced federal taxable income.

26 (b) Contributions made pursuant to this subsection (5) are subject to the recapture tax provided for
27 in 15-62-208.

28 (6) (a) An individual who contributes to one or more accounts established under the Montana

1 achieving a better life experience program or to a qualified program established and maintained by another
2 state may reduce taxable income by the lesser of \$3,000 or the amount of the contribution. In the case of
3 married taxpayers, each spouse is entitled to a reduction, not to exceed \$3,000, for the spouses' contributions
4 to the accounts. Spouses may jointly elect to treat one-half of the total contributions made by the spouses as
5 being made by each spouse. The reduction in taxable income under this subsection (6)(a) applies only with
6 respect to contributions to an account for which the account owner is the taxpayer, the taxpayer's spouse, or
7 the taxpayer's child or stepchild if the taxpayer's child or stepchild is a Montana resident. The provisions of
8 subsection (2)(d) do not apply with respect to withdrawals of contributions that reduced taxable income.

9 (b) Contributions made pursuant to this subsection (6) are subject to the recapture tax provided in
10 53-25-118.

11 (7) By November 1 of each year, the department shall multiply the subtraction from federal taxable
12 income for a taxpayer that has attained the age of 65 contained in subsection (3)(g) by the inflation factor for
13 that tax year, rounding the result to the nearest \$10. The resulting amount is effective for that tax year and must
14 be used as the basis for the subtraction from federal taxable income determined under subsection (3)(g)."

16 **SECTION 10. SECTION 25-13-608, MCA, IS AMENDED TO READ:**

17 **"25-13-608. Property exempt without limitation -- exceptions.** (1) A judgment debtor is entitled to
18 exemption from execution of the following:

19 (a) professionally prescribed health aids for the judgment debtor or a dependent of the judgment
20 debtor;

21 (b) benefits the judgment debtor has received or is entitled to receive under federal social security
22 or local public assistance legislation, except as provided in subsection (2);

23 (c) veterans' benefits, except as provided in subsection (2);

24 (d) disability or illness benefits, except as provided in subsection (2);

25 (e) except as provided in subsection (2), individual retirement accounts, as defined in 26 U.S.C.
26 408(a), to the extent of deductible contributions made before the suit resulting in judgment was filed and the
27 earnings on those contributions, Roth individual retirement accounts, as defined in 26 U.S.C. 408A, to the
28 extent of qualified contributions made before the suit resulting in judgment was filed and the earnings on those

1 contributions, and rollover contributions, as defined in 26 U.S.C. 408(d)(3);

2 (f) benefits paid or payable for medical, surgical, or hospital care to the extent they are used or will
3 be used to pay for the care;

4 (g) maintenance and child support;

5 (h) a burial plot for the judgment debtor and the debtor's family;

6 (i) benefits or payments paid or payable from a retirement system or plan within Title 19, chapters
7 3, 5 through 9, and 13, as provided by 19-2-1004;

8 (j) benefits or payments paid or payable from a retirement system or plan within Title 19, chapter
9 20, as provided by 19-20-706;

10 (k) the judgment debtor's interest in any unmatured life insurance contracts owned by the
11 judgment debtor; ~~and~~

12 (l) as provided in 25-13-603, a medical care savings account under Title 15, chapter 61, a health
13 savings account under 26 U.S.C. 223, or a medical savings account under 26 U.S.C. 220 to the extent of
14 contributions made before the suit resulting in judgment was filed and the earnings on those contributions; and

15 (m) payments from the end of watch trust provided in [sections 1 through 6].

16 (2) Veterans' and social security legislation benefits based upon remuneration for employment,
17 disability benefits, and assets of individual retirement accounts are not exempt from execution if the debt for
18 which execution is levied is for:

19 (a) child support; or

20 (b) maintenance to be paid to a spouse or former spouse."

21

22 **NEW SECTION. Section 11. Unfunded mandate laws superseded.** The provisions of [this act]
23 expressly supersede and modify the requirements of 1-2-112 through 1-2-116.

25 **NEW SECTION. Section 12. Effective date.** (1) Except as provided in subsection (2), [this act] is
26 effective July 1, 2023.
