14	(a) generic prescription drugs that are not listed within any of the schedules of controlled
15	substances found at 21 CFR 1308.11 through 21 CFR 1308.15 or the schedules of controlled substances found
16	in Title 50, chapter 32;
17	(b)(A) any GENERIC prescription drug, generic or brand name, that is not listed within any of the
18	schedules of controlled substances found at 21 CFR 1308.11 through 21 CFR 1308.15 or the schedules of
19	controlled substances found in Title 50, chapter 32, after a covered person has been prescribed the COVERED
20	drug AT THE SAME QUANTITY without interruption for 6 months;
21	(c)(B) any prescription drug or drugs, generic or brand name, on the grounds of therapeutic
22	duplication FOR THE SAME DRUG if the covered person has already been subject to prior authorization on the
23	grounds of therapeutic duplication for the same dosage of the prescription drug or drugs and coverage of the
24	prescription drug or drugs was approved;
25	(d)(C) any prescription drug, generic or brand name, solely because the dosage of the medication for
26	the covered person has been adjusted by the prescriber of the prescription drug, AS LONG AS THE DOSAGE IS
27	WITHIN THE DOSAGE APPROVED BY THE FOOD AND DRUG ADMINISTRATION OR IS CONSISTENT WITH CLINICAL DOSING
28	FOR THE MEDICATION; or

Section 2. Exemption from prior authorization requirements. (1) (A) A health 22 insurance issuer that uses a REQUIRED prior authorization process for A COVERED PERSON'S benefits may not 23 require a AN ORDERING HEALTH CARE provider to obtain prior authorization ON BEHALF OF A COVERED PERSON for a 24 particular benefit CATEGORY OF PRIOR AUTHORIZATION if, in the most recent 6-month JANUARY THROUGH 25 SEPTEMBER evaluation period, as described in subsection (2), THE PROVIDER HAS HAD A MINIMUM OF 10 PRIOR 26 AUTHORIZATION REQUESTS IN A PARTICULAR CATEGORY OF PRIOR AUTHORIZATIONS AND the health insurance issuer 27 has approved or would have approved not less than 90% of the prior authorization requests IN THE PRIOR 28 AUTHORIZATION CATEGORY submitted by the provider for the particular COVERED benefit.

3	PROVIDER. an individual licensed to practice medicine under Title 37, chapter 3. For a determination made under

5	practice medicine under Title 37, chapter 3, who has the same or similar specialty as that physician.

16	(10) A health insurance issuer may not deny or reduce payment to a provider for a benefit for which
17	the provider has qualified for an exemption from prior authorization requirements under subsection (1) based on
18	medical necessity or appropriateness of care unless the provider:
19	(a) knowingly and materially misrepresented the benefit in a request for payment submitted to the
20	health insurance issuer with the specific intent to deceive and obtain an unlawful payment from the issuer; or
21	(b) failed to substantially furnish or deliver the benefit.
22	(11) A health insurance issuer may not conduct a retrospective review of a benefit subject to an
23	exemption except:
24	(a) to determine if the provider still qualifies for an exemption under this section; or
25	(b) if the health insurance issuer has a reasonable cause to suspect a basis for denial exists under
26	subsection (10).
27	(12) Not later than 5 days after qualifying for an exemption from prior authorization requirements
28	under subsection (1), a health insurance issuer must provide to a provider a notice that includes:

- 19 review organization. A health insurance issuer may not require a provider to engage in an internal grievance
- 20 process before requesting a review by an independent review organization under this p art.
- 21 (2) A health insurance issuer shall pay:
- 22 (a) for any independent external review of an adverse determination regarding a prior authorization
- 23 exemption requested under this section; and
- 24 (b) a reasonable fee determined by the Montana b oard of m edical e xaminers for any copies of
- 25 medical records or other documents requested from a provider during an exemption rescission independent
- 26 external review requested under this section.
- 27 (3) An independent review organization shall complete a review of an adverse determination
- 28 regarding a prior authorization exemption not later than the seventh day after the date a provider files the

2	(4) A provider may request that the independent review organization consider another random
3	sample of not less than 20 and no more than 50 claims submitted to the health insurance issuer by the provider
4	during the relevant evaluation period for the relevant health care service as part of its review. If the provider
5	makes a request under this subsection, the independent review organization shall base its determination on the
6	medical necessity of claims reviewed by the health insurance issuer under Title 33, chapter 32, part 2, and
7	reviewed under this subsection.
8	(5) A health insurance issuer is bound by an independent external review determination that does
9	not affirm the determination made by the health insurance issuer to rescind a prior authorization exemption.
10	(6) A health insurance issuer may not retrospectively deny a benefit based on a rescission of an
11	exemption, even if the health insurance issuer's determination to rescind the prior authorization exemption is
12	affirmed by an independent review organization.
13	(7) If a determination of a prior authorization exemption made by the health insurance issuer is
14	overturned on review by an independent review organization, the health insurance issuer:
15	(a) may not attempt to rescind the exemption before the end of the next evaluation period that
16	occurs; and
17	(b) may only rescind the exemption after if the entity complies with the previous provisions of this
18	section.

20	Section 4. Section 33-32-309, MCA, is amended to read:
21	"33-32-309. Expedited review of grievance involving adverse determination. (1) A health
22	insurance issuer shall establish written procedures for the expedited review of urgent care requests of
23	grievances involving an adverse determination, and separate written procedures for the expedited review of
24	prescription drug grievances involving an adverse determination, as described in subsection (11).
25	(2) A health insurance issuer shall provide an expedited review of a grievance involving an
26	adverse determination with respect to a concurrent review of an urgent care request involving an admission,
27	availability of care, continued stay, or health care service for a covered person who has received emergency
28	services but has not been discharged from a facility. The procedures in subsection (1) must also specify the



1 process for the concurrent review of urgent care requests under this subsection (2). 2 The procedures under this section must provide that a covered person or, if applicable, the (3) 3 covered person's authorized representative may request an expedited review orally, in writing, or electronically. 4 On receipt of a request for an expedited review, a health insurance issuer shall appoint one or (4)5 more physicians or health care professionals of the same licensure to review the adverse determination. An 6 appointed physician or health care professional of the same licensure may not have been involved in making 7 the initial adverse determination. 8 In an expedited review, all necessary information, including the health insurance issuer's (5) 9 decision, must be transmitted between the health insurance issuer and the covered person or, if applicable, the 10 covered person's authorized representative in the most expeditious method available, whether by telephone, 11 facsimile, or other method. 12 (6) (a) The timeframe for making a decision under an expedited review and notification, as 13 provided in subsection (8), must be as expeditious as the covered person's medical condition requires but may 14 take no more than 72 hours after the receipt of the request for the expedited review. 15 (b) If the expedited review is of a grievance involving an adverse determination with respect to a 16 concurrent review urgent care request, the health insurance issuer shall continue the health care service or 17 treatment without liability to the covered person until the covered person has been notified of the determination. 18 -For purposes of calculating the timeframe within which a decision is required to be made under (7)19 subsection (6), the time period within which the decision must be made begins on the date the request is filed 20 with the health insurance issuer in accordance with the health insurance issuer's procedures for filing requests 21 established under 33-32-307 without regard to whether all of the information necessary to make the 22 determination accompanies the filing. 23 (8) A notification of a decision under this section must be in a manner calculated to be understood 24 by the covered person or, if applicable, the covered person's authorized representative and, if necessary, meet 25 the requirements of subsection (9). The notification must include: 26 the titles and qualifying credentials of each physician or health care professional of the same (a) 27 licensure participating in the expedited review process; 28 information sufficient to identify the claim involved with respect to the grievance, including the (b)



1	date of service, the health care provider, and, if applicable, the claim amount;
2	(c) a statement describing the availability, upon request, of the diagnosis code and its
3	corresponding meaning and the treatment code and its corresponding meaning. On receiving a request for a
4	diagnosis or treatment code, the health insurance issuer shall provide the information as soon as practicable. A
5	health insurance issuer may not consider a request for the diagnosis code and treatment information, in itself,
6	to be a request to file a grievance for external review as outlined in Title 33, chapter 32, part 4.
7	(d) a statement from the physicians or health care professionals of the same licensure participating
8	in the review of their understanding of the covered person's grievance;
9	(e) a description in clear terms of the decision of the physicians or health care professionals of the
10	same licensure and the contract basis or medical rationale in sufficient detail for the covered person to respond
11	further to the health insurance issuer's position;
12	(f) a reference to the evidence or documentation used as the basis for the decision. If the decision
13	involves an adverse determination, the notice must provide:
14	(i) all specific reasons for the adverse determination, including the denial code and its
15	corresponding meaning, as well as a description of the health insurance issuer's standard, if any, that was used
16	in reaching the denial;
17	(ii) the reference to the specific plan provisions on which the determination is based;
18	(iii) if the adverse determination is based on incomplete documentation, a description of any
19	additional material or information necessary for the covered person to complete the request, including an
20	explanation of why the material or information is necessary to complete the request;
21	(iv) a copy of any internal rule, guideline, protocol, or other similar criteria if relied on by the health
22	insurance issuer to make the adverse determination. Alternatively, the health insurance issuer may provide a
23	statement that a specific rule, guideline, protocol, or other similar criteria was relied on to make the adverse
24	determination and that a copy of the rule, guideline, protocol, or other similar criteria will be provided free of
25	charge to the covered person on request.
26	(v) an explanation of the scientific or clinical judgment used for making the adverse determination
27	if the adverse determination is based on a medical necessity or experimental or investigational treatment or
28	similar exclusion or limit. The explanation must apply the terms of the health plan to the covered person's



1	medical circumstances. Alternatively, the health insurance issuer may provide a statement that an explanation
2	will be provided to the covered person free of charge on request.
3	(vi) instructions for requesting any of the following that are applicable:
4	(A) a copy of the rule, guideline, protocol, or other similar criteria relied on in making the adverse
5	determination in accordance with subsection (8)(f)(iv); or
6	(B) the written statement of the scientific or clinical rationale for the adverse determination in
7	accordance with subsection (8)(f)(v);
8	(vii) a statement describing the procedures for obtaining an independent external review of the
9	adverse determination pursuant to Title 33, chapter 32, part 4;
10	(viii) the following statement, if applicable:
11	"You and your plan may have other voluntary alternative dispute resolution options, such as mediation.
12	One way to find out what may be available is to contact your state insurance commissioner."
13	(ix) a statement indicating the covered person's right to bring a civil action in a court of competent
14	jurisdiction; and
15	(x) a notice of the covered person's right to contact the commissioner's office for assistance at any
16	time, including the telephone number and address of the commissioner's office.
17	(9) The notice under subsection (8)(f) must be provided in accordance with federal regulations and
18	as provided in 33-32-211(9).
19	(10) (a) A health insurance issuer may provide the notice required under this section orally, in
20	writing, or electronically.
21	(b) If notice of the adverse determination is provided orally, the health insurance issuer shall
22	provide written or electronic notice of the adverse determination within 3 days after the oral notification.
23	(11) (a) Notwithstanding any other provision of this part, any adverse determination for a
24	prescription drug made during the course of prior authorization is eligible for an expedited review of a
25	grievance, initiated by the prescriber of the prescription drug, if the prescriber of the prescription drug subject to
26	prior authorization believes that, in the prescriber's professional judgment, the covered person will suffer
27	serious harm without access to the prescription drug subject to prior authorization.
28	(b) On initiation of the expedited review of the grievance by the prescriber of the prescription drug

1	subject to prior authorization, a health insurance issuer shall render a decision on the expedited review of the
2	grievance within 48 hours and provide written notice.
3	(c) If a health insurance issuer does not render a decision on the expedited review of the
4	grievance initiated by the prescriber of the prescription drug subject to prior authorization within 48 hours of
5	initiation, the initial adverse determination must be automatically overturned, and the covered person must be
6	granted immediate approval for coverage of the prescription drug subject to prior authorization.
7	(d) The decision rendered during the expedited review of the grievance by a health insurance
8	issuer must be made by a physician who is in the same specialty as the prescriber of the prescription drug
9	subject to prior authorization or must be made by a physician whose specialty focuses on the diagnosis and
10	treatment of the condition for which the prescription drug was prescribed to treat
11	
12	NEW SECTION. Section 3. Codification instruction. (1) [Sections 1 and 2] are intended to be
13	codified as an integral part of Title 33, chapter 32, part 2, and the provisions of Title 33, chapter 32, part 2,

16	provisions of Title 33, chapter 32, part 4, apply to [section 3].
