12	Section	on 1. Section 37-1-401, MCA, is amended to read:	
13	" 37-1 ·	401. Uniform regulation for licensing programs without boards definitions. As used in	
14	this part, the following definitions apply:		
15	(1)	"Complaint" means a written allegation filed with the department that, if true, warrants an	
16	injunction, dis	ciplinary action against a licensee, or denial of an application submitted by a license applicant.	
17	(2)	"Department" means the department of labor and industry provided for in 2-15-1701.	
18	(3)	"Investigation" means the inquiry, analysis, audit, or other pursuit of information by the	
19	department, with respect to a complaint or other information before the department, that is carried out for the		
20	purpose of de	termining:	
21	(a)	whether a person has violated a provision of law justifying discipline against the person;	
22	(b)	the status of compliance with a stipulation or order of the department;	
23	(c)	whether a license should be granted, denied, or conditionally issued; or	
24	(d)	whether the department should seek an injunction.	
25	(4)	"License" means permission in the form of a license, permit, endorsement, certificate,	
26	recognition, or registration granted by the state of Montana to engage in a business activity or practice at a		
27	specific level in a profession or occupation governed by:		
28	(a)	Title 37, chapter 35, 72, or 73; or

2	(5) "Profession" or "occupation" means a profession or occupation regulated by the department		
3	under the provisions of:		
4	(a) Title 37, chapter 35, <u>40,</u> 49, 72, or 73; or		
5	(b) Title 50, chapter 39, 74, or 76."

7	Section 2. Section 37-40-101, MCA, is amended to read:		
8	"37-40-101. Definitions. Unless the context requires otherwise, as used in this chapter, the followin	g	
9	definitions apply:		
10	(1) "Board" means the board of sanitarians provided for in 2-15-1751.		
11	(2)(1) "Department" means the department of labor and industry provided for in Title 2, chapter 15,		
12	part 17.		
13	(3)(2) "Practice the profession of sanitarian" means:		
14	(a) giving advice on or enforcing compliance with state and local regulations applicable to local		
15	government jurisdictions and programs concerning food service, food processing, public accommodations,		
16	trailer courts, campgrounds, day-care centers, schools, swimming pools and spas, air pollution, solid and		
17	hazardous waste collection and disposal, sewage treatment and disposal, vector control, underground storage		
18	tanks, drinking water, land subdivision, and milk sanitation;		
19	(b) cooperating with government agencies on matters of public and environmental health, including	ng	
20	epidemiological investigations and emergency response to investigations; and		
21	(c) providing educational and training programs in environmental standards and public health.		
22	(4)(3) "Registered sanitarian" means a sanitarian licensed under this chapter.		
23	(5) "Sanitarian", within the meaning and intent of this chapter, shall mean a person who, by reason of) f	
24	the person's special knowledge of the physical, biological, and chemical sciences and the principles and		
25	methods of public health acquired by professional education and practical experience through inspectional,		
26	educational, or enforcement duties, is qualified to practice the profession of sanitarian.		
27	(6) "Sanitarian-in-training" means a person who meets the minimum educational qualifications		
28	required for a sanitarian's license and who works under the supervision of a licensed sanitarian. Sanitarians-ir)-

1	training may, with board approval, work in a public health agency for a period not to exceed 1 year and be		
2	considered exempt from the licensing and registration requirements of 37-40-301."

4	Section 3. Section 37-40-203, MCA, is amended to read:		
5	"37-40-203. Rulemaking power. (1) The board-department may adopt rules, consistent with the		
6	purposes of this chapter, as it considers necessary.		
7	(2) The board's rulemaking and hearing functions must be in accordance with the Montana		
8	Administrative Procedure Act. The board shall adopt rules:		
9	(a) establishing standards of professional conduct in order to maintain a high standard of integrity,		
10	dignity, and competency in the profession of sanitarian, including competency in specific fields of sanitation;		
11	(b) governing the conduct of matters before the board;		
12	(2) The department shall adopt rules:		
13	(c)(a) governing educational equivalency requirements, as provided in 37-40-302, for registration of		
14	sanitarians; and		
15	(d)(b) defining qualifications for sanitarian-in-training status for issuance of the initial permit."

17	Section 4. Section 37-40-302, MCA, is amended to read:		
18	"37-40-302. Application examination certificate. (1) A person wishing to practice the profession		
19	of sanitarian may apply to the department for registration on a form furnished by the department.		
20	(2) An applicant must have a minimum of a bachelor's degree in environmental health or its		
21	equivalent from an accredited university or college.		
22	(3) If the applicant meets the board's department's standards and passes the examination		
23	prescribed by the board department, the department shall issue a certificate of registration.		
24	(4) A holder of a current certificate is entitled to append to the holder's name the initials "R.S."."

26	Section 5. Section 37-40-312, MCA, is amended to read:		
27	"37-40-312. Penalty. (1) A person who offers the person's services as a sanitarian or uses, assumes,		
28	or advertises in any way any title or description tending to convey the impression that the person is a registered		



- 1 sanitarian who does not hold the license specified by this chapter is guilty of a misdemeanor and is punishable
- 2 by a fine not to exceed \$500 or by imprisonment for not longer than 6 months, or both.
- 3 (2) The <u>board department</u> may enforce the provisions of this chapter by injunction or any other
- 4 appropriate proceeding."
