On behalf of Chief Justice Mike McGrath, I am attaching the appointment notice for the chief judge of the Montana Water Court. The appointment is subject to Senate confirmation pursuant to 3-1-906, MCA.

Judge Russell McElyea's appointment notice, letter of application, and public comment are attached. Judge McElyea was the only applicant for the position. Please note Judge McElyea was first appointed to the court in July 2012 as the associate water court judge and as chief judge in 2013 and 2017. He was confirmed by the Senate in 2013, 2015, and in the November 2017 special session. This confirmation is for a full four-year term starting on August 1, 2021.
